

# Terms and Conditions

## **Agreement between User and www.boysandgirls.org**

Welcome to www.boysandgirls.org. The www.boysandgirls.org website (the "Site") is comprised of various web pages operated by Boys & Girls Clubs of the Twin Cities ("BGCTC").

www.boysandgirls.org is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of www.boysandgirls.org constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

www.boysandgirls.org is a Non-Profit Site.

## **Children Under Thirteen**

BGCTC does not knowingly collect, either online or offline, personal information from persons under the age of thirteen. If you are under 18, you may use www.boysandgirls.org only with permission of a parent or guardian.

You are granted a non-exclusive, non-transferable, revocable license to access and use
