Voting Center and Accessibility Information

Accessible voting is accessible at the South Bend Auditor's Office beginning 18 days before Election Day, Monday through Friday, from 8am to 4pm in the Election Office. On Election Day, accessible voting is available from 8am to 8pm. The touchscreen voting unit provides an alternate method of voting independently and privately for voters with accessibility, cognitive or mobility issues. Assistance is available upon request by contacting the Elections Department.

The Board of Pacific County Fire Protection District No. 1 adopted Resolution No. 2024-04 concerning a proposition to maintain and adequately fund District operations.

This proposition authorizes the District to restore its regular property tax levy to \$1.15 per \$1,000 of assessed value to be assessed in 2024 and collected in 2025. The funds will maintain and improve fire protection and emergency medical services, replace apparatus, equipment and facilities and provide for firefighter safety. The maximum allowable levy in 2024 shall serve as the base for subsequent levy limitations as provided by chapter 84.55

Explanatory Statement

Pacific County Fire Protection District No. 1 provides emergency fire protection and emergency medical services to its citizens. Due to the statutory 1% limitation on property tax increases, the Fire District's current levy has dropped to approximately \$.85 per thousand in 2023. The maximum regular levy rate for Washington fire districts is \$1.50 per \$1,000 of assessed value.

If approved by the voters, this proposition will authorize the District to restore its levy rate to \$1.15 per \$1,000 of assessed valuation for collection in 2025. The dollar amount levied in the 2024 year shall serve as the District's future tax levy base.

The Board of Commissioners has determined that this proposition is necessary to maintain an effective level of services, fire fighter staffing, equipment and facilities in light of rising costs, rising demands and the continued growth of our community. Approval of this measure will allow the District to maintain the level of fire protection and emergency medical services provided to its

Explanatory Statement

South Beach Regional Fire Authority provides emergency fire protection and medical services to its citizens. The maximum regular levy rate for Washington fire authorities is \$1.50 per \$1,000 of assessed value.

Due to the statutory 1% limitation on property tax increases, South Beach Fire's current levy rate has dropped to \$0.95 per thousand. If approved by the voters, this proposition will authorize the Authority to restore its levy rate to \$1.50 per \$1,000 of assessed valuation in 2024 for collection in 2025 which is the amount originally approved by the voters in 2017. Approval of this levy would replace the expiring excess levy approved by the voters in 2023.

The Authority's Governing Board has determined that this proposition is necessary to maintain an effective level of services, fire fighter staffing, equipment and facilities in light of rising costs, rising demands and the continued growth of our community. Approval of this measure will allow the Authority to maintain the level of fire protection and emergency medical services provided to its citizens.
