### **Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration**

#### **Addendum**

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, and in accordance with paragraph 7 of the note by the President dated 19 December 2007 (S/2007/749), the Secretary-General is submitting the following summary statement.

The complete list of items of which the Security Council was seized as at 4 October 2008 is contained in document S/2008/10/Add.39 of 10 October 2008.

The present addendum lists the items on which the Security Council took action during the week ending 11 October 2008. The dates given for each item indicate when the item was first taken up by the Council at a formal meeting, and the most recent formal meeting of the Council held on that item.

#### **The situation in Somalia** (17 March 1992; 7 October 2008)

The Security Council resumed its consideration of the item at its 5987th meeting, held on 7 October 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representatives of Canada, Denmark, Greece, Japan, Lithuania, Malaysia, the Netherlands, Norway, Portugal, the Republic of Korea, Singapore, Somalia and Spain, at their request, to participate in the consideration of the item without the right to vote. The Council proceeded to vote on draft resolution S/2008/633, submitted by Belgium, Canada, Croatia, Denmark, France, Greece, Italy, Japan, Lithuania, Malaysia, the Netherlands, Norway, Panama, Portugal, the Republic of Korea, Singapore, Spain, the United Kingdom of Great Britain and Northern Ireland and the United States of America, and adopted it unanimously as resolution 1838 (2008).

#### **The situation in Guinea-Bissau** (6 November 1998; 7 October 2008)

The Security Council resumed its consideration of the item at its 5988th meeting, held on 7 October 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Guinea-Bissau, at his request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended invitations to B. Lynn Pascoe, Under-Secretary-General for Political Affairs, and Maria Luiza Ribeiro

**Meeting of the Security Council with the troop-contributing countries pursuant to resolution 1353 (2001), annex II, sections A and B** (10 September 2001; 8 October 2008)

**United Nations Stabilization Mission in Haiti**

The Security Council resumed its consideration of the item at its 5989th meeting, held in private on 8 October 2008. At the close of the meeting, in accordance with rule 55 of the provisional rules of procedure of the Security Council, a communiqué was issued through the Secretary-General in place of a verbatim record (S/PV.5989).

**The question concerning Haiti** (16 June 1993; 8 October 2008)

The Security Council resumed its consideration of the item at its 5990th meeting, held on 8 October 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Haiti, at his request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended an invitation to Hédi Annabi, Special Representative of the Secretary-General and Head of the United Nations Stabilization Mission in Haiti.

**Meeting of the Security Council with the troop-contributing countries pursuant to resolution 1353 (2001), annex II, sections A and B** (10 September 2001; 9 October 2008)

**United Nations Observer Mission in Georgia**

The Security Council resumed its consideration of the item at its 5991st meeting, held in private on 9 October 2008. At the close of the meeting, in accordance with rule 55 of the provisional rules of procedure of the Security Council, a communiqué was issued through the Secretary-General in place of a verbatim record (S/PV.5991).

**The situation in Georgia** (8 October 1992; 9 October 2008)

The Security Council resumed its consideration of the item at its 5992nd meeting, held on 9 October 2008. The Council proceeded to vote on draft resolution S/2008/639, which had been prepared in the course of the Council's prior consultations, and adopted it unanimously as resolution 1839 (2008).
