

Submission of 'closing sequence' remains possible for closed procedures.




Changes relating to NCA functionality

MAHs are no longer able to submit PSURs and responses for closed procedures.




Renamed product list attachments in PSUR Repository notifications (SD-303, 23)

There are no special characters in the attachment name as these require further renaming.

- The EMA admin users are now able to cancel and revoke a cancellation for a nonstarting procedure. The reason for cancellation will be provided in the notification to the NCAs.
- Once the procedure is cancelled, the automated reminder notifications to upload the assessment report will no longer be sent to the LMS (Lead Member State).
- The PSUR start of procedure notification no PSUR received will be disabled for NAP only PSUSA procedures.
