8. Organizational Changes in the Appliances Company (Effective April 1)

Objectives and Contents:

With the aim of strengthening product competitiveness through the reorganization for business promotion in the Asia and Oceania region, the development and manufacturing functions of Panasonic Appliances Asia Pacific will be transferred to the relevant business divisions.

In addition, the sales company management function will be transferred to the Consumer Marketing Division.

Accordingly, Panasonic Appliances Asia Pacific will be reformed.

9. Organizational Changes in the Corporate Strategy Division and the Professional Business Support Sector (Effective April 1)

Objectives and Contents:

With the aim of implementing the human resources strategy for achieving business transformation (productivity improvement, leader fostering, corporate culture reform, and risk management), under the Professional Business Support Sector, the Strategic Human Resources Department will be established to formulate comprehensive strategies related to the acquisition, assignment, remuneration, and engagement of human resources as well as develop relevant systems and schemes, and the Industrial Relations Department will be established and put in charge of labor relations, labor policy, and labor infrastructure development, while the function of developing the resource management strategies will be remained under the Corporate Strategy Division.

Accordingly, the Corporate Human Resources Strategy Department of the Corporate Strategy Division and the Human Resources & Industrial Relations Department of the Professional Business Support Sector will be dissolved.

10. Organizational Changes in the Innovation Promotion Sector and Others (Effective April 1)

Objectives and Contents:

The Lifestyle Innovations Division will be established in order to create user-oriented Lifestyle Updates businesses and develop and implement new business and technology frameworks through united efforts with Fellow Matsuoka and the relevant Companies.

In addition, the Technology Division will be established by integrating the Business Innovation Division and the Technology Innovation Division in order to create world-class technologies

and solutions by merging digital and AI technologies with material and device technologies, and continue to accumulate and evolve technologies for group-wide use, as well as accelerate the creation of technology-oriented businesses.

Accordingly, the Business Innovation Division and the Technology Innovation Division will be dissolved.

Furthermore, the Director in charge of Environment and Energy Business will be appointed in order to promote group-wide efforts to develop the environment and energy business as a new business pillar.
