NOTE 1. Organization

The North, Central American and Caribbean Volleyball Confederation, NORCECA, is a non-profit, non-governmental, Multinational and Continental Organization affiliated to the Federation Internationale de Volleyball, FIVB, founded on April 20, 1947, in Paris, France. The FIVB consists of 222 affiliated National Federations whose mission is the worldwide management and guidance of volleyball and beach volleyball in their respective countries and/or territories. The FIVB's Central Headquarters is located in the city of Lausanne, Switzerland.

The FIVB has grouped its affiliated National Federations into 5 Confederations, taking into consideration their geographical location:

- African Confederation
- Asian Confederation
- European Confederation
- North, Central American and Caribbean Confederation
- South American Confederation

NORCECA's objective is the management, organization, representation, regulation, control and evaluation of all volleyball and beach volleyball activities in the North, Central American and Caribbean Regions to support and facilitate the development of its affiliated National Federations, guaranteeing that the FIVB Constitution, Administrative, Financial, Sport, General Regulations and Disciplinary are met.

The FIVB Board of Administration must approve the Constitution, Regulations and decisions of the NORCECA Volleyball Confederation as a representative body of the FIVB. Also, NORCECA must guarantee full commitment to the general principles and guidelines of the FIVB. NORCECA was recognized as a Continental Confederation by the FIVB in 1968. The new elected authorities of NORCECA were transferred to the Dominican Republic on November 1st, 2001 and were re-elected during the XXIII NORCECA Congress 2015 and will remain for a period of 4 years until October 23rd, 2019. Mr. Cristobal Marte Hoffiz, President, represents NORCECA.

The majority of NORCECA's income comes from the FIVB annual contribution, competitions, events and activities, publicity, marketing rights and National Federation affiliation fees. As of December 31st, 2016 a total of 41 National Federations and Regional members are affiliated to the NORCECA Volleyball Confederation. The NORCECA Headquarters are located at Av. Máximo Gómez, Esquina 27 de Febrero, Volleyball Pavilion, Juan Pablo Duarte Olympic Center in the city of Santo Domingo, Dominican Republic.



NOTE 2. Accounting Policies

2.1 Income

NORCECA accounting policies recognizes its income using the accrual method.

2.2 Foreign Currencies

Transactions in foreign currencies are converted into the local currency of Dominican Pesos (RD), according to the current exchange rate at the time of the transaction. Profit and loss resulting from the transaction of foreign currencies are included in the Profit and Loss Statement.

As of December 31st 2016, the current exchange rate for the US\$ dollar used by NORCECA Confederation was RD\$46.62 per US\$1.00 and the exchange rate for the Swiss Franc was RD\$45.82 per CHF1.00

2.3 Furniture and Equipment

Furniture and equipment are registered at the acquisition cost.

The depreciation is calculated using the straight line method at an annual rate of 25% and 15%

NOTA 3 Cash and Bank Balance

The North, Central American and Caribbean Volleyball Confederation perform its operations through two current bank accounts, registered under the name of NORCECA with the signatures of Lic. 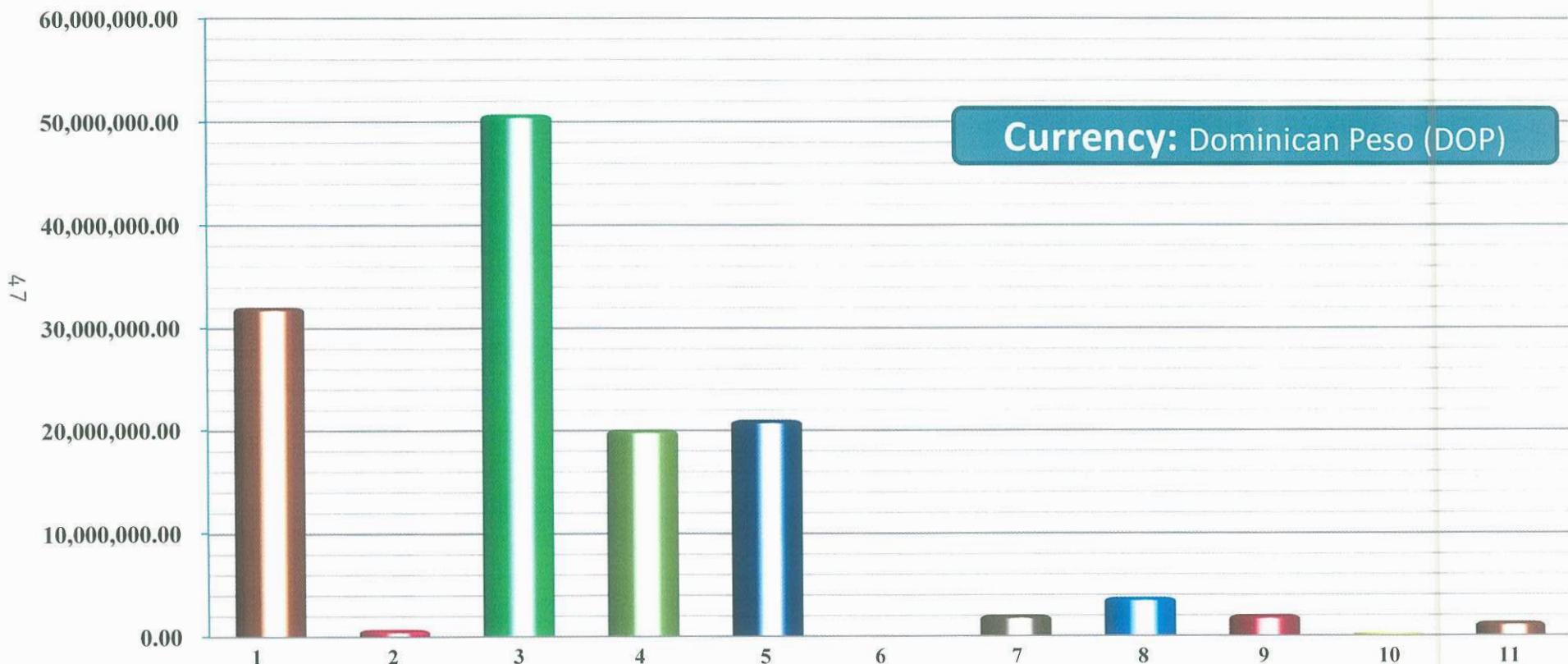

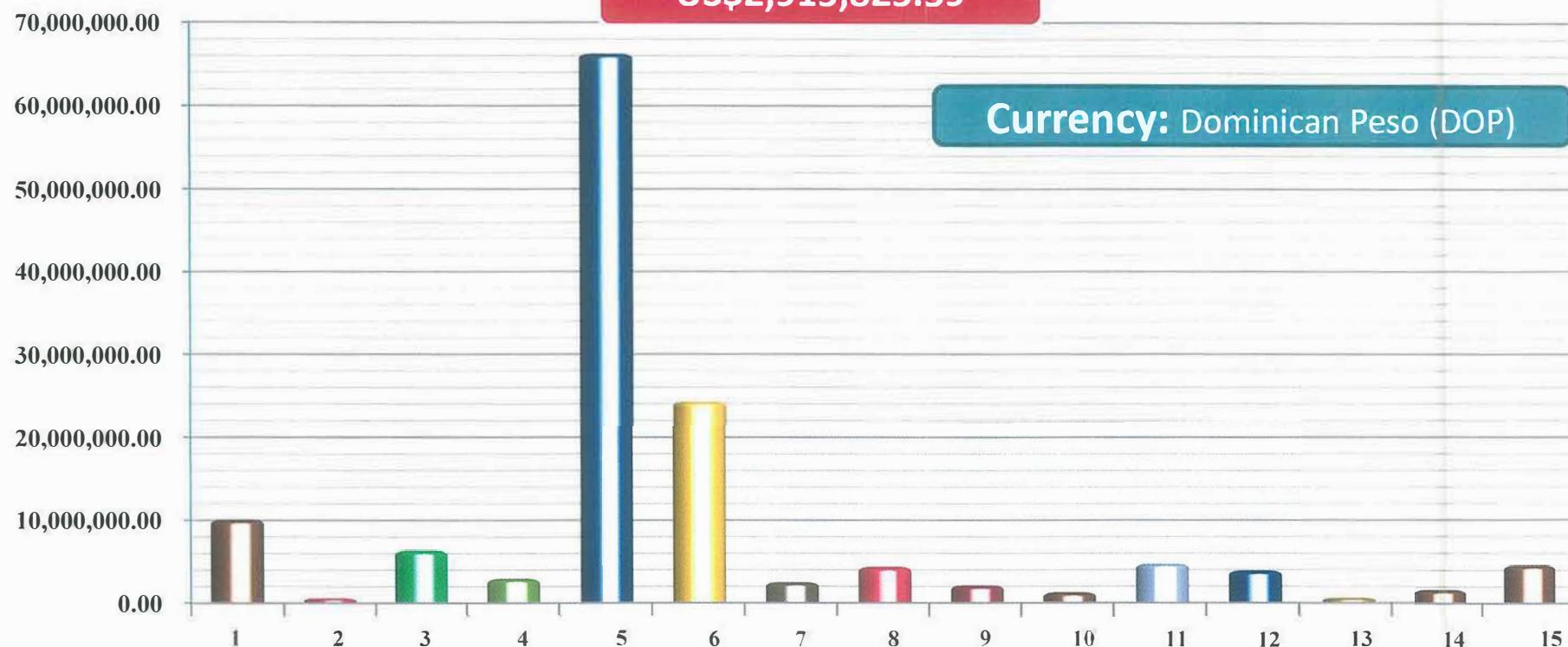

NOTE 2. Accounting Policies

2.1 Income

2.2 Foreign Currencies

Transactions in foreign currencies are converted into the local currency of Dominican Pesos (RD\$), according to the current exchange rate at the time of the transaction. Profit and loss resulting from the transaction of foreign currencies are included in the Profit and Loss Statement.

As of December 31st, 2016 and 2015 the current exchange rate for the US\$ used by NORCECA Volleyball Confederation is RD\$46.62 y RD\$45.47 and for the Swiss Franc is RD\$45.82 y RD\$45.91 respectively.

2.3 Furniture and Equipment

Furniture and equipment are registered at the acquisition cost.

The depreciation is calculated using the straight line method at an annual rate of 25% and 15%

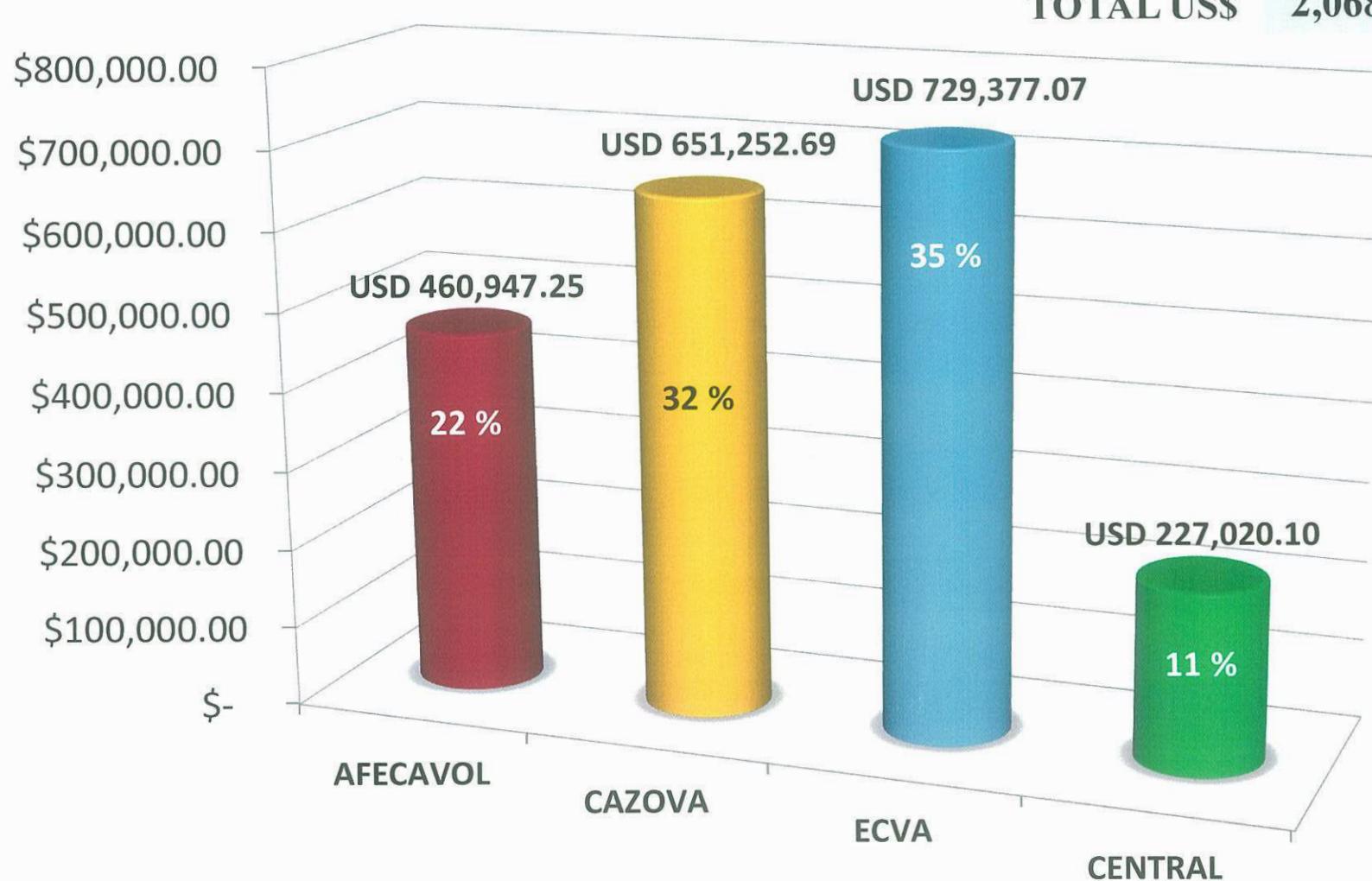

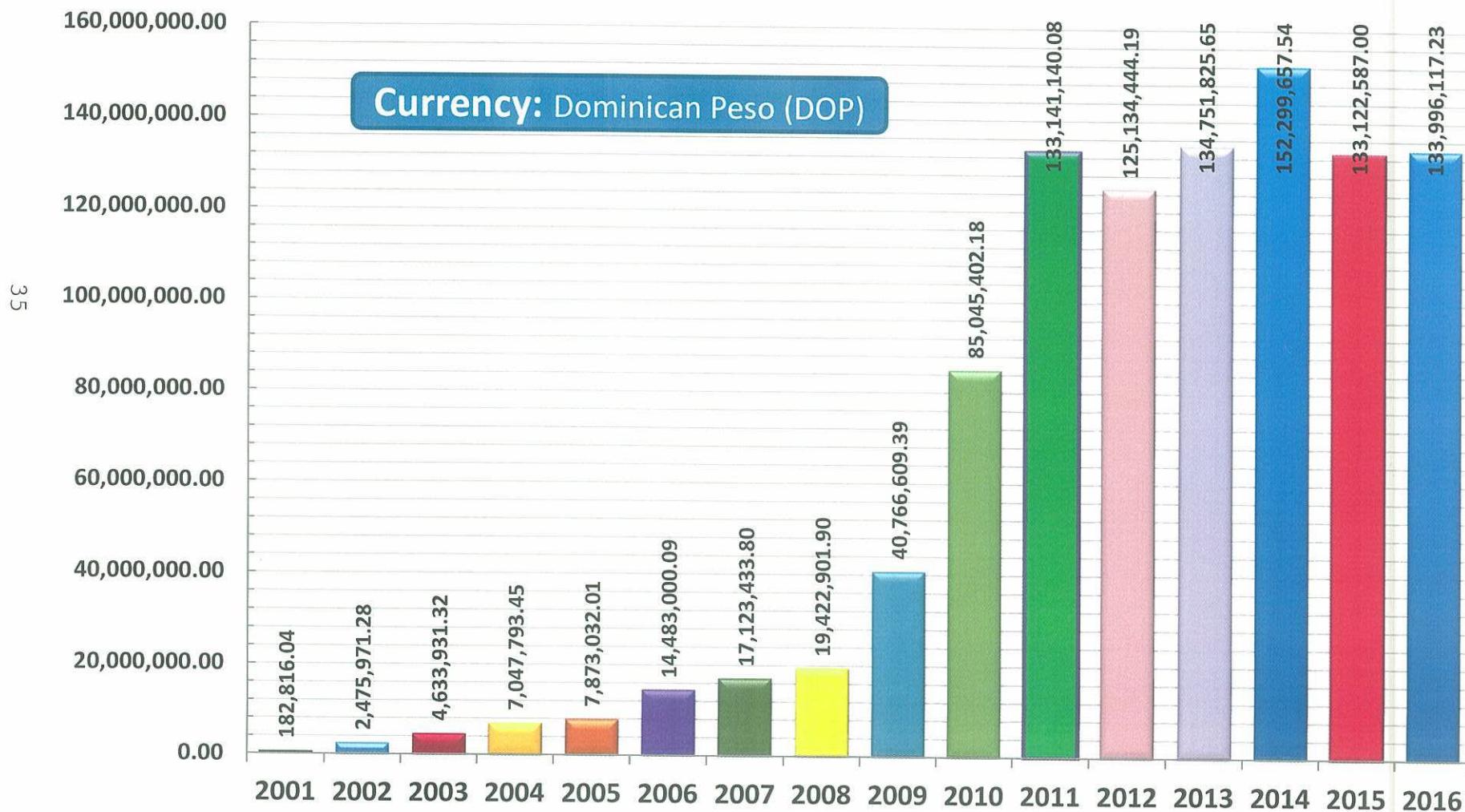

NORCECA Financial Evolution 2001- 2016



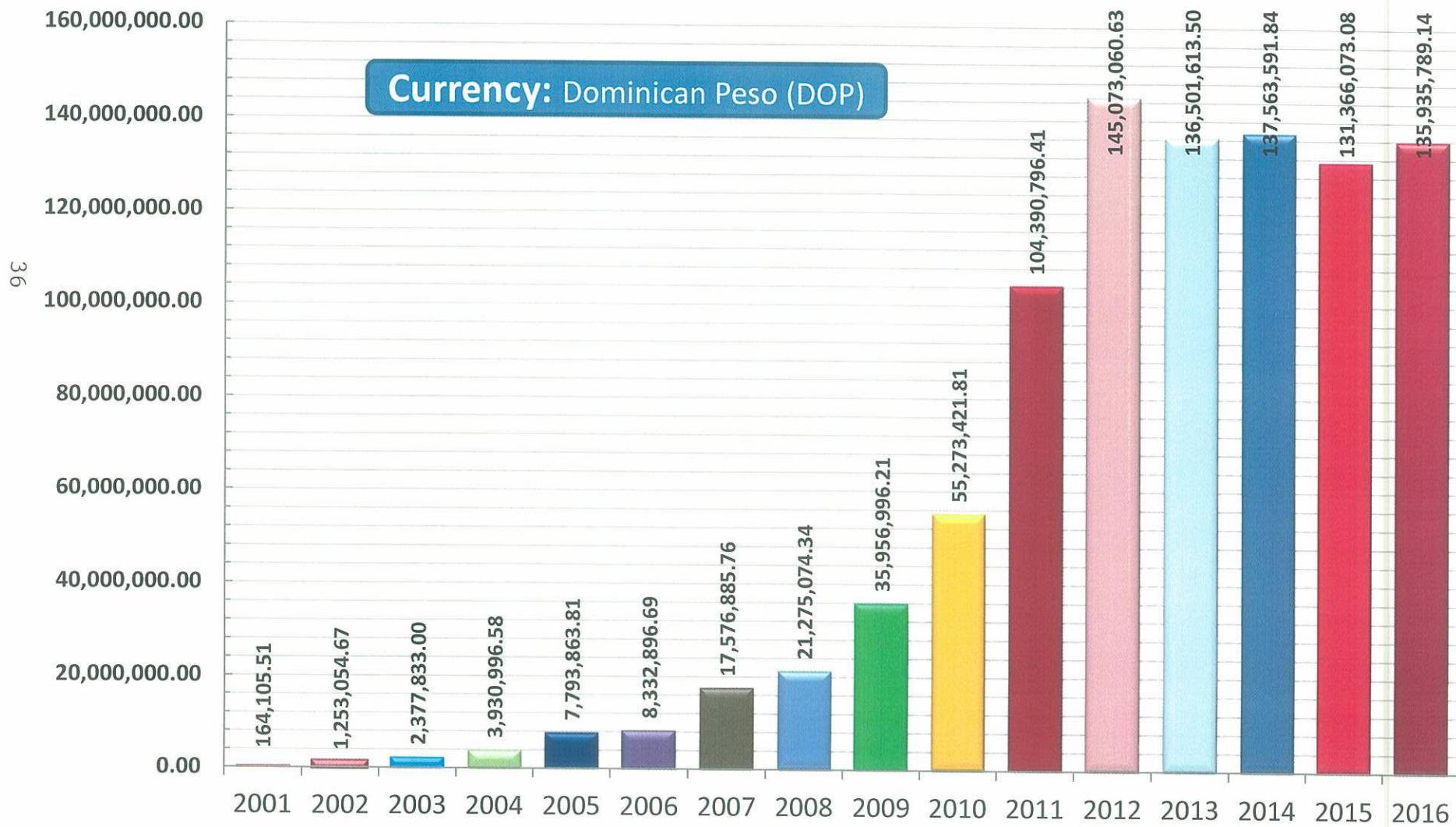
INCOME 2001-2016

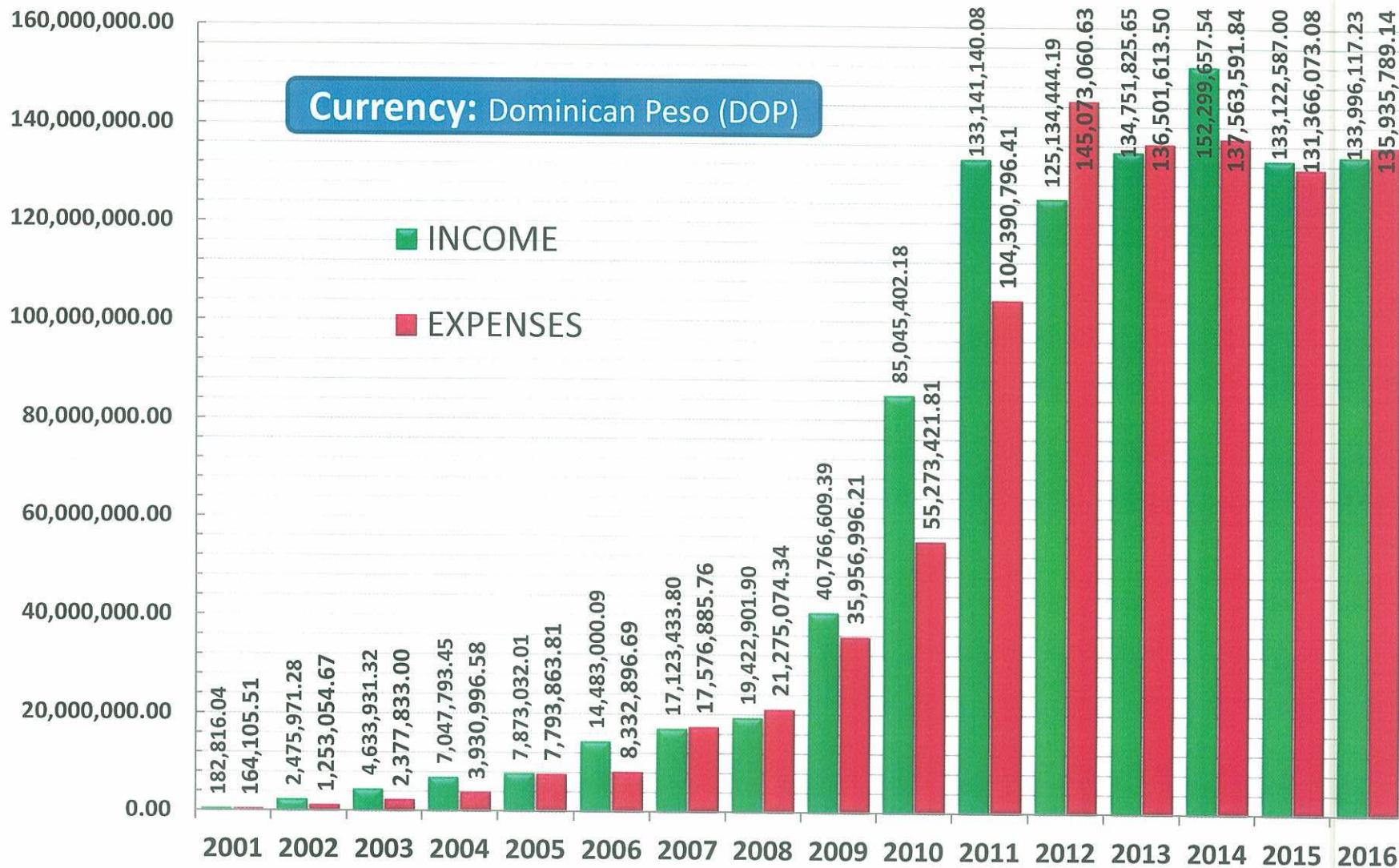
EXPENSES 2001-2016

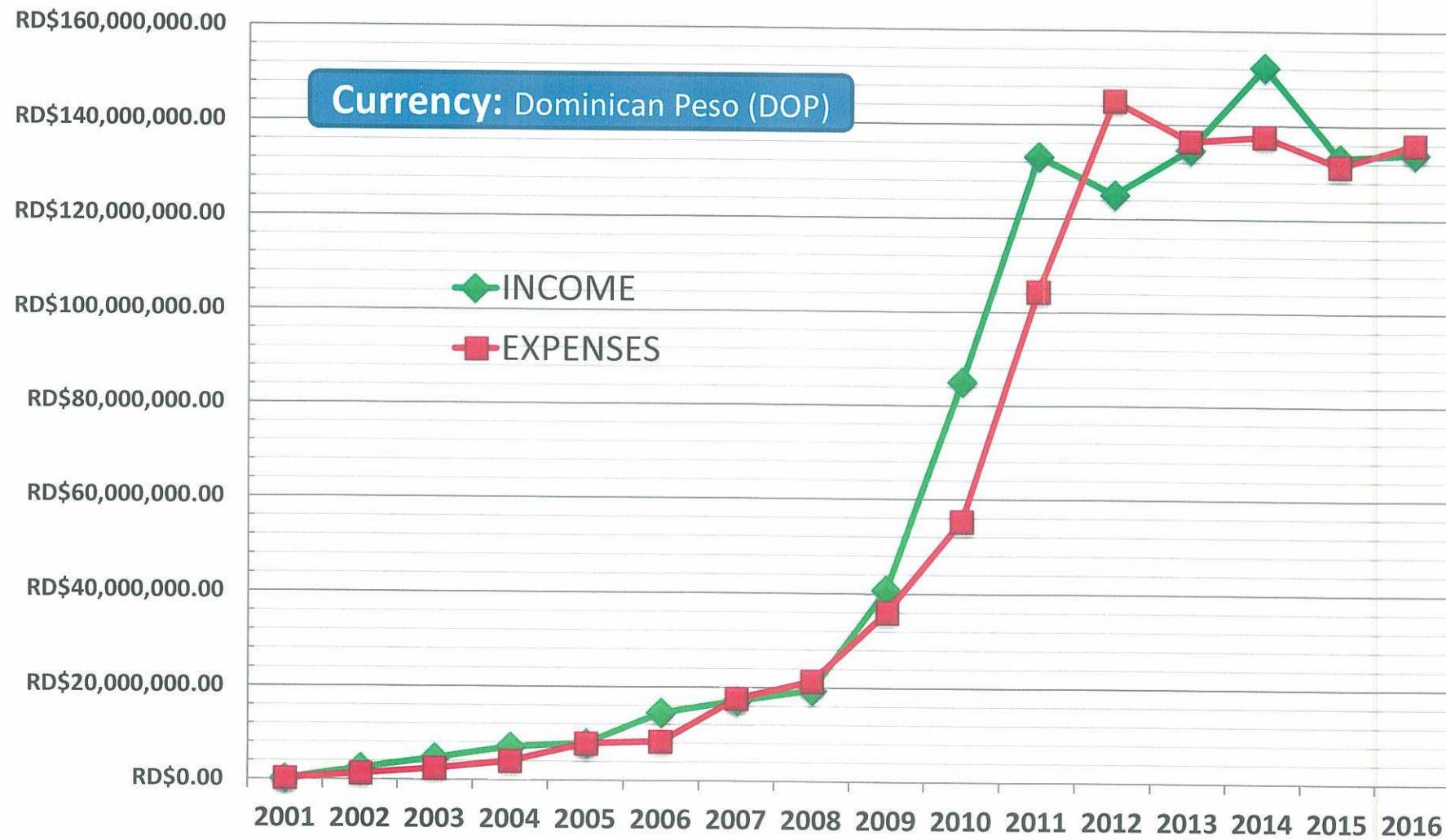


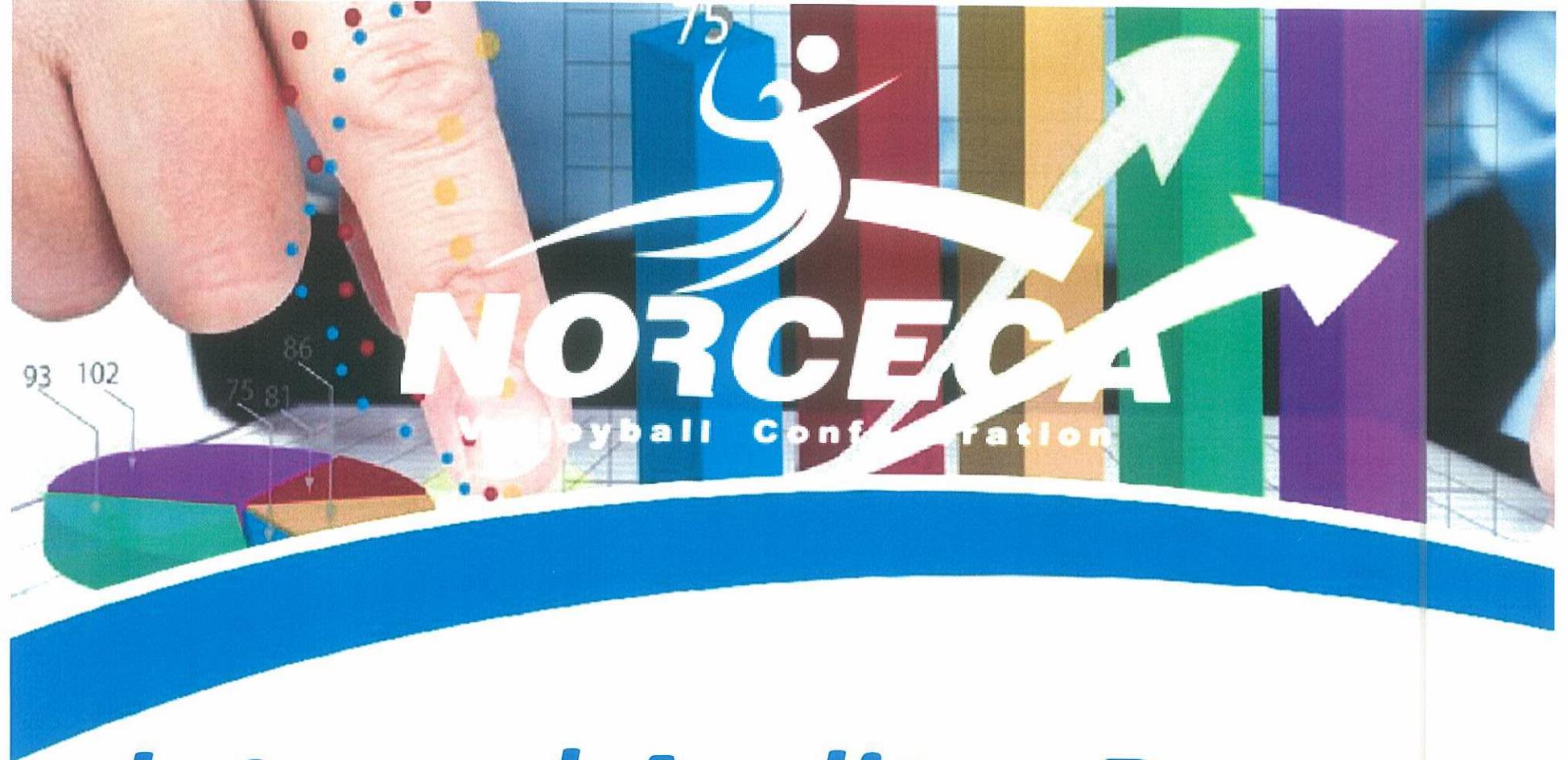
INCOME & EXPENSES 2001-2016

Internal Auditors Management Report

We have reviewed the Balance Sheet, the Statement of Activities (profit and Loss account of NORCECA Volleyball Confederation for the period ended December 31st 2016 and the budget for 2017 and 2018. It is our opinion that the Financial Statements reflect a true and fair view of the Financial Position of the Confederation.

Our review of the Financials for 2016 considered the following:

External Auditors Management Letter

We reviewed the External Auditors Management Letter for NORCECA Volleyball Confederation for the Financial Year Ended December 31st 2015.

The report documented some similar recommendations of previous Internal Audit Reports such as:-

- 1) The Accounting for Provision for Accounts Receivable noting in particular the outstanding amounts from Jamaica and querying NORCECA's policy. A similar answer was provided to the External Auditors as the Internal Auditors, that is, due to personnel constraints NORCECA accounting department do not possess an accounting handbook in which the procedures for provision are documented.
- 2) The remarks that were made by the External Auditors regarding the current accounting system, states it does not coincide with the size of such a modern organization. Notwithstanding this, the accounting department has been able to use its existing resources to prepare and finalize on a timely basis the Confederation Financial Reports.
- 3) We enquired about the Accounting Computer System Back-up, what method and how often the semi accounting system was back-up and what medium was used for storage. We were told tapes and "cloud" was used and back-up was done daily.

We congratulate the NORCECA staff on performing daily back-ups of the important information. But to guard against any changes in operating system software that can affect the performance of the current accounting system.

We will like to highly suggest the Confederation continues to pursue means to have the accounting system fully automated.

Bank Balances and Signatories

We reviewed the bank reconciliation for the year ended 2016 and found the bank reconciliation reports maintained and up to date.

We noted in the Notes to the Financial Statements on Bank Balances and in the minutes of the Board of Directors, it was communicated that the Acting General Manager be included as a signatory to bank account following the departure of the General Manager.

We urge the management of NORCECA to execute as soon as possible, the decision taken in the Executive Board to have the Acting General Manager as the third signatory to the bank account of NORCECA. Not complying with this can affect the efficiency of the daily operating activities.

Employees' Severance

We have noted the Dominican Labor Code requires the payment of severance to employees based on several types of termination including death of an employee.

We enquired from the Finance Manager if any provisions had been made in the Financial Accounts in consideration of such potential liability. No provisions had been made for such Liability.

Thus we highly recommend accounting provision be made in the Financial Accounts to consider such potential liability.

Mid-year Review

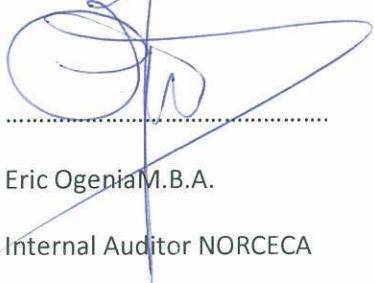
We will like to suggest that the Confederation Treasurer conducts a Mid-Year review of the Financial Statement with the accounting staff to assist and ensure a more effective understanding of the Confederation day to day operating activities. It will also help in a more timely preparation of the full year accounts.

Analysis of the budget versus the actual figures

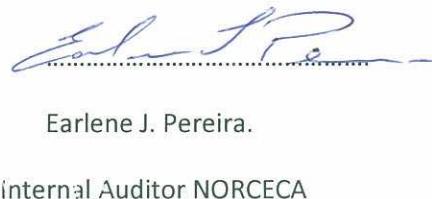
We again will like to suggest despite the constraints of the Accounting Department, that some analytical reports on the actual vs budget results for transactions with a 10% variance be performed. It will significantly enhance the process of decision making for future activities.

Conclusion:

We recognize the diligent work performed by the Accounting staff of NORCECA Confederation and ask that they continue to do a good job and also engage the knowledge of the Treasurer of NORCECA in the day to day operating activities of the office.
