Honoring Heroes	Annual contribution of at least \$35 must be made to the Public Safety Honoring Heroes foundation.	\$135.75
Humanitarian Service	Annual contribution of at least \$25 must be made in support of various Utah humanitarian service organizations.	\$125.75

Purple Heart	Provide a copy of a membership card in the Military Order of the Purple Heart Association or military discharge form DD214 issued by the National Personnel Records Center. <i>If ordering for a motorcycle, subtract \$5 from the amount on the right.</i>	\$82.75
Soccer (RSL)	Annual contribution of at least \$25 must be made to the National Professional Men's Soccer Team Support of Building Communities restricted account.	\$125.75

Share the Road	Annual contribution of at least \$25 must be made to the Share the Road Bicycle Support Fund.	\$125.75
Snowmobiler	Initial contribution of at least \$25 must be made in support of snowmobile safety education programs. No annual contribution is required.	\$125.75
Soil Conservation	Initial contribution of at least \$25 must be made in support of agricultural education programs. No annual contribution is required.	\$125.75
Special Interest	Vehicle must be 20 years old or older or must meet the requirements in Utah Code §41-1a-102(70). Provide a Statement of Facts (TC-569D) detailing the reason why your vehicle meets these requirements.	\$100.75
Utah Jazz	Annual contribution of at least \$25 must be made to the National Professional Men's Basketball Team support of women and children issues.	\$125.75
Utah Housing Opportunity (Realtor)	Annual contribution of at least \$30 must be made in support of affordable housing programs. Provide proof of membership in a trade organization for real estate licensees which has more than 15,000 Utah members.	\$130.75
Utah Law Enforcement Memorial	Annual contribution of at least \$35 must be made to the Utah Law Enforcement Memorial Endowment Fund.	\$135.75
Veterans	Initial contribution of at least \$25 must be made to the Utah Department of Veterans' and Military Affairs. An annual contribution of \$10 must be made thereafter. Applicant may select the Air Force, American Legion, Army, Coast Guard, Marines, or Navy plate. <i>If ordering for a motorcycle, subtract \$5 from the amount on the right.</i>	\$125.75
Veteran Combat Theater	Initial contribution of at least \$25 must be made to the Utah Department of Veterans' and Military Affairs. An annual contribution of \$10 must be made thereafter. Applicant may select the Army Combat Infantry Badge, Army Combat Action Badge, Air Force Combat Action Medal, or the Marine & Navy Combat Action Ribbon. Must obtain proof of qualification for the campaign or combat theater award requested from the Utah Department of Veterans' and Military Affairs.	\$125.75
Vintage	Vehicle must be at least 30 years old and not driven for general daily transportation.	\$100.75
Wildlife	Annual contribution of at least \$25 must be made in support of wildlife and wildlife habitat preservation. Applicant may select the Kestrel, Elk, Trout, or Mule Deer plate.	\$125.75
Women's Suffrage	Recognizes and commemorates women's suffrage. This plate is available to any person making the request.	\$100.75
Zion National Park	Annual contribution of at least \$25 must be made in support of Zion National Park preservation.	\$125.75

All plates, except Amateur Radio, Search and Rescue Radio, and Purple Heart, require payment of an additional \$10 fee when renewing for the next registration year. Any personalized plate that has not been renewed within six months of its expiration date will be forfeited.
