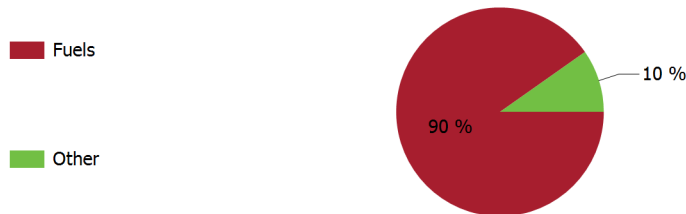

Merchandise exports growth rate in 2023

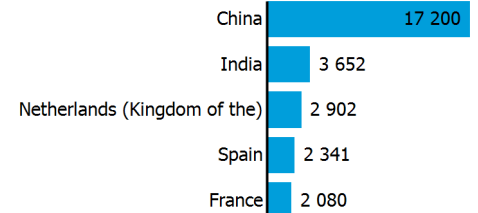
Export structure by product group in 2023

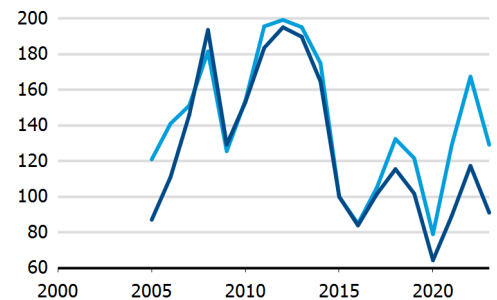

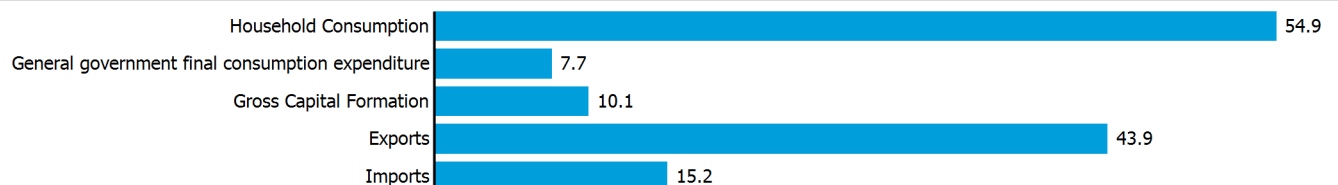

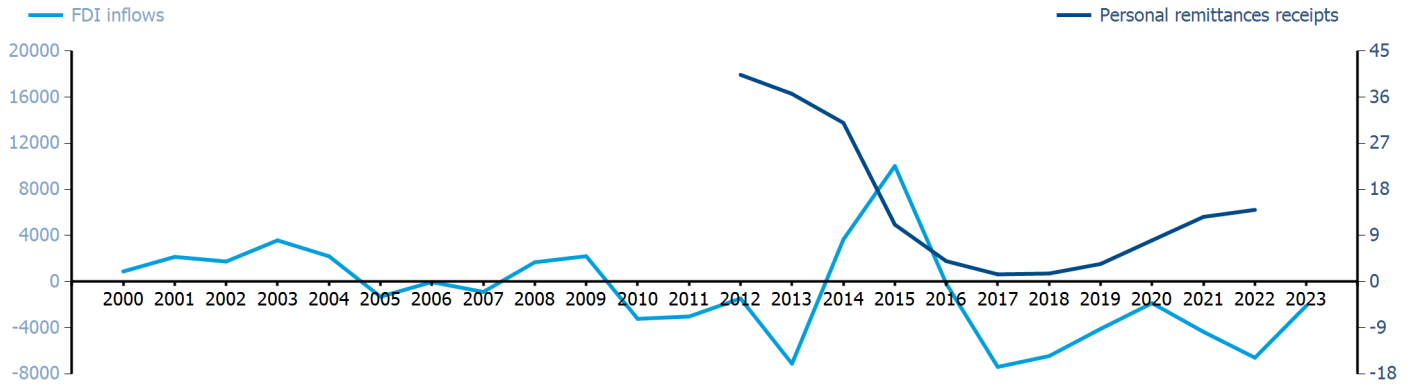

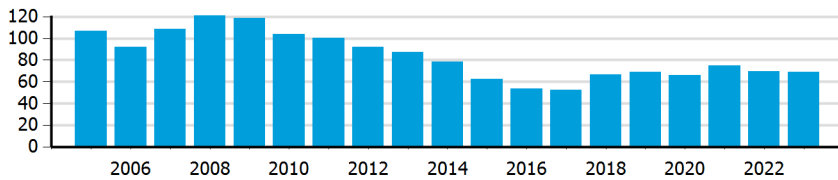

Trade openness²

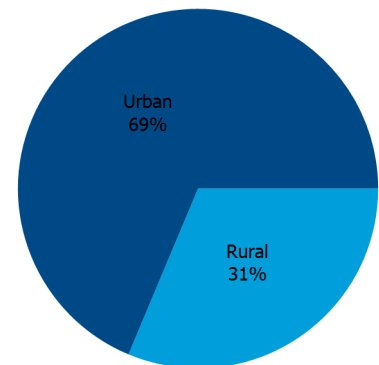
(sum of imports and exports as % of GDP)
