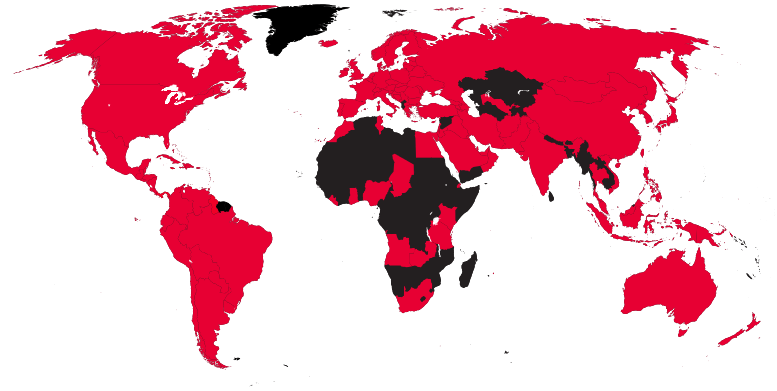

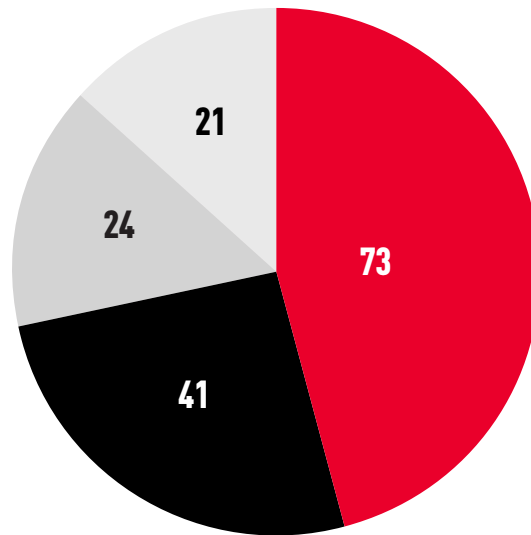


EMERGENCY ARBITRATIONS ADMINISTERED BY THE ICDR
