### STATEMENT OF POLICY

#### PRIVACY MISSION STATEMENT

Island Resort Group (Leisure) Corporation understands that our clients put great value on their privacy. With this in mind we have strived to minimise the personal data collected from our clients to the bare minimum required to respond to enquiries and send out newsletters (when the client opts in to these).

#### NO COOKIES

We also do not use cookies to maintain data transparency - except the ignore cookies required to prevent further cookies.

#### DATA ANALYTICS

Just as most website use data analytics to improve the websites and other services we do too. However we make the extra effort to make sure that any personal information received from your browser such as IP addresses are anonymised.

### PERSONAL INFORMATION WE COLLECT

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

When you make an enquiry or sign up for our newsletter, we may ask for your contact information, including items such as name, email address and information regarding your stay.

### HOW WE USE YOUR PERSONAL INFORMATION

We use the information we collect in various ways, including to:

- Provide, operate and maintain our website
- Improve, and expand our website
- Understand and analyze how you use our website
- Develop new products, services, features and functionality
- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website, and for marketing and promotional purposes

### LOG DATA

Island Resort Group (Leisure) Corporation follows a standard procedure of using log files. These log visitors when they visit websites for website analytical purposes.

#### LOG DATA - PURPOSE OF PROCESSING

Island Resort Group (Leisure) Corporation is processing the following log data:

- IP address (anonymised)
- Date and time
- Title of the page being viewed
- URL of the page being viewed
- URL of the page that was viewed prior to the current page
- Screen resolution
- Time in local timezone
- Files that were clicked and downloaded
- Link clicks to an outside domain
- Pages generation time
- Country, region, city
- Main language of the browser
- User Agent of the browser

The processing of log data by Island Resort Group (Leisure) Corporation is based on legitimate interests.

#### LOG DATA - THE LEGITIMATE INTERESTS

Since the data processed is anonymised there is limited privacy impact on the individual furthermore without the data, we would not be able to provide you the service we are currently offering to you. Your data will be used only to improve the user experience on our website and help you find the information you are looking for.

#### LOG DATA - THE EXISTENCE OF EACH OF THE DATA SUBJECT'S RIGHTS

- Right of access: you can ask us at any time to access your log data
- Right to erasure: you can ask us at any time to delete all the log data we are processing about you
- Right to object: you can object to the tracking of you log data by [contacting us](#) directly.

### THIRD PARTY PRIVACY POLICIES

### CCPA PRIVACY RIGHTS (DO NOT SELL MY PERSONAL INFORMATION)
