Subject: Executive Officer Review Decisions Report of Board Nursing Education Consultant Program Reports from May 14, 2024, to July 23, 2024.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

## Effective May 14, 2024:

## Annenberg School of Nursing Vocational Nursing Program – Request Approved
