## GRANT OF “LEVER-RULE” PROTECTION

**AGENCY:** Customs & Border Protection, Department of Homeland Security.

**ACTION:** Notice of grant of “Lever-rule” protection.

**SUMMARY:** Pursuant to 19 CFR §133.2(f), this notice advises interested parties that Customs & Border Protection (CBP) has granted “Lever-rule” protection to Arla Foods amba in respect to certain cream and processed cheese products bearing the PUCK® trademark. Notice of the receipt of an application for “Lever-rule” protection was published in the July 28, 2010, issue of the *Customs Bulletin*.

### SUPPLEMENTARY INFORMATION:

#### BACKGROUND

In accordance with 19 CFR §133.23(a)(3), CBP has determined that certain cream and processed cheese products bearing the PUCK® trademark are physically and materially different from the PUCK® articles authorized by Arla Foods amba for importation into the United States. Specifically, CBP has determined that the above-referenced gray market products differ from those authorized for importation in the United States in the following respects: the labels on the gray market goods lack nutrition information, serving size, amount of nutrients and caloric breakdown, rendering it misbranded food under the Food, Drug and Cosmetic Act, 21 U.S.C. §343; the net contents of the gray market can is not expressed in ounces as required by the Fair Packaging and Labeling Act, 15 U.S.C. §1453(a)(3)(A)(i); the gray market goods are not in compliance with the Animal Health Protection Act, 7 U.S.C. §8301 *et seq.* and 9 CFR §94.16, which prohibits the importation of milk products from regions where the animals are infected with foot-and-mouth disease and rinderpest.

## ENFORCEMENT

Arla Foods amba PUCK® cream and processed cheese products not authorized for importation into the United States shall be denied entry and subject to detention as provided for in 19 CFR §133.25, unless a label in compliance with 19 CFR §133.23(b) is applied to the goods.
