

AWARD YEAR 2024-2025 STUDENT FINANCIAL AID REFUND DATES

Attendance

You must attend your classes to be eligible for financial aid. Fall and spring attendance is confirmed starting the first week of classes through the 21^{st} day of classes each semester. The WN (Never Attended) Grade will be assigned if your attendance is not confirmed. **Financial Aid will not pay for classes with WN Grades.**

Financial Aid (Federal Pell, SEOG, Direct Loans) Refund Dates

Please see Federal Work Study (FWS) payment calendar for FWS payment dates. Checks will be mailed directly to you (address we have on CUNYfirst) if you do not have direct deposit. Summer 2024 refunds for all financial aid programs will begin on July 19, 2024 and will be issued weekly as students become eligible.

Your awards will be prorated based on the number of days you attended during the semester.
