RESOLUTION NO. 2020 - 17

WHEREAS, pursuant to Education Code ("EC") Sections 47605 and 47607, the Fresno County Board of Education ("County Board"), on August 5, 2020, received a material revision ("Material Revision") from Crescent View West Public Charter, Inc. ("CVWPC") regarding its currently authorized charter covering the five year term of July 1, 2016 through June 30, 2021; and

WHEREAS, a committee ("Charter Committee") reviewed the Material Revision pursuant to the criteria established in EC Sections 47605 and 47607, and other applicable statutes and regulations; and

WHEREAS, a public hearing on the Material Revision was conducted on September 17, 2020 at which time the County Board received and considered the level of support for the Material Revision; and

WHEREAS, the Charter Committee reviewed the Material Revision and submitted for the County Board's consideration a Committee Report regarding the Material Revision dated September 30, 2020 ("Committee Report"), which is attached as Attachment A, in which the Charter Committee recommends approval of the Material Revision.

NOW, THEREFORE, BE IT RESOLVED by the Fresno County Board of Education as follows:

- 1. The County Board finds the above-listed recitals to be true and correct, and incorporates them herein by this reference.
- 2. The County Board hereby adopts the Committee Report (See attached Attachment A) which is incorporated herein in its entirety by this reference.
- 3. The County Board, having reviewed and considered the Material Revision, applicable Education Code, other applicable statutes and regulations, the Committee Report, and Committee findings, hereby approves the Material Revision.
- 4. The County Board's approval of the Material Revision is conditioned upon CVWPC entering into an amendment to the current memorandum of understanding between CVWPC and the County Board within 30 days reflecting the changes set forth in the Material Revision.
