In the Matter Regarding Approval of the Crescent View West Public Charter Renewal Petition

RESOLUTION NO. 2020 - 18

WHEREAS, pursuant to Education Code ("EC") Section 47607, the Fresno County Board of Education ("County Board"), on August 5, 2020, received a renewal charter petition ("Renewal Petition") covering the five year term beginning July 1, 2021 and ending June 30, 2026, for the Crescent View West Public Charter, Inc. ("CVWPC"); and

WHEREAS, CVWPC is currently authorized pursuant to a charter that had previously been granted by the County Board for the term of July 1, 2016 through June 30, 2021; and

WHEREAS, a committee ("Charter Committee") reviewed the Renewal Petition pursuant to the criteria established in EC Sections 47605 and 47607, and other applicable statutes and regulations; and

WHEREAS, a public hearing on the Renewal Petition was conducted on September 17, 2020 at which time the County Board received and considered the level of support for the Renewal Petition; and

WHEREAS, the Charter Committee reviewed the Renewal Petition and submitted for the County Board's consideration a Committee Report regarding the Renewal Petition dated September 30, 2020 ("Committee Report"), which is attached as Attachment A, in which the Charter Committee recommends approval of the Renewal Petition.

NOW. THEREFORE, BE IT RESOLVED by the Fresno County Board of Education as follows:

- 1. The County Board finds the above-listed recitals to be true and correct, and incorporates them herein by this reference.
- 2. The County Board hereby adopts the Committee Report (See attached Attachment A) which is incorporated herein in its entirety by this reference.
- 3. The County Board, having reviewed and considered the Renewal Petition, applicable Education Code, other applicable statutes and regulations, the Committee Report, and Committee findings, hereby approves the Renewal Petition for a term of five years (July 1, 2021 through June 30, 2026).
- 4. The County Board's approval of the Renewal Petition is conditioned upon CVWPC entering into a memorandum of understanding with the County Board within 30 days setting forth the terms and conditions governing CVWPC's operation and program.
