WHEREAS, experience in the arts develops insights and abilities central to the experience of life, and the arts are collectively a most important repositories of culture;

WHEREAS, many national and state professional arts education associations hold celebrations in the month of March, focused on students' participation in the arts;

WHEREAS, these celebrations give California schools a unique opportunity to focus on the value of the arts for all students, to foster cross-cultural understanding, to give recognition to the state's outstanding young artists, to focus on careers in the arts available to California students, and to enhance public support for this important part of our curriculum;

WHEREAS, the California State Board of Education states in its Arts Education Policy adopted in July 1989 that each student should receive a high quality, comprehensive arts education program based on the adopted California Arts Framework for California Public Schools, Pre-Kindergarten through Grade Twelve (2020);

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education and the Fresno County Superintendent of Schools is proclaiming the month of March 2021 as Arts Education Month and encourages all school districts to celebrate the arts with meaningful student activities and programs that demonstrate learning and understanding

in and through all arts disciplines, even in this time of distance learning, and encourage all Fresno County School Districts to participate with appropriate activities and curriculum on this day and throughout the year.
