WHEREAS, it is essential that we educate residents about suicide risks, signs, resources and the ways they affect all people in the community; and

WHEREAS, we must encourage relatives, friends, co-workers, and providers to recognize the signs of a problem, and guide those in need to appropriate services and supports; and demonstrating to speak up and asking for help is not a weakness; and

WHEREAS, Suicide Prevention Month inspire millions of Americans to raise awareness, build resiliency, and find hope.
