WHEREAS, Earth Day was first celebrated on April 22, 1970; and

WHEREAS, Earth Day is an annual event created to promote environmental citizenship and stewardship year-round by encouraging people to find ways to protect the environment including planting trees, removing litter, conserving water and energy, waste reduction, recycling, and other environmentally responsible actions; and

WHEREAS, the Fresno County Board of Education ("County Board") and the Fresno County Superintendent of Schools ("County Superintendent") acknowledge that education regarding environmental principles and concepts is important as outlined in Education Code section 51227.3 and County Superintendent and Board Policy No. 6142.5; and

WHEREAS, the County Board and the County Superintendent recognize that schools play a crucial role in educating students about the importance of the environment and in preparing them to be stewards of natural resources; and

WHEREAS, the County Board and the County Superintendent believe that students should value the environment, respect all life forms, understand the basic ecological principles which support the planet, and live an ecologically responsible life-style.




