In the Matter of Issuing or Canceling Temporary Certificates

RESOLUTION NO. 2023 - 29

WHEREAS, Education Code Section 44332 authorizes the Fresno County Board of Education to issue temporary certificates to individuals authorizing them to provide and be compensated for instructional, pupil and administrative services while they have their credential or permit applications pending with the California Commission on Teacher Credentialing ("CTC"); and

WHEREAS, Section 44332 further directs the County Board to cancel temporary certificates upon receipt of notification from CTC regarding an individual's ineligibility for a credential or permit; and

WHEREAS, given the ongoing volume of requests for temporary certificates and the need for local districts and FCSS to immediately hire employees to provide instructional, pupil and administrative services, it is impractical for the County Board to regularly authorize the issuance of temporary certificates or to cancel temporary certificates upon receipt of specified CTC notification.

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education delegates the responsibility for and authorizes the Fresno County Superintendent of Schools or the County Superintendent's designee to issue or cancel temporary certificates on behalf of the County Board in accordance with Education Code Section 44332.

BE IT FURTHER RESOLVED that the Board hereby ratifies the issuance of the temporary certificates between January 1, 2023 and July 31, 2023 more fully described in Exhibit A to this Resolution.

BE IT FURTHER RESOLVED that the issuance or cancelation of temporary certificates shall be presented to the Fresno County Board of Education for ratification on a quarterly basis following the adoption of this Resolution.

BE IT FURTHER RESOLVED that the Fresno County Superintendent of Schools or the County Superintendent's designee are further delegated the authority to take all necessary and proper actions to consummate the intent of this Resolution.
