



VERIFICATION STATEMENT GREENHOUSE GAS EMISSIONS

APEX Companies LLC, (Apex) was engaged to conduct an independent verification of the greenhouse gas (GHG) emissions reported by IQVIA for the period stated below. This Verification Statement applies to the related information included within the scope of work described below.

The determination of the GHG emissions is the sole responsibility of IQVIA. Apex's sole responsibility was to provide independent verification on the accuracy of the GHG emissions reported and on the underlying systems and processes used to collect, analyze and review the information.

Boundaries of the reporting company GHG emissions covered by the verification:

- Operational Control
- Global
- Exclusions:
 - Q2 locations operated by Quest Diagnostics

Emissions data verified:

- **Scope 1:** 37,342 metric tons of CO₂ equivalent
- **Scope 2 (Location-Based):** 50,778 metric tons of CO₂ equivalent
- **Scope 2 (Market-Based):** 53,345 metric tons of CO₂ equivalent
- **Scope 3:**
 - Category 6: Business Travel: 90,872 metric tons of CO₂ equivalent
- **Year over Year Change in Emissions (2017-2018):**
 - Scope 1: 1.5%
 - Scope 2 (location-based): -1.7%
 - Scope 3: (market-based): -2.0%

Data and information supporting the Scope 1, Scope 2 and Scope 3 GHG emissions assertion were in some cases estimated rather than historical in nature.

Period covered by GHG emissions verification:

- January 1, 2018 to December 31, 2018

GHG Reporting Protocols against which verification was conducted:

- World Resources Institute (WRI)/World Business Council for Sustainable Development (WBCSD) Greenhouse Gas (GHG) Protocol Corporate Accounting and Reporting Standard (Scope 1 and 2)
- WRI/WBCSD Greenhouse Gas Protocol Corporate Value Chain (Scope 3) Accounting and Reporting Standard (Scope 3)

GHG Verification Protocol used to conduct the verification:

- ISO 14064-3: Greenhouse gases -- Part 3: Specification with guidance for the validation and verification of greenhouse gas assertions

Level of Assurance and Qualifications:

- Limited
- This verification used a materiality threshold of $\pm 5\%$ for aggregate errors in sampled data for each of the above indicators

GHG Verification Methodology:

- Interviews with relevant personnel of IQVIA's consultant;
- Review of documentary evidence produced by IQVIA and their consultant;
- Review of IQVIA data, information systems and methodology for collection, aggregation, analysis and review of information used to determine GHG emissions; and
- Audit of sample of data used by IQVIA to determine GHG emissions.

Assurance Opinion:

Based on the process and procedures conducted, there is no evidence that the GHG emissions assertion shown above:

- is not a fair representation of the GHG emissions data and information; and
- has not been prepared in accordance with the WRI/WBCSD GHG Protocol Corporate Accounting and Reporting Standard (Scope 1 and 2), and WRI/WBCSD Greenhouse Gas Protocol Corporate Value Chain (Scope 3) Accounting and Reporting Standard (Scope 3).

It is our opinion that IQVIA has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these GHG emissions for the stated period and boundaries.


Statement of independence, impartiality and competence
