Exam Registration

To be eligible to take ISACA exams, candidates must first register. For registration, please refer to the [Registration Guide](#). Once you have registered and paid for an exam, you will receive a notification by email that you are eligible to schedule your appointment.



Note: Your ISACA profile registration name must be identical to your government-issued photo ID.

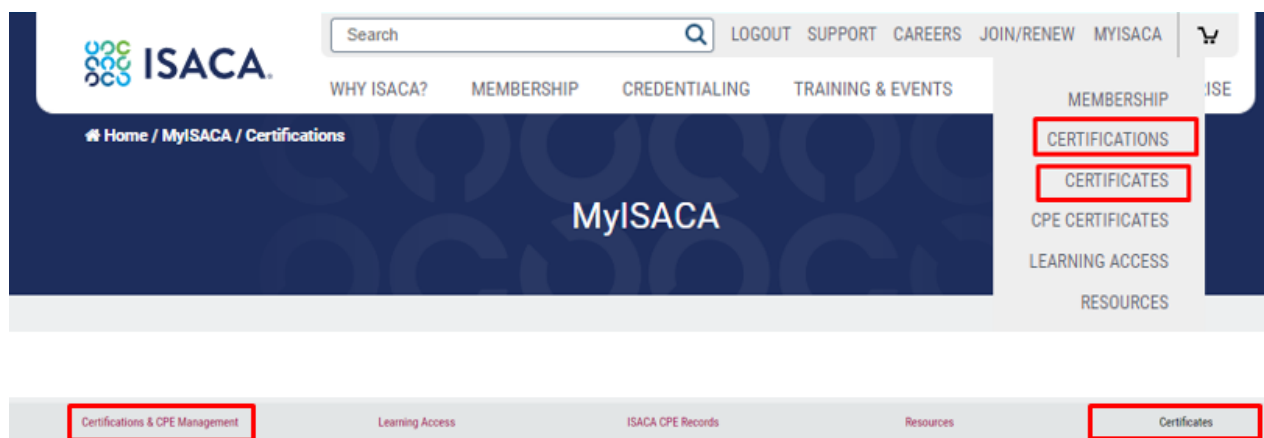
Special Accommodations

Special testing accommodations must be requested during the registration process and approved by ISACA before scheduling an exam. To request special testing accommodations please follow the steps below.

1. During the exam registration process, be sure to check the special accommodations requirement field.
2. Print the [Special Accommodations Request Form](#).
3. Complete the ISACA Special Accommodations Request Form.
Note: The form must be completed by you and your healthcare professional.
4. Submit the form to ISACA at [ISACA Customer Support](#).

Navigating My ISACA page

1. To schedule your exam please log in to your ISACA profile at www.isaca.org/MyISACA.
 - For the certification exams [CISA](#), [CRISC](#), [CISM](#), [CGEIT](#), or [CDPSE](#), please click the “**Certifications & CPE Management**” tab.
 - For other exams please click the “**Certificates**” tab.
2. Scroll down until you find the exam for which you registered. This will redirect you to the PSI scheduling platform.

Navigating the PSI Portal

1. After you are directed to the PSI portal, you will see the following options:
 - Schedule - Select and Book Tests
 - Manage - View Booked Tests
2. In the “SCHEDULE” tab, you will be able to view available tests and select your preferred test option from the list of tests you are eligible to take. Once you have selected the test you want from the eligible options, you will be able to continue your booking process by choosing your preferred modality, location (if applicable), date, and time.
3. In the “Manage” tab, you will be able to view and manage the tests you have previously booked. In case you need to modify any test details such as time, date, or location (if applicable), you may reschedule or cancel your exam. In addition, you can view the “Test Instructions.”

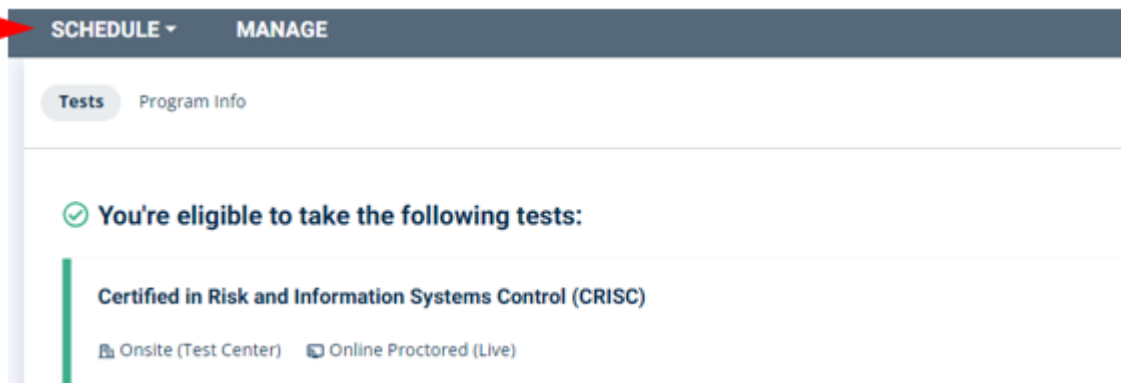

PSI Exam Center Regulations - Live Proctored

- No conversing or any other form of communication among candidates is permitted once you enter the examination area.
- You are prohibited from reproducing, communicating or transmitting any test content in any form for any purpose. Copying or communicating content is a violation of PSI security policy. Either one may result in the disqualification of examination results, may lead to legal action and will be reported to your Licensing Authority/Sponsor.

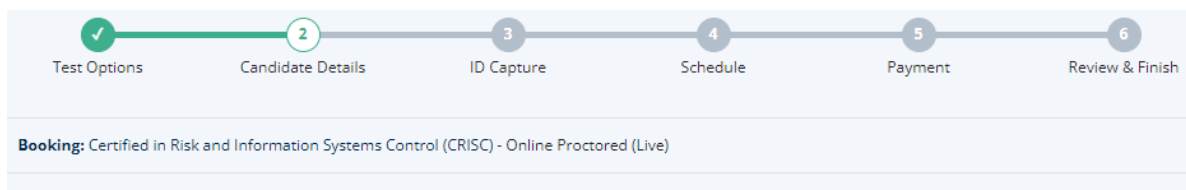

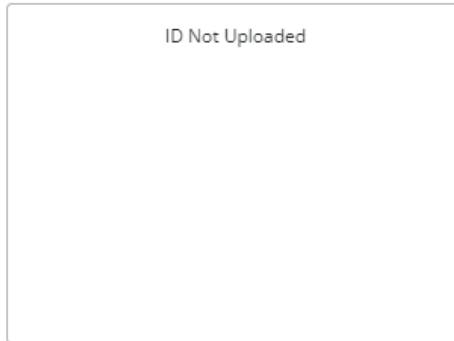

Photo Identification Capture

As part of taking an Online Proctored live test you must meet certain requirements during the check-in process before beginning your test. One of the check-in requirements is that you must submit a Photo Identification card to a live proctor for verification. We highly recommend that you go ahead and capture your Photo ID card and submit it here. Your Photo ID will be saved under your account and can be view by the proctor during the check-in process. You can skip this ID capture step as it is not required to book your test today or if you have already submitted one. If you did not submit your Photo ID today you can still submit it later after this booking.

How to Capture Your Photo ID

We have provided a secure site for capturing your Photo ID online. You have the option to use your mobile phone camera or desktop/laptop camera. Please scan the QR code with your phone camera to begin or use the provided link if you wish to use your desktop or laptop camera.

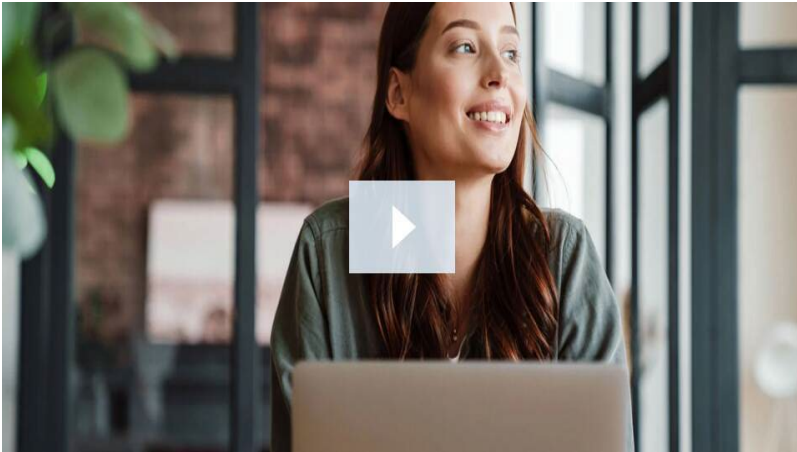

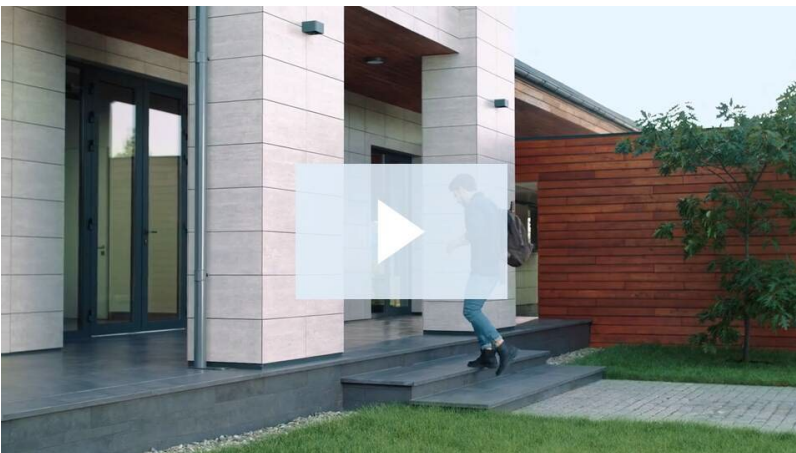
