1. TOPIX Information (2)

(3) Volume Charge

For the redistribution of "Index Constituents Master" or "Change In Constituents Level (Forecast)", the following volume charge fees will be applied. Depending on the data provision method, 1) terminal service or 2) data feed service, the number of terminals or users shall be reported, and the fee will be charged based on the number. If the user provides both terminal and data feed services, the both fees will be applied.

4. Other Rules



- (1) Data Feed Service
- 1 ID is provided per subscription.
- The number of Global IP address for setting is limited to 16 per 1ID. (For IP range, every single IP address in the range will be counted.)
- In case where the number of Global IP address exceeds 16, additional fee of 20,000JPY/month/exceeded IP will be charged.

(2) Web Service

- Following number of IDs will be provided per subscribing service category.
- Single Entity Use or Redistribution : 3 ID
- Affiliate Companies Use : 6 ID

*Multiple login with the same ID is not available.

• For additional IDs, additional fee of 10,000JPY/month/ID will be charged.
