Dyma'r pedwerydd gorchymyn cychwyn a wnaed gan Weinidogion Cymru o dan Ddeddf Safonau a Threfniadaeth Ysgolion (Cymru) 2013 ("Deddf 2013"). Mae'r Gorchymyn hwn yn dwyn i rym ar 20 Chwefror 2014 ddarpariaethau canlynol Deddf 2013:

This is the fourth commencement order made by the Welsh Ministers under the School Standards and Organisation (Wales) Act 2013 ("the 2013 Act"). This Order brings into force on 20 February 2014 the following provisions of the 2013 Act:

- (a) Pennod 1 o Ran 2 (ymyrryd ym materion rhedeg ysgolion a gynhelir);
  - (b) Pennod 2 o Ran 2 (ymyrryd mewn awdurdodau lleol);
  - (c) adran 96 (diddymu'r ddarpariaeth am god ymarfer ar gyfer y berthynas rhwng awdurdodau lleol ac ysgolion);
  - (d) adran 99 (mân ddiwygiadau a diwygiadau canlyniadol) i'r graddau y mae'n ymwneud â'r diwygiadau a wneir gan Ran 1 o Atodlen 5;
  - (e) Atodlen 1 (cyrff llywodraethu sydd wedi eu ffurfio o aelodau gweithrediaeth interim);
  - (f) Rhan 1 o Atodlen 5 (mân ddiwygiadau a diwygiadau canlyniadol sy'n ymwneud â Rhan 2 o Ddeddf 2013); ac
  - (g) paragraffau 32 a 34(2) o Ran 3 o Atodlen 5 (diddymu adran 58 o Ddeddf Addysg ac Arolygiadau 2006).
- (a) Chapter 1 of Part 2 (intervention in conduct of maintained schools);
  - (b) Chapter 2 of Part 2 (intervention in local authorities);
  - (c) section 96 (repeal of provision for code of practice for local authority school relations);
  - (d) section 99 (minor and consequential amendments) in so far as it relates to the amendments made by Part 1 of Schedule 5;
  - (e) Schedule 1 (governing bodies consisting of interim executive members);
  - (f) Part 1 of Schedule 5 (minor and consequential amendments relating to Part 2 of the 2013 Act); and
  - (g) paragraphs 32 and 34(2) of Part 3 of Schedule 5 (repeal of section 58 of the Education and Inspections Act 2006).

Mae erthygl 3 o'r Gorchymyn hwn yn darparu bod unrhyw weithred, datganiad neu gyfarwyddyd y mae Gweinidogion Cymru wedi ei wneud o dan eu pwerau yn adrannau 496 i 497A o Ddeddf Addysg 1996 ("Deddf 1996"), neu mewn perthynas â'r pwerau hynny, yn parhau i fod yn gymwys. Mae hefyd yn darparu y caniateir i gyfarwyddyd pellach, mewn perthynas â'r un materion, gael ei wneud o dan adrannau 496 i 497A o Ddeddf 1996.

Article 3 of this Order provides that any act, declaration or direction that the Welsh Ministers have made under or relating to their powers in sections 496 to 497A of the Education Act 1996 ("the 1996 Act") continue to apply. It also provides that a further direction, in relation to the same matters, may also be made under sections 496 to 497A of the 1996 Act.

The Welsh Ministers, in exercise of the powers conferred upon them by sections 97 and 100 of the School Standards and Organisation (Wales) Act 2013(1) make the following Order:

**Title and interpretation**

1.—(1) The title of this Order is the School Standards and Organisation (Wales) Act 2013 (Commencement No.4 and Savings Provisions) Order 2014.

(2) In this Order, "the 2013 Act" ("*Deddf 2013*") means the School Standards and Organisation (Wales) Act 2013.

**Provisions coming into force on 20 February 2014**

2. Subject to article 3, the appointed day for the following provisions of the 2013 Act coming into force is 20 February 2014—

- (a) Chapter 1 of Part 2 (intervention in conduct of maintained schools);
- (b) Chapter 2 of Part 2 (intervention in local authorities);
- (c) section 96 (repeal of provision for code of practice for local authority school relations);
- (d) section 99 (minor and consequential amendments) in so far as it relates to the amendments made by Part 1 of Schedule 5;

**Arbedion mewn perthynas ag adrannau 496 i 497A o Ddeddf Addysg 1996**

3.—(1) Nid yw dod ag unrhyw un neu ragor o'r darpariaethau a nodir yn erthygl 2 i rym yn effeithio ar unrhyw weithred a wneir, unrhyw ddatganiad nac unrhyw gyfarwyddyd o dan bwerau Gweinidogion Cymru yn adrannau 496 i 497A o Ddeddf Addysg 1996(1) neu mewn perthynas ag arfer y pwerau hynny, ac mae'r adrannau hynny yn parhau i fod yn gymwys fel pe na bai'r darpariaethau a nodir yn erthygl 2 wedi eu gwneud.

(2) Pan fo Gweinidogion Cymru wedi dyroddi cyfarwyddyd drwy arfer eu pwerau yn adrannau 496 i 497A o Ddeddf Addysg 1996 ("y pwerau cyfarwyddo") cyn i unrhyw un neu ragor o'r darpariaethau a nodir yn erthygl 2 ddod i rym a'u bod wedi eu bodloni y dylai cyfarwyddyd pellach gael ei ddyroddi mewn perthynas â'r un materion drwy arfer y pwerau cyfarwyddo, mae'r adrannau hynny yn parhau i fod yn gymwys fel pe na bai'r darpariaethau a nodir yn erthygl 2 wedi eu gwneud.

**Savings in relation to sections 496 to 497A of the Education Act 1996**

3.—(1) The coming into force of any of the provisions set out in article 2 does not affect any act done, any declaration or any direction under, or in relation to the exercise of the Welsh Ministers' powers in sections 496 to 497A of the Education Act 1996(1) and those sections continue to apply as if the provisions set out in article 2 had not been made.

(2) Where the Welsh Ministers have issued a direction in exercise of their powers in sections 496 to 497A of the Education Act 1996 ("the direction powers") before any of the provisions set out in article 2 come into force and they are satisfied that a further direction should be issued in relation to the same matters in exercise of the direction powers those sections continue to apply as if the provisions set out in article 2 had not been made.
