Report:

The 2018 OCI schedule was finalized and distributed in December, after implementing changes affecting the Western Canada schools in response to post-recruitment employer and school feedback. We continue to assist with one-off issues related to 2018 venues.

The 2019 OCI schedule has been drafted and will be discussed at the CLCDN meeting with school representatives in the summer.

Anna Decia-Gualtieri will take over as the lead vice-chair of the Committee in April at the annual meeting, while Shannon Leo will stay on the Committee for another year to assist. Jennifer Nadon from the University of Ottawa has joined Mike Molas from Queen's University as co-Vice-Chair of this Working Group.

The Summer 2017 Survey collected 137 responses from students who interviewed for 2018 Articling positions in Calgary, Ottawa, Vancouver, and Toronto. The Aggregate Report was received on November 13 and distributed to law schools through the CLCDN listserv. Preliminary findings were shared at the NALP Winter Meeting in December. A full summary report is being finalized and will be distributed via NALP Connect the week of January 29th. Employers in those markets who received specific comments will also be emailed individual reports, at that time.

The Fall 2017 Survey collected 301 responses from students who interviewed for 2018 Summer positions in Calgary, Vancouver, and Toronto. The Aggregate Report was received on December 6 and distributed to law schools through the CLCDN listserv.

Looking Forward:

The Vice-Chairs will work to identify specific issues as identified by survey respondents from the Fall 2017 survey, which will be reported via NALP Connect. While a full summary report will not be prepared for this survey, employers who received specific comments will still be emailed individual reports.

The Vice-Chairs will email Judy Collins with updated survey questions for the Winter 2018 survey, which will survey students interviewing for 1L and 2L summer positions in Calgary, Toronto, and Ottawa. The intent is for the survey to go live the week of February 26 and remain open for approximately 3 weeks. The Vice-Chairs will work to identify specific issues from the Winter 2018 survey, which will be reported via NALP Connect. While a full summary report will not be prepared for this survey, employers who received specific comments will still be emailed individual reports.

The Working Group will also continue to work with the Summer and Articling Working Group to identify best practices in the design and implementation of future surveys.
