**Update:** The Working Group is still in the process of finalizing the draft 2020 OCI schedule. It is currently waiting on approval from the Vancouver Bar Association for in-firm processes (Call Day, In-Firm Interview Week, Offer Day). Alberta will likely align itself with these processes, but also require confirmation. The approval is unlikely to come before the beginning of the year. A draft of the 2021 OCI schedule is in the process of being prepared, drawing upon feedback received from certain schools. The Chair will be reaching out to all schools to confirm OCI dates ahead of circulating the draft broadly to others outside of the Working Group for in-put/consideration.

**Update:** This is a quiet time for the Canadian Industry Data Working Group as our two 2019 surveys are complete. Our next goal (and the subject of our next quarterly call scheduled for October 30th) will be to set out a timeline and plan for the 2020 surveys, which will include the annual Graduation Destination Survey and an Employer Salary Survey. In terms of membership, Kathleen Behan is also now on leave following the birth of her baby boy, and we would like to thank Margaret Seko for her many contributions to the Group.

## 4. National Recruitment Survey Working Group

**Update:** Over the summer months, our group had very positive and constructive discussions on the overall purpose of the survey and its goals. Ultimately, we worked through each survey question and assessed its value to NALP Canadian Section Report October 2019

the whole. We had active engagement and responses from both school-side and employer-side group members, which were again very positive and constructive.

The guiding philosophy is ultimately looking for ways to improve the overall efficiency for 1) students to take the survey 2) data to be collected 3) data to be analyzed and 4) data to be shared.

The Vice Chair had a call with Judy Collins, NALP-Survey contact, on Monday September 23 to discuss viability of incorporating some of our suggestions into the survey. Judy confirmed that hyperlinking to various recruitment processes and procedures would save a lot of time, as we would not have to reproduce the updated guidelines each year.

The Vice Chair has prepared the links and is making the updates to subsequent questions effected by this change. At which point, he will share for French translation.

Our goal is still to collect data 3 times per year:

Once in the Fall to collect data from the articling recruitment processes that occurred over this summer, which concluded with Toronto and Vancouver offers towards the end of August.

Once again in the later Fall/early Winter to collect data from the 2L summer recruitment processes that are occurring presently.

Once again in late Winter/early Spring to collect data from 1L and 2L summer recruitment processes that begin in January and typically conclude end of February-early March.

We are also going to send employer "report cards" once data is collected. These will be sent by school-side working group members directly to any employer specifically identified in the data. Data will be both positive and or critical. The goal is to get this data in front of employers so that they can read, directly from students, thoughts surrounding recruitment.
