Update

Our CDLE working group which is currently focused on the Demographic and Diversity Sections of the CDLE met in February to discuss the work of our two Sub-Groups (detailed below) who met in January to advance their work as follows:

- Demographic Categories Sub-Group This group reviewed the demographic categories used by the Canadian law schools and law societies to try to create a proposed list of categories for the CDLE. We discussed their recommendations and some of the issues that arose from their work. The next step is to review that recommendation and compare it to the work undertaken by various firms to create the self-identification categories that are being recommended for the viPortal for candidate applications. We will be discussing the results of that review at our meeting in early March with a view to being in a position to bring forward a recommendation for discussion with various stakeholders at our meeting at the Annual Conference.

- Surveys:
 - o We have drafted our survey for employers and intend to distribute widely in April
 - We are also preparing a survey for law schools and will distribute it to schools in April
 - We have also added two questions to the NALP Student Recruitment survey to capture the student perspective that survey should also go out soon
- Consultant Engagement:
 - We have met with two different consultants, who provided the group with an overview of their processes as it relates to our work
 - The group has met and decided which consultant to retain, we will proceed with that and also solicit the consultant's feedback on the survey questions
- Membership:
 - We are in the process of sorting out whether a MAG representative can join us they indicate that they are looking into a NALP membership

Next Steps:

- Once the survey results are in, we will analyze the data to identify commonalities and pain points. We will then work with the selected consultant(s) to determine the best way to approach next steps and engage stakeholders with a goal of reaching consensus for a way forward
- The canvassing of other jurisdiction practices and other industry practices will commence soon to see if there are any alternate models in whole or part that could be adopted
- We initially targeted the annual spring meeting of the NALP Canadian section as a time where we could dive into these issues more deeply and/or bring in the consultant to facilitate a discussion of our findings/ possible recommendations we may have to delay this, depending on how long surveys/consultant work takes
 - Once we have survey results, the WG will review the results and work with the consultants on a design thinking model to identify areas for improvement and recommendations
- Our target is to have recommendations ready for the LSO's consideration for implementation in 2023, for the summer 2024 recruit.
