

Supplementary Provisions

Handling of the Personal Information of Users Residing in the State of California

In addition to the provisions set forth above, the following provisions apply to the handling of the Personal Information (information that identifies, relates to, describes, references, and is capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or device. The same shall apply hereinafter in this Supplementary Provisions.) of Users residing in the State of California in accordance with the provisions of the California Consumer Privacy Act of 2018 and California Privacy Rights Act of 2020 (Collectively, "CPRA").

1. In relation to the collection and use of Personal Information, User may exercise the following rights to Nikkei in accordance with the provisions of CPRA.

(1) Right to Access Specific Information

A User has the right to request that Nikkei disclose to User information about Nikkei's collection, selling, sharing, disclosure or use of User's Personal Information during the past twelve (12) months from the time of User's request. Upon receiving and confirming User's verified consumer request, Nikkei will disclose the following information to User:

- The categories of User's Personal Information that Nikkei has collected;
- The categories of the sources of Personal Information that Nikkei has collected;
- Nikkei's business or commercial purpose(s) for collecting, selling or sharing such Personal Information;
- The categories of third parties with which Nikkei discloses, sells or shares such Personal Information;
- The categories of Personal Information disclosed, sold or shared to each third party; and
- The specific pieces of Personal Information of User that Nikkei has collected.

(2) Right to Request Deletion

A User has the right to request that Nikkei delete any Personal Information that

Nikkei has collected from User and retained, subject to certain exceptions. Upon receiving and confirming User's verified consumer request, Nikkei will delete (and notify third parties, including service providers, to whom Nikkei has disclosed Personal Information to delete) User's Personal Information from our records, unless an exception applies.

Nikkei may deny User's deletion request if retaining the information is necessary for Nikkei or its service providers or its contractor to:

- Complete the transaction for which Nikkei collected the Personal Information, fulfill the terms of a warranty or product recall made pursuant to federal law, or provide a service or good that User requested, take actions reasonably anticipated within the context of our ongoing business relationship with User, or otherwise perform our contract with User;
- Help ensure the security and integrity of consumers' Personal Information to the extent that its use is reasonably necessary and proportionate to its purpose;
- Debug products to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the rights of other users to exercise their free speech rights, or exercise other rights provided by law;
- Comply with the California Electronic Communications Privacy Act (Cal. Penal Code § 1546 et. seq.);
- Engage in public or peer-reviewed scientific, historical, or statistical research that conforms or adheres to all other applicable ethics and privacy laws, where the deletion of the information is likely to render the research impossible or to seriously impair the research, if User previously provided informed consent thereto;
- Perform internal and lawful uses reasonably aligned with consumer expectations based on User's relationship with us and that are compatible with the context in the which User provided such information; or
- Comply with legal obligations.

(3) Right to Request Correction

If Nikkei holds inaccurate Personal Information about User, a User has the right to

correct such inaccurate Personal Information, taking into account the nature of the Personal Information and the purposes for which the Personal Information is processed. Upon receiving and confirming User's verified consumer request, Nikkei will use commercially reasonable efforts to correct the inaccurate Personal Information indicated by you in accordance with the laws and regulations.

(4) Opt-Out Rights

A User has the right to request that Nikkei no longer sells or shares User's Personal Information. To exercise that right, please click the following link: [here \(Do Not Sell or Share My Personal Information\)](#) or [here](#).

Nikkei does not knowingly sell Personal Information about a User under the age of 16 unless a User has affirmatively authorized the sale or share of its Personal Information.

(5) Right to Limit Use of Sensitive Personal Information

Nikkei will not use or disclose any sensitive personal information collected from a User for any purposes other than those listed below:

- Performing the services reasonably expected by an average consumer who requests such services;
- Helping to ensure security and integrity;
- Conducting short-term temporary use (except those involving profiling or changes in future consumer experience);
- Providing services on our behalf; or
- Maintaining or improving the quality and safety of Nikkei's services and devices.

(6) Non-Discrimination

Nikkei will not discriminate against Users due to their exercise of any of their rights under the CPRA. Moreover, unless permitted by the CPRA, Nikkei will not:

- Deny Users services or goods;
- Charge Users different prices or rates for services or goods, including by

- granting discounts or imposing penalties;
- Suggest that Users may receive a different price or rate for services or goods; or
- Provide Users with a different level or quality of services or goods.

(7) Exercising Access, Deletion or Correction Rights

Only a User, a natural person or a person registered with the California Secretary of State that the User authorizes to act on its behalf, or a person who has power of attorney or is acting as a conservator for the User, may make a verified consumer request related to such User's Personal Information. A User may also make a verified consumer request on behalf of such User's minor child.

The verified consumer request must:

- Provide information that sufficiently allows Nikkei to reasonably verify that Nikkei has collected such User's Personal Information or an authorized representative of such User; and
- Describe User's request in sufficient detail to allow Nikkei to properly understand, evaluate, and respond thereto.

2. Collection of Personal Information

The categories of the Personal Information of Users collected by Nikkei in the past twelve (12) months and the sources thereof are as follows:

[Nikkei ID Member Attribute Information]

- o Category: Name, date of birth, sex, occupation, country of residence, post code, business category, job category, job title, number of employees at workplace, address, telephone number, email address, workplace, etc.

- o Source of Collection: Entered by User at the time of registration and changes to User's Nikkei ID.

[Access Data]

- o Category: Data regarding access to the website on which services are provided
- o Source of Collection: Acquired through use of cookies, etc., from the website on which services are provided

Nikkei collects User's Nikkei ID (email address) and password, which fall under the category of sensitive personal information as defined by CPRA.

3. Purpose of Use of Personal Information

The Personal Information set forth in the preceding paragraph will be used by Nikkei for the following purposes:

[Nikkei ID Member Attribute Information]

The purposes set forth in Article 2 of the Privacy Policy.

[Access Data]

The purposes specified in "[Cookie Policy](#)."

4. Retention Period of Personal Information

Nikkei will retain User's Personal Information to the extent necessary for the purposes set forth in the preceding paragraph.

Nikkei's criteria for determining the retention period include, without limitation: (i) the duration the User receives services from Nikkei; and (ii) the existence of legal obligations to which Nikkei is subject.

5. Sale, Share or Disclosure to Third Parties

[Nikkei ID Member Attribute Information]

Nikkei has sold and shares User's Personal Information including its Nikkei ID Member Attribute Information to advertisement distributors, etc. in the past twelve

(12) months.

[Access Data]

Nikkei has sold and shares User's Personal Information including its Access Data to advertisement distributors, etc. in the past twelve (12) months.

6. Use of Data for Advertising Purposes (Behavioral Targeting Advertising) and Opt-out of Cookies
