Approval of application and judges panel will be sent separately to the Event Secretary.

If any non-regular classes are offered, a description and entry requirements must be provided in the Premium List.

A copy of the Premium List must be sent to AKC at the time it is sent to prospective entrants.

\*LATE APPLICATIONS are subject to a minimum \$50 PENALTY
