Fees	Delivery Charge Optional delivery charge of \$8 per loaded mile is allowed for the delivering dealer. Use Google Maps to calculate the mileage.

Financing	John Deere Municipal Lease by John Deere Financial Allowed: If the agency rules and guidelines allow. This 12-60-month financial product requir payments and enables ownership of the equipment.

Open Market by Dealer (not listed in the price book)	Allowed: Open-Market items not available from John Deere but offered by the delivering Dealer to complete the purchase of John Deere equipment awarded on contract. Items must be clearly labeled on the purchase order as Open Market.	
Payment and Remittance	Credit card payments not allowed. Remit to Address: Deere & Company Ag & Turf CBD & Government Sales 21748 Network Place Chicago, IL 60673-1217	



Substitutions	Government Sales must contact the state for approval.
Trade-In	Allowed: Items must be clearly labeled on the purchase order or quote as Trade-In. The agency and the dealer determine the trade-in value.
