The following is a list of Premiers of British Columbia, 1871 to the present.

An individual Premier is assigned an order number for each time that he or she holds office without a break between terms. Thus, George Anthony Walkem is listed as both the third and the fifth Premier.

The British Columbia Gazette is the primary source for name spellings. In recent years, the trend has been for people in general to not provide a formal full name to official publications; thus, in many cases, a premier's middle name is not included on this list.

Walkem: Name: "Boomer" is occasionally added to Walkem's given names. However, it does not appear on his death certificate (BC Archives Microfilm Number B13081). The *Dictionary of Canadian Biography vol. XIII* (pg 1066) states that Walkem's will did not include the name Boomer, and the author speculates that "Boomer" may have been a nickname used by Walkem's political opponents. The spelling for this list comes from the Gazette: "Appointments – Dec 28, 1872," *British Columbia Gazette 1872*, p. 1. Party: Confirmed in *Electoral History of British Columbia 1871-1986*, Victoria: Elections British Columbia, 1988, p. 545-547. Start Date: It is unclear exactly when Walkem became premier. A Feb. 12, 1874, *Colonist* article noted it was "rumoured" the previous day that Walkem had been called to form a government and "the crisis was debated" by the Executive Council, but it is not clear what resulted. Thus, a later date – Feb. 13, 1874 – was selected for this list because that was the date that Walkem told the Assembly that he had formed a new government based on the same cabinet appointments as under DeCosmos.
