

ORDINANCE NO. 07-2024

AN ORDINANCE OF THE CITY OF DELTONA, FLORIDA, AMENDING SECTIONS 22-186 to 22-191, OF ARTICLE VI, “STREET VENDORS”, OF CHAPTER 22 “BUSINESSES”, OF THE LAND DEVELOPMENT CODE OF THE CITY OF DELTONA; PROVIDING FOR CONFLICTS, CODIFICATION, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, the City of Deltona, Florida, adopted Article VI, Street Vendors, and Chapter 22, Businesses, and

WHEREAS, the City of Deltona, has included Chapter 22, Businesses, within the Land Development Code; and

WHEREAS, Sections 22-186 to 22-191, of Article VI, “Street Vendors”, of Chapter 22, “Businesses”, of the Land Development Code shall be amended; and

WHEREAS, the Planning and Zoning Board held a public hearing on August 21, 2024, and forwarded its recommendations to the City Commission.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA, as follows:

Section 1: Sections 22-186 to 22-191, of Article IV, Street Vendors, of Chapter 22, “Businesses”, of the Land Development Code, is hereby amended as follows:

Section 2. Conflicts. Any and all Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 3. Severability. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect

any other provision or application of this Ordinance which can be given effect without the invalid provision or application.

Section 4. Codification. The provisions of this Ordinance shall be codified as and be made a part of the Code of Ordinances of the City of Deltona. The Sections of this Ordinance may be renumbered to accomplish such intention.

Section 5. Effective Date. This Ordinance shall take effect immediately upon its final adoption by the City Commission.
