- the Boat Registration Certificate;
- the pink HIN Certificate photocopies will not be accepted (unless a certified HIN number appears in the boat details section on the Boat Registration Certificate);
- your proof of identity documents. Proof of identity must be produced to the Department, Licensing Officer or Agent before this boat transfer can be accepted;
- pay the prescribed transfer fee (for current fee please see www.transport.wa.gov.au/imarine/marine-fees-and-payments.asp#). Failure to comply may incur an infringement; and
- submit these documents and payment to the Department within fifteen (15) days of the date of purchase.

## If submitted by mail:

- Applicants intending to complete the transfer by mail must provide their WA Driver Licence Number in the required field under the purchaser details section. If the purchaser is not a permanent resident of WA or does not have a WA drivers licence they must provide a certified copy of their passport or current interstate drivers licence.
