## AARP's \$10K Shopping Spree Sweepstakes Official Rules

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: AARP's \$10K Shopping Spree Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia, who are at least eighteen (18) years old at the time of entry. Employees of AARP, Merkle Inc., and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. - **4. How to Enter:** During the Promotion Period, visit <u>aarp.org/10kshoppingspree</u> and following the links and instructions to log into your current AARP.org account. If you are not already registered, you need to register through the online form to create a new AARP.org account. You will receive one (1) Sweepstakes entry.

<u>Limit</u>: You may enter one (1) time during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than one (1) entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and may result in disqualification. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for this Sweepstakes. If any additional information provided by entrant is inconsistent with the information provided at registration for this Sweepstakes, Sponsor and/or Administrator may disqualify such entrant and such disqualification may result in the forfeiture of any prizes won. **5. Grand Prize Drawing:** Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winner are final and binding. The potential Grand Prize winner will be notified by email (@helloworldfulfillment.com) with prize claim instructions, if any, including the requirement to complete and return Declaration of Compliance, Liability Waiver and where not prohibited a Publicity Release ("Declaration") (this includes an IRS W-9 form, for his/her/their Grand Prize), which must be received by Administrator within five (5) days of the date notice or attempted notice is sent, in order to claim the prize. If a winner is a minor in his/her jurisdiction, a parent or legal guardian must complete the Declaration. In addition, if any provision contained in these Official Rules shall for any reason be held to be excessively broad as to duration, geographical scope, activity or subject, it shall be construed by limiting and reducing it, so as to be enforceable to the extent compatible with applicable law.
