### Driving Directions:

#### Northbound/Southbound I-5

- Take the City Center Exit #133. Follow City Center signs towards downtown Tacoma.
- Stay left to follow signs that read South 15th & Pacific Avenue.
- Continue through the traffic light up one block to Commerce and turn right.
- Continue on Commerce through the light at 13th.
- Pacific Plaza is on the corner on the right at 13th & Pacific.
- The entrance to the parking garage is on the right.
- Our office is on floors 1 and 8. Parking is on floors 2 through 6.

**Parking** is up to \$16.00 per day and can be paid by cash or credit card.
