STIPULATION

The parties to this stipulation, Plaintiff, STATE OF WASHINGTON (STATE), and the Defendant, JEFF MORRIS, individually and as the candidate authorizing the MORRISCAMPAIGN.COM political committee, desiring to resolve all claims arising out of the State's complaint, hereby enter into the following stipulation:

1. Defendant JEFF MORRIS agrees to pay the State within 30 days of the date of entry of this Judgment an assessed civil penalty in the amount of \$170.00 for his violations of RCW 42.17A for failing to timely disclose contributions received by his 2016 campaign for election to the House of Representatives for a seat in the 40th Legislative District.
2. Defendant JEFF MORRIS agrees to pay, in a separate transmittal, the State the total amount of \$560.00 as attorney fees, \$240 in court costs, and \$160.00 in investigation costs in this action, this amount to be paid within 30 days of the date of entry of the Judgment.

The Plaintiff, STATE OF WASHINGTON (STATE), appearing through its attorneys of record, through the OFFICE OF THE ATTORNEY GENERAL and LINDA A. DALTON, Senior Assistant Attorney General, and Defendant, JEFF MORRIS, individually and as the candidate authorizing the MORRISCAMPAIGN.COM political committee, appearing *pro se*, apprised the Court of their agreement to the entry of this judgment for the purpose of settling and compromising this action brought under RCW 42.17A. The Court, having reviewed the records and files herein, and having found the settlement to be a just and proper resolution of this matter, and being otherwise fully advised in the premises, hereby ORDERS as follows:

1. Defendant, JEFF MORRIS is hereby assessed a civil penalty, under the provisions of RCW 42.17A, in the amount of \$170.00 payable to the State of Washington.
2. Defendant JEFF MORRIS shall pay to the State of Washington the assessed civil penalty (\$170.00) within 30 days of the entry of this Judgment.
3. Defendant JEFF MORRIS shall pay to the State of Washington by separate transmittal, the amount of \$560.00 as attorney fees, \$240.00 in court costs, and \$160.00 in costs of


