The Public Counsel Unit of the Washington Attorney General's Office represents the interests of residential and small business customers of state regulated electric, natural gas, water, and telecommunications companies and customers of transportation companies regulated by the Washington Utilities and Transportation Commission. Public Counsel advocates on behalf of customers before the Commission and courts regarding rates, mergers, business practices, service quality, energy efficiency, safety, and policy matters.

Puget Sound Energy's General Rate Case (GRC) Filing

Puget Sound Energy (PSE) filed a request with the Washington Utilities and Transportation Commission (UTC) to increase its electric and natural gas rates in 2025 and 2026. For electricity rates, PSE is requesting a total revenue increase of \$192.2 million in 2025 and \$259.9 million in 2026. For natural gas rates, PSE is requesting a total revenue increase of \$196 million in 2025 and \$25.4 million in 2026.

For electricity customers, PSE's request is a 6.74 percent increase in electric revenues in 2025 and an 8.48 percent increase in 2026. For natural gas customers, PSE's request is an 18.96 percent increase in revenues in 2025 and a 2.07 percent increase in 2026.

PSE argues that the increases are necessary because of major capital investments needed to provide safe and reliable service, meet mandatory obligations, and replace aging or damaged infrastructure. PSE justifies its requested increases based on inflation, increased interest rates, and increased energy costs. PSE also proposes to increase the returns paid to investors from 9.4 percent to 9.95 percent in 2025 and 10.50 percent in 2026. These returns are paid by PSE's customers.

PSE's electric proposal would increase the average residential electric user's bill by \$7.84 per month in 2025 and another \$11.20 per month in 2026.

PSE's natural gas proposal would increase the average residential natural gas customer's bill by \$13.96 per month in 2025 and another \$1.51 per month in 2026.

Has Public Counsel taken a position?

Yes. Public Counsel has provided testimony and analysis arguing that PSE's requested increases are too high. Public Counsel has opposed any increases to rates that are not supported by the evidence. Public Counsel is also opposing higher basic charges and the Company's attempt to shift risks to ratepayers for certain costs such

as construction overruns and wildfires. Lastly, Public Counsel opposes PSE's request for higher shareholder profits.

Process for Commission Decision

By law, the UTC has up to 11 months to review the filing and issue a decision. New rates from this case will go into effect no later than January 16, 2025. The UTC will hold an evidentiary hearing on November 4-5, 2024, and will issue its decision in time for the new rates to go into effect.
