

Notice of Cy Pres Funding Opportunity and Invitation to Apply

Greetings:

The Attorney General's Office (AGO) brought a lawsuit against Federal Way Discount Guns and its owner after they illegally sold high-capacity magazines to the public. The case, *State v. Federal Way Discount Guns, LLC, et al.*, King County Cause No. 22-2-20064-2-SEA, ultimately settled and the Court entered a Consent Decree that allows the Attorney General to distribute a portion of the settlement funds *cy pres* to local law enforcement agencies to assist in promoting firearms safety, combatting gun violence, and supporting victims of gun violence.

We are writing to solicit applications from local law enforcement and tribal law enforcement organizations interested in this funding opportunity. Interested agencies should complete and return the enclosed application form by October 31, 2024.

All applications the AGO receives by October 31, 2024 will be reviewed under a number of non-exclusive criteria, including the proposal's feasibility and sustainability; anticipated effectiveness in addressing gun violence, promoting firearms safety, or supporting victims of gun violence; and opportunity for measurable outcomes, among others. Proposals should include an anticipated date for final expenditure of funds that falls within 24 months of the award. After the close of the application period, the AGO will decide whether and how to fund any request, in whole or part, in its sole discretion. Although organizations are welcome to ask for an amount they deem necessary, the AGO will determine the final amounts of all awards.

Funding Requirements

This is a one-time funding opportunity. Any local government or tribal law enforcement organization may apply for funding to support a specific proposal to promote firearms safety, combat gun violence, or support victims of gun violence. Recipients will be solely responsible for ensuring that the expenditure of funds complies with all state and federal law, including antidiscrimination laws. The funds must be used in the manner described in the application and tracked separately from any other monies. Recipients will be required to keep a detailed accounting of their use along with supporting source documentation to enable the public to confirm that the expenditure and stewardship of the funds conforms to the purposes for which the funding was awarded.

Recipients will be required to report on their use of the funds by December 31, 2026, or three months after the funds are fully expended, whichever comes first. At the end of the 24-month funding period, recipients will return any funds that remain unspent, regardless of the status of the project.

Any local law enforcement agency or police department of any Washington political subdivision as defined in RCW 10.108.020(2), including city police departments and county sheriff offices, may apply. Tribal law enforcement organizations are also invited to apply.
