Snapchat is built to help people share their full range of human emotions and bring them closer to those who matter most, even when they're far away. When designing Snapchat, we embraced what is now referred to as safety-by-design (i.e., minimizing features believed to cause uneasiness, like social-comparison metrics, and unmoderated news feeds)
