

APIQ[✓]® Audit Fees effective 1 July 2024

APIQ[✓]® Compliance Audit Fees & Charges¹

Different fee structures apply to single-site organisations and joint organisations as per below. For both organisational types, additional charges are payable as per Section 3 below:

1. Single Site Organisations

1.1. A base rate by number of sows and or growers/ finishers (Table 1) is applied to the Audit of a single site organisation/ piggery.

1.2. The following scenarios provide further guidance:

- (1) Scenario 1: The site is a breeder or breeder to weaner with sows and suckers/weaners only – The pricing is based on the number of sows.
- (2) Scenario 2: The site is a grower only i.e. gilts, weaners, growers and finishers – The pricing is based on the grower number.
- (3) Scenario 3: The site is a farrow to finish i.e. has sow’s, gilts, suckers, weaners, growers and finishers – The pricing is based on what is the higher number growers or sows.

1.3. The base rate covers four (4) hours including time taken to draft and provide the Compliance Audit Report, including the close out of CARs provided such closure occurs within the timeframes agreed between the Producer and the Auditor; and in accordance with the APIQ[✓]® Administrative Policies and APIQ[✓]® Certification Policies – otherwise additional fees will be payable as per Section 3.2 below.

- 1.4. Where the Audit (on-site and offsite reporting) takes more than four (4) hours² additional charges will be applied at the hourly rate specified in Table 2.

2. Joint Certifications

An hourly rate is applied to Audits conducted for Joint Certifications where a Joint Certification Application has been approved³ by APIQM at the rate specified in Table 3.

It is expected that:

- (1) Multiple Audits may be conducted in a single day for some organisations. In such cases, this will occur in line with biosecurity and the third-party auditing organisations' WHS provisions.
- (2) Up to 90 minutes may be charged for completion of the head office or overall system desk audit⁴ at the hourly rate.
- (3) Up to 30 minutes per site may be charged for off-site report writing at the hourly rate.
- (4) Time will be charged in increments of 15 minutes at the hourly rate, pro-rata.
- (5) The above charges include the time taken to draft and provide the Compliance Audit Report, including the close out of CARs, provided such CAR closure occurs within the timeframes agreed between the Producer and the Auditor; and in accordance with the APIQ[✓]® Administrative Policies and APIQ[✓]® Certification Policies – otherwise additional fees will be payable as per Section 3.2 below.

² An audit may take more than 4 hours for several reasons including but not limited to: where a producer's systems and or piggery are found to be disorganised and difficult to audit, where policies and procedures are not correctly in place, where non-compliances are found requiring the auditor to review more of the piggery than would otherwise be necessary.

³ CP 17 requires a Joint Certification Application to be completed and presented to APIQM upon initial application, or whenever a new site is to be added or removed, prior to site selection.

⁴ Additional time may be charged where an organisation's manuals and systems are not in place, are disorganised or are difficult to navigate requiring more time than would otherwise have been necessary.

3. Additional Charges

3.1. Travel

3.1.1. Associated travel and accommodation charges as set out in Table 4 will be applied to single and multi-site organisations and are additional to the charges in Sections 1 and 2.

3.2. Closing Corrective Action Requests (CARs) and follow up activities.

3.2.1. If the close out of CARs does not occur within the timeframes agreed between the Producer and the Auditor and in accordance with the APIQ[✓]® Administrative Policies and APIQ[✓]® Certification Policies the Company may charge Producers for additional time and costs incurred to close and verify CARs, at the hourly rates specified in Tables 2 or 3, whichever applies.

3.2.2. Where an additional visit/Audit is deemed necessary to verify CARs are closed or to address other issues identified during an Audit, additional fees and charges may apply at the hourly rate as specified in Tables 2 and 3, whichever applies.

3.3. Audit Scope

3.3.1. Where a site requires additional scopes (i.e. GSF, CSC, VEBS) additional time may be required to assess and report findings, which will be charged at the hourly rate as specified in Tables 2 and 3.

3.4. Other Charges

3.4.1. Fees and charges listed in 3.2 will be applied to random or ad hoc Audits when required by APIQM, the APIQ Panel and/or the APL Board Industry Integrity Committee to address a Critical CAR or for any other purpose they deem is in the best interest of industry to protect the integrity and credibility of the program.

3.4.2. As per APIQ Certification Policy 2 (CP2), Current APIQ[✓]® Certification requires all Audit Fees to be paid. Failure to pay Audit Fees will result in APIQ[✓]® Certification being refused, cancelled or suspended (CP9).

3.5. Cancellation Fees

3.5.1.A Cancellation Fee of \$832.00 (ex GST) plus relevant travel expenses will be charged if audits are cancelled without sufficient notice (48 hours) or reason.
