

Terms and Conditions for Standard Chartered Bank Kenya Limited (SCB), Switch your Salo, Bank Better Promotion, BCLB No. 002975

The following terms and conditions shall apply to "The **Switch your Salo. Bank Better Promotion** BCLB No. 002975

Promotion (the "promotion").

By participating in the 'Switch your Salo. Bank Better Promotion., you will be deemed to have read, understood, and accepted these terms and conditions.

The promotion is aimed at rewarding New to Bank salaried clients who channel their net salary to their Personal Bank Account at Standard Chartered.

Promotion period: 18 September to 18t December 2023.

1. Eligibility

1.1. You qualify to participate in the promotion based on the below criteria:

1.1.1. Salaried Clients

- a) If you are a new client to the Bank who is among the lucky 80 clients to open and channel their net salary (payroll) into their Personal Bank Account at Standard Chartered during the promotion period.
- b) Clients wishing to open payroll accounts will need to specify that the account is being opened for this purpose during the account opening process to qualify.
- c) Your first net salary deposit >KES 15,000 will be considered for purposes of meeting the promotion thresholds.
