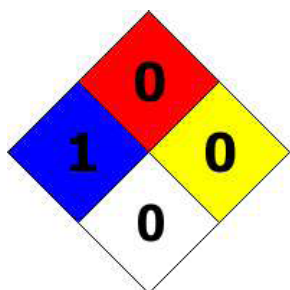

SECTION 4 : First aid measures

Description of first aid measures

Precautions for safe handling:
