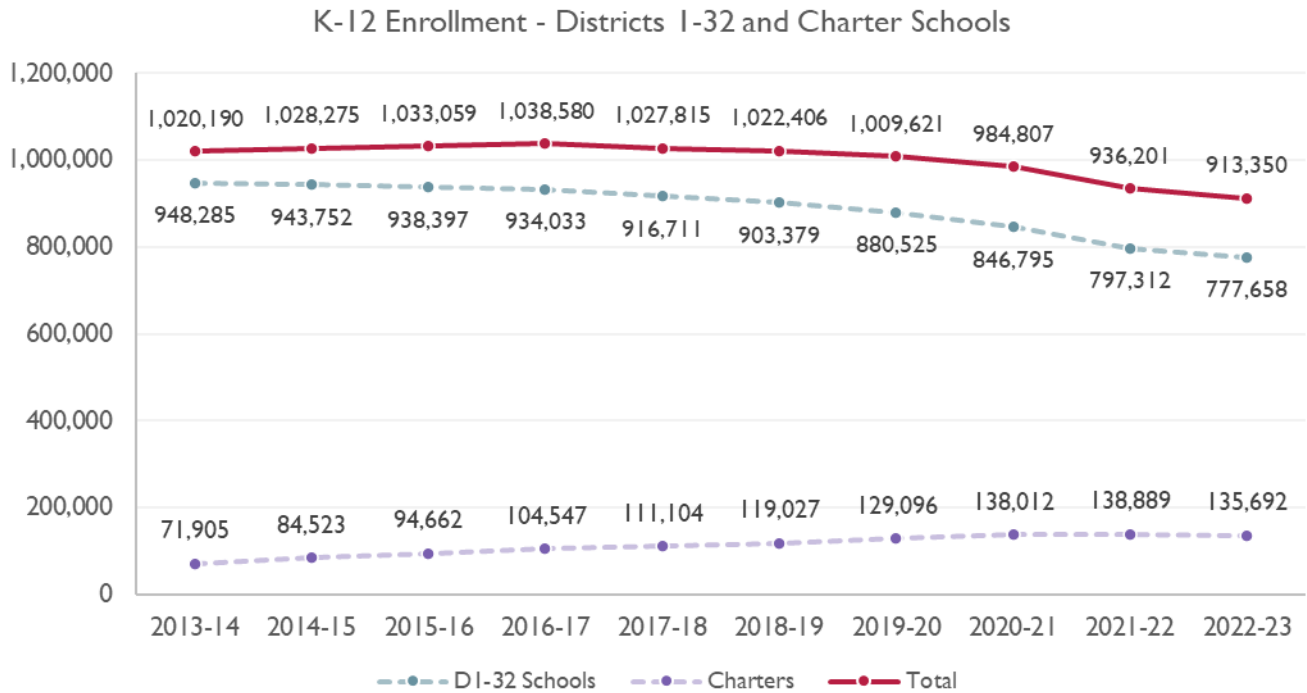

CITYWIDE TRENDS

CITYWIDE ENROLLMENT (DISTRICT AND CHARTER), 2013-14 TO 2022-23

New York City Public Schools (NYCPS) is committed to thoughtful collaboration with districts and communities to collectively strengthen schools, support students and families, and respond to demographic and population changes in New York City.

- K-12 enrollment in District 1-32 schools and charter schools has declined by about 12% since its peak in the 2016-2017 school year, exacerbated by population changes during the COVID-19 pandemic.

DISTRICT PLANNING PROCESS

- The Office of District Planning partners with communities, superintendents, and other stakeholders to identify solutions that address district needs, in accordance with Chancellor’s Regulations A-185 and A-190.
 - **Chancellor’s Regulation A-185** governs the process to re-zone or unzone schools in partnership with and voted on by Community Education Councils (CECs).
 - **Chancellor’s Regulation A-190** governs the process to make any major changes to school utilization such as co-locations, school mergers, grade expansions and truncations, re-sitings, and other changes. A-190 proposals are voted on by the Panel for Educational Policy (PEP).
- Guiding Questions:
 - How might recent changes affect the needs of the district as they are implemented? Do they address key needs and priorities?
 - What other school changes could be considered?

CHANGES IN DISTRICT – 2020-21 TO 2023-24

- There have been no A-190 proposals approved in District 11 since the 2020-2021 school year.
- The Office of District Planning will continue to partner with communities, superintendents, and other stakeholders to identify needs and develop scenarios and proposals to address these priorities.

DISTRICT ENROLLMENT

UNPACKING ENROLLMENT TRENDS

- Enrollment is a key data component in the District Planning Process. Enrollment data helps us identify trends, generate hypotheses, and understand where we need to dig deeper in partnership with our stakeholders.
- Guiding Questions:
 - What has happened to district enrollment over the last six years overall? By incoming grade (i.e. K and sixth)? Are there notable trends?
 - Are students remaining in the district to attend school? If not, where are they going?

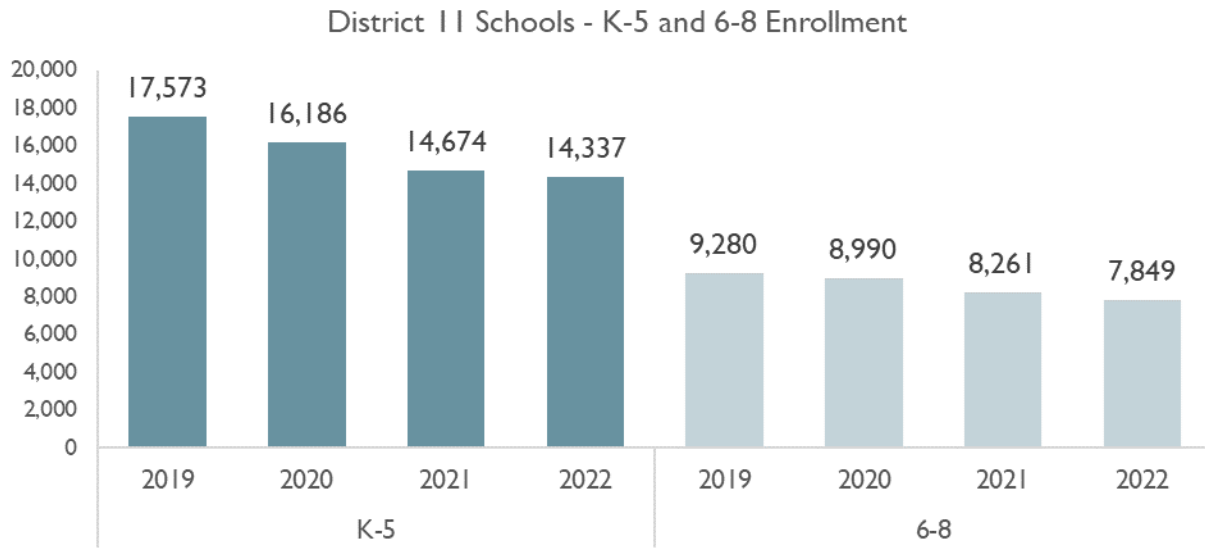

- Over the last five years, total enrollment in District 11 decreased by 19%.
- From the previous school year, total enrollment in District 11 decreased by 4%.
- The sharpest decline occurred at the elementary school level, where enrollment has decreased by 25% in the past five years.

DISTRICT SCHOOL ENROLLMENT

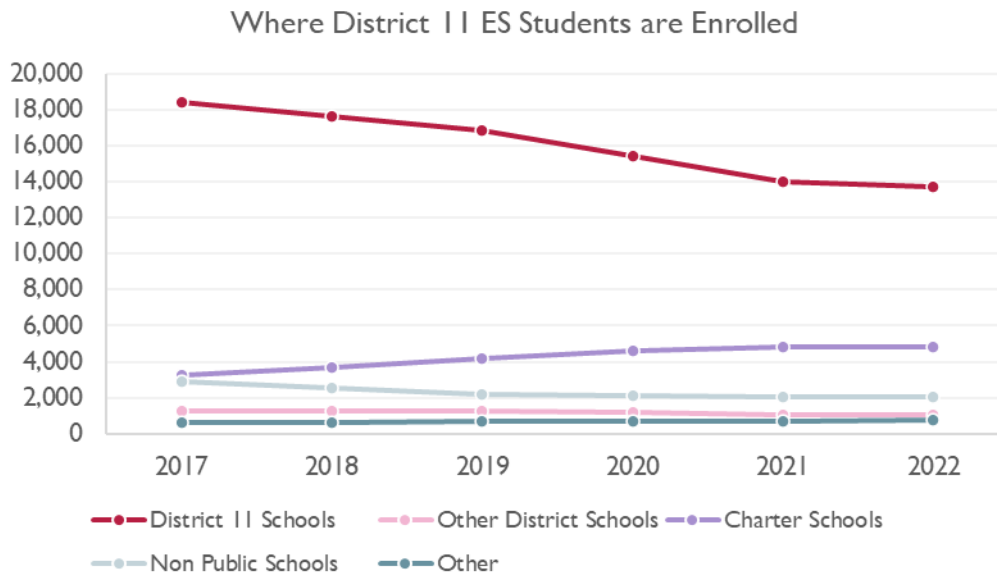

- Since the 2019-2020 school year, district elementary enrollment in District 11 declined by 19%.
- Since the 2019-2020 school year, district middle school enrollment in District 11 declined by 15%.
- Enrollment declined at a similar or faster rate across the Bronx.

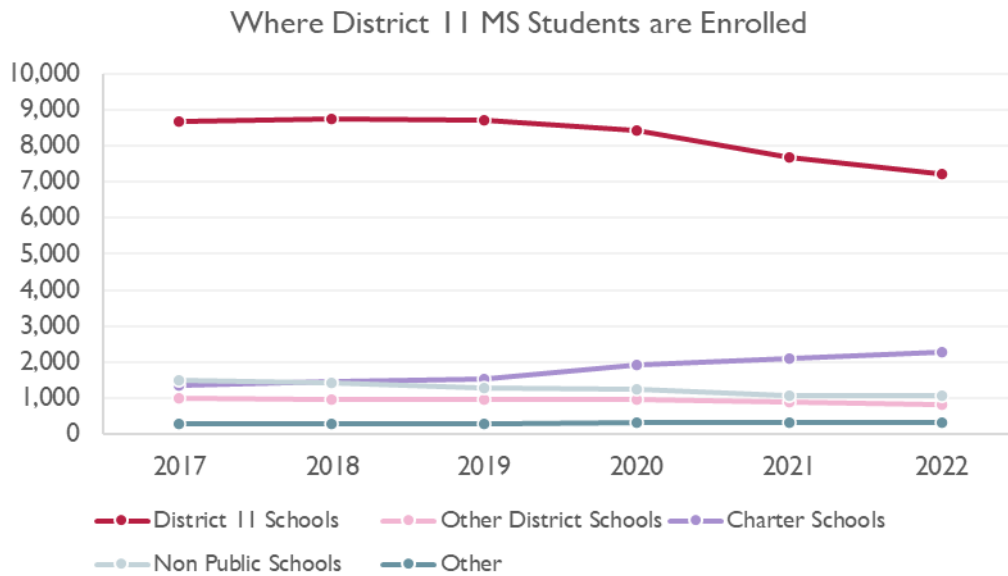

- Over the past five years, the number of elementary school-aged children in District 11 declined by 15%.
- Enrollment in District 11 elementary schools declined by 26%, and the share of elementary-aged children attending a District 11 school decreased by nine percentage points.
- Charter school enrollment increased by 49%, and the share of District 11 elementary school children attending charter schools increased by nine percentage points.
- The number of students enrolling in other district schools and charter schools declined along with the population.
- This trend is similar to neighboring districts.

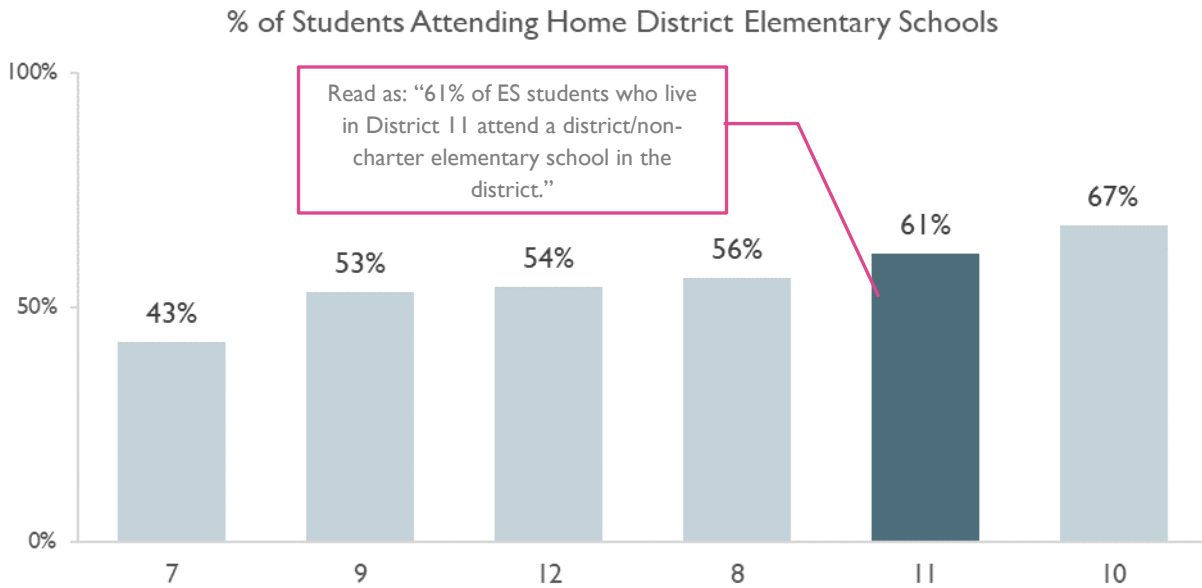

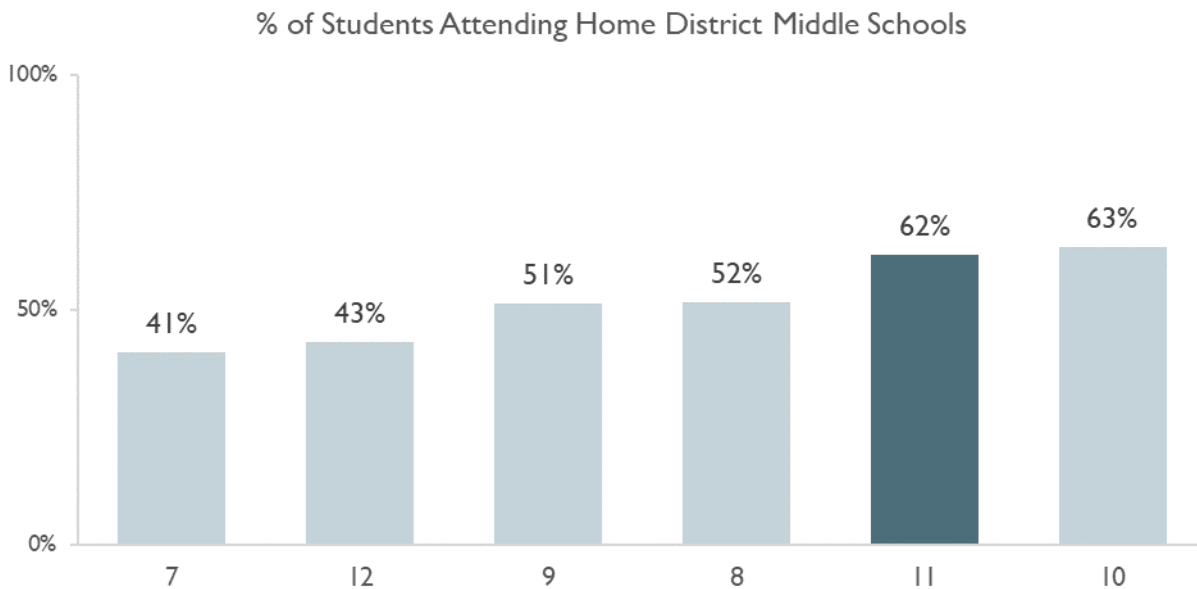
- Over the past five years, the number of middle school-aged children in District 11 declined by 8%.
- Enrollment in District 11 middle schools declined by 17%, and the share of middle school-aged children attending a District 11 school decreased by six percentage points.
- Charter school enrollment increased by 69%, and the share of District 11 elementary school children attending charter school increased by eight percentage points.
- The number of students enrolling in other district schools and charter schools declined slightly faster than the population, and the share of students choosing those options for middle school also decreased.
- This trend is similar to neighboring districts.

Elementary School Students



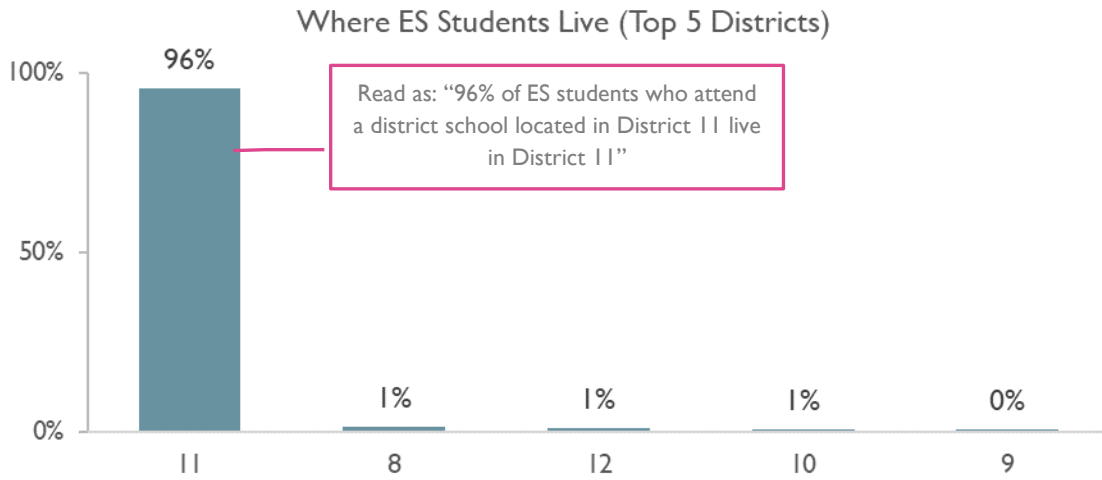

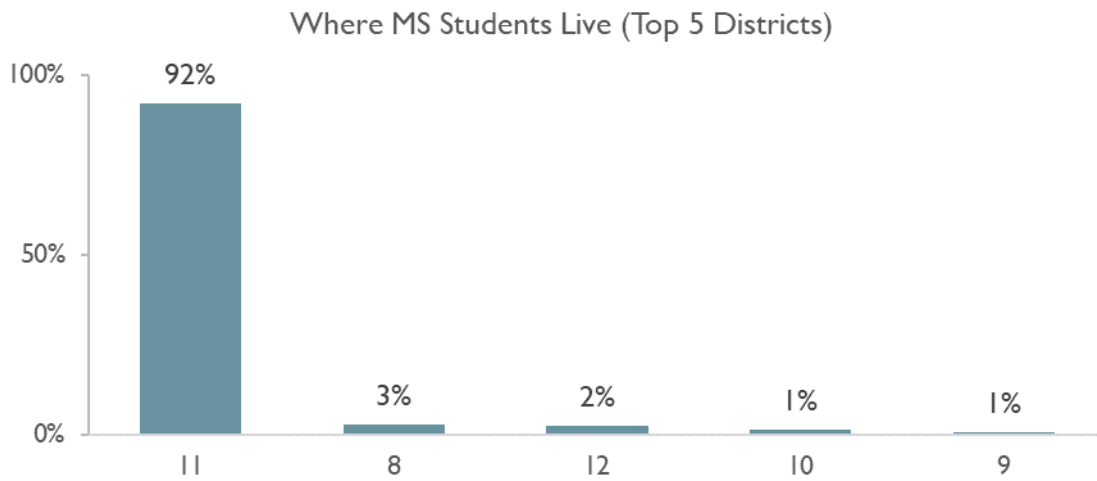

Middle School Students – District of Residence

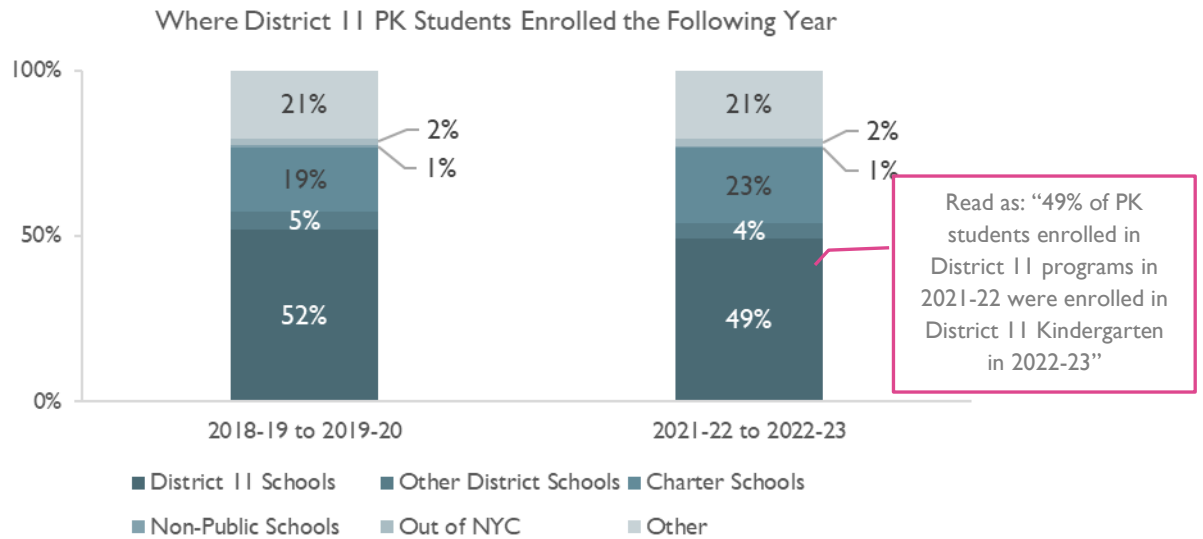

- Just over 60% of elementary and middle school students in District 11 attend a district/non-charter elementary school in the district. This is the second-highest rate of any district in the Bronx.
- Ninety-six percent of elementary and 92% middle school students attending District 11 schools live in District 11.

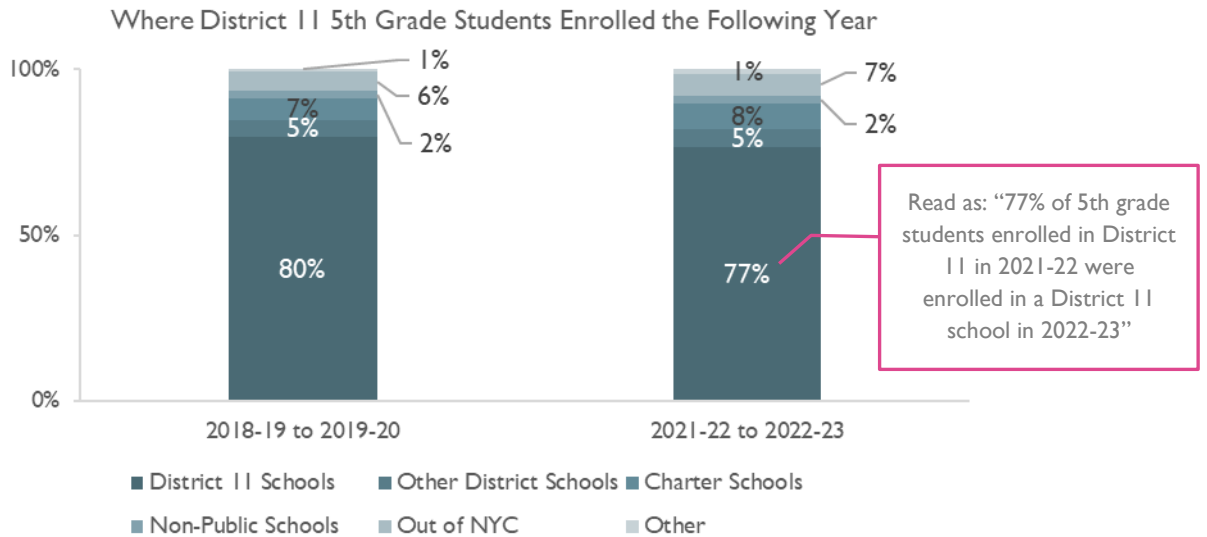

- The percentage of pre-K students leaving NYC or enrolling in non-district school options for 6th grade increased by four percentage points.
- The overall number of pre-K students in District 11 declined, and the number of pre-K students articulating to district schools declined faster than the discharge rate.
- This trend is observable across the Bronx. District 11 is notable for its comparatively high share of students discharged to a school other than district, charter, non-public, or outside of New York City.

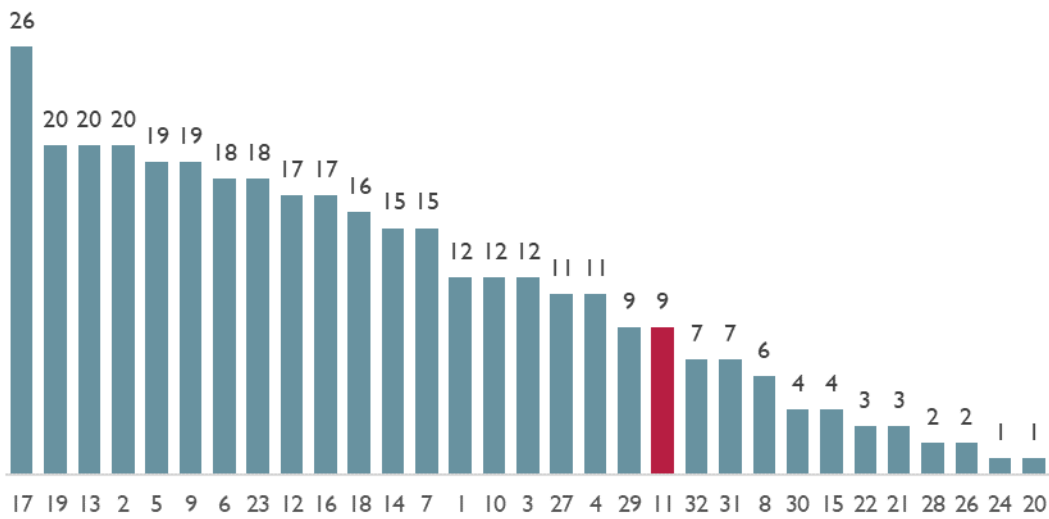
- The percentage of 5th grade students leaving NYC or enrolling in non-district school options for 6th grade increased by two percentage points.
- The overall number of 5th grade students in District 11 declined, and the number of 5th grade students articulating to district schools declined faster than the discharge rate.
- Discharges to non-public and charter schools and outside of NYC decreased very slightly.
- This trend is similar to the borough trend.

- Both CASA and Bronx Alliance Middle School lost nearly 40% of their enrollment in the past five years and have fewer than 50 true applicants for Fall 2023.
- CASA now serves fewer than 200 students.

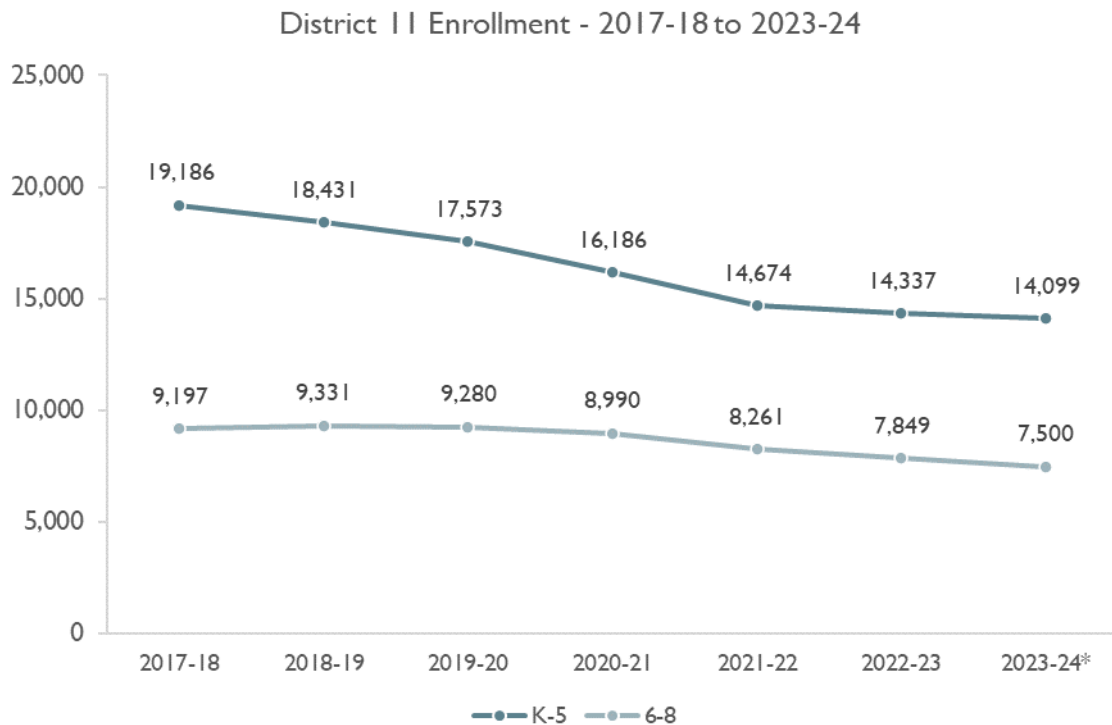

- The high-demand elementary and middle schools in District 11 represent a range of sizes and neighborhoods.
- P.S. 108 is located in X108, where an addition is anticipated to open in September 2024.
- The highest-demand middle school, 11X468, is co-located with two other middle schools in building X135.

SEAT DEMAND

- We consider the total number of students and the total number of seats to see if there is a net surplus or deficit of seats within a district.
- Some districts, and particular areas within a district, struggle with over-utilization, while others have excess capacity.
- Guiding Questions:
 - Are there certain parts of the district with significant excess space? Areas of crowding or over-utilization?
 - How does projected enrollment compare to capacity and how do we expect that to change over time?
 - Do projections align with current, on-the-ground experience?

- The additions anticipated to be completed in the coming years allow for the opportunity to alleviate over-utilization across District 11.
- District 11 is expected to continue to have excess K-5 seat capacity over the next year.
- Currently, there are roughly 1,500 excess seats at the elementary school level and 2,750 excess seats at middle school.

BUILDINGS & CAPACITY

SCHOOL & BUILDING UTILIZATION WITHIN THE DISTRICT

- The Office of District Planning works closely with the School Construction Authority (SCA) and the Office of Space Management to understand how buildings are currently used and how capacity can best be used in future years.
- Each year, the SCA publishes the Blue Book, a tool that analyzes the capacity of each NYCPS building across the City and compares the target capacity with the number of enrolled students to determine a utilization rate for the building.
- Guiding Questions:
 - Given the current and projected capacity trends presented in the preceding Demand and Capacity section, does the district have sufficient capacity to meet its needs and support its students?
 - Is over- or under-utilization concentrated at a particular grade level? In a particular area?
 - Are there under-utilized buildings with excess capacity to accommodate an additional school or program?

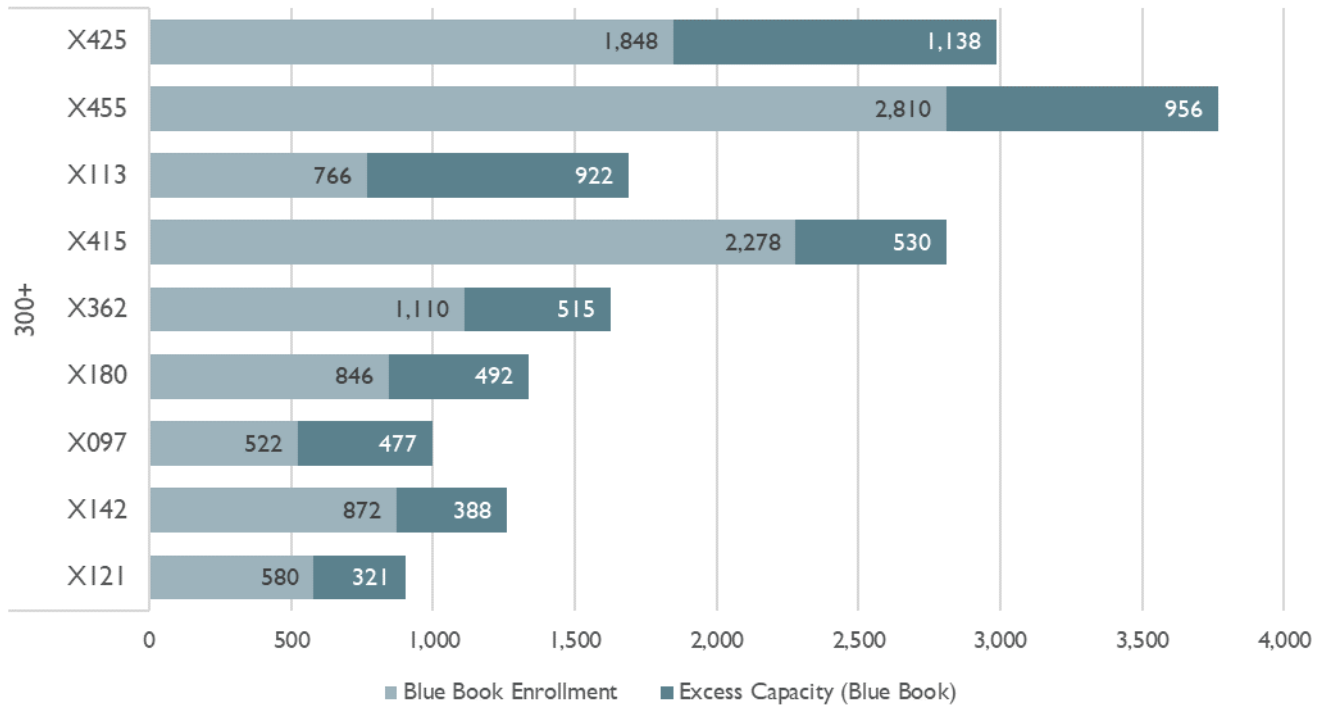

Under-utilized Buildings in District 11 with 300+ Excess Seats

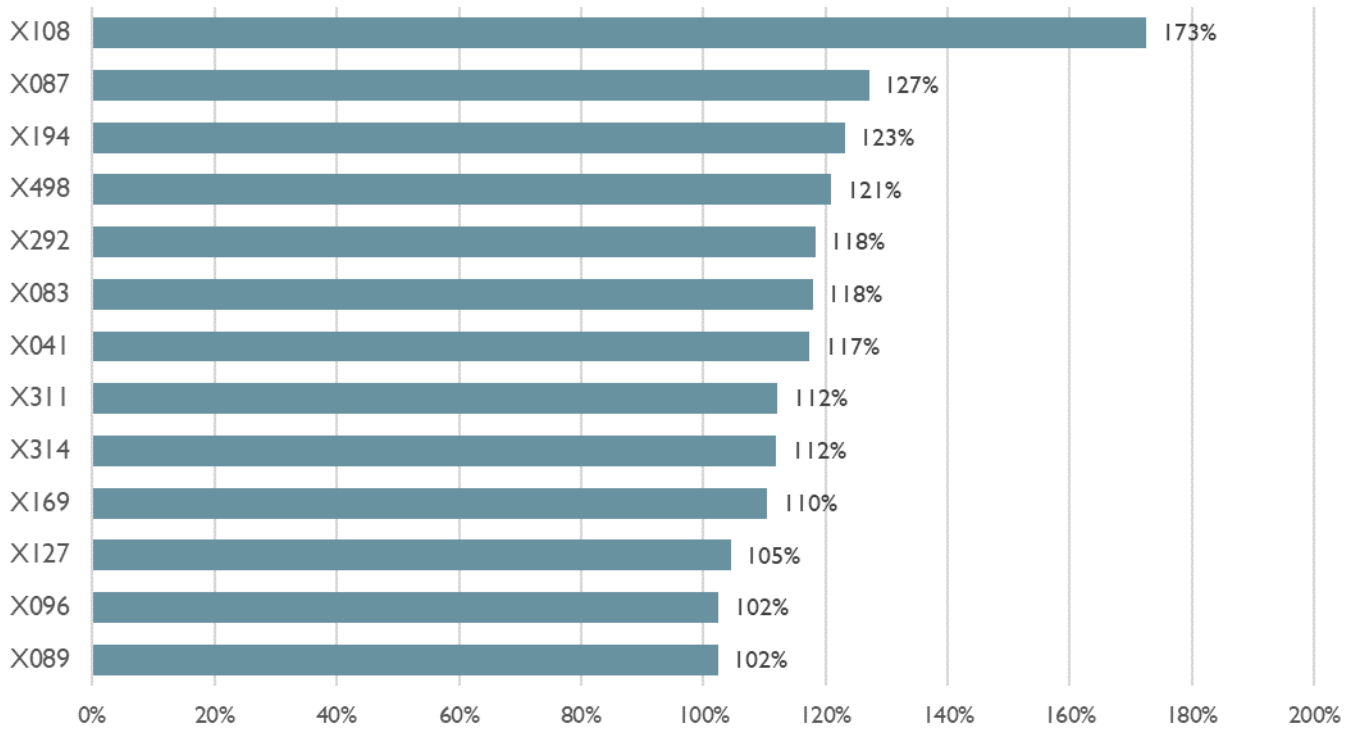

- Utilization rates do not always capture the full narrative of space in a building, but provide a starting point for assessing potential space availability. For example, some buildings, although under-utilized, may not have sufficient space to add another school.
- Other buildings with significant excess seats could be candidates to address pressing district needs, including housing another school or adding or expanding programs such as dual language offerings, District 75 programming, Autism Spectrum Disorder (ASD) programs, Gifted and Talented, and/or other district needs.
- Building X425 has over 1,100 excess seats, the most excess space of any school in the district.
- Building X113 has over 900 excess seats, the most of any school serving grades 6-8 in District 11.
- Building X097 opened a new addition in September 2021 and has the most excess seats of any elementary school building in District 11.

- The Office of District Planning seeks to work with superintendents, CECs, and partner offices to alleviate overcrowding through the leveraging of available capacity.
- Additions are expected to open at X108 and X087 in September 2024 to reduce overcrowding at those buildings as well.

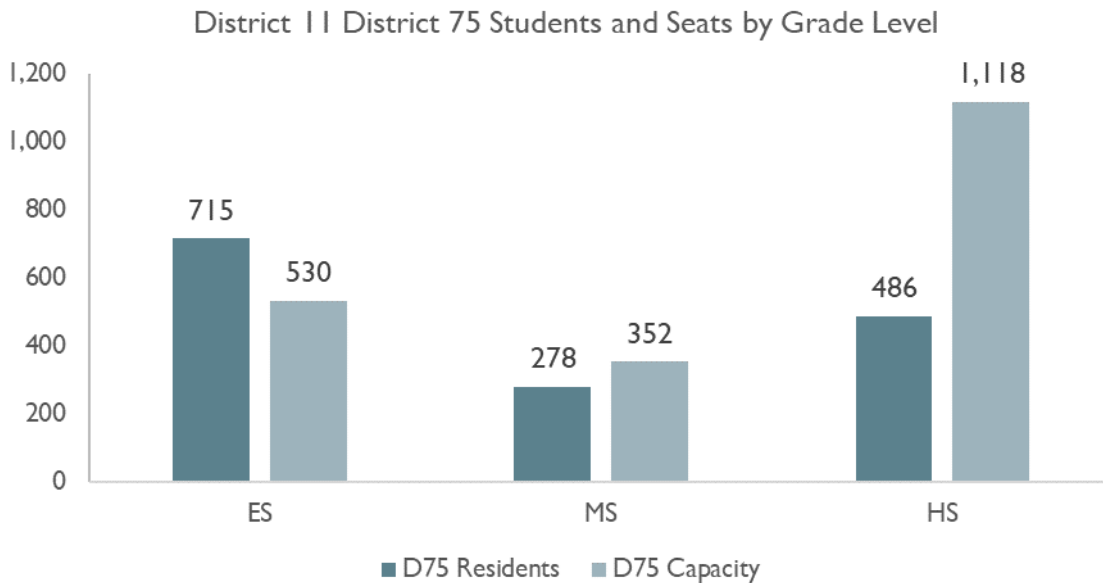

DISTRICT 75

- NYCPS’s District 75 provides highly specialized instructional support for students with significant challenges, such as ASD, significant cognitive delays, emotional disturbance, sensory impairment, and multiple disabilities.
- District 75 serves students through a number of different program models designed for students of different ages and education needs.
 - Most District 75 students attend Special Class programs, which operate as distinct schools and may be located in standalone sites or co-located with district schools
 - A smaller number of students attend Inclusion Programs, in which students receive District 75 services within general education classes at a district school partner.
- Guiding Questions:
 - Does the district have a need for more District 75 seats?
 - Are there potential options for new D75 sites to provide opportunities for students to attend programs closer to their homes?

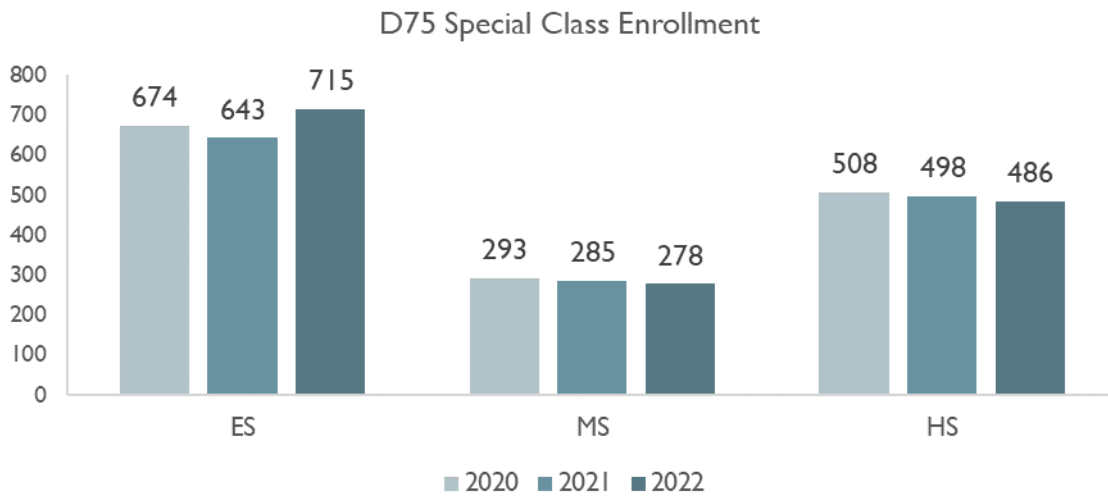

District 11 D75 Special Class Enrollment by Year



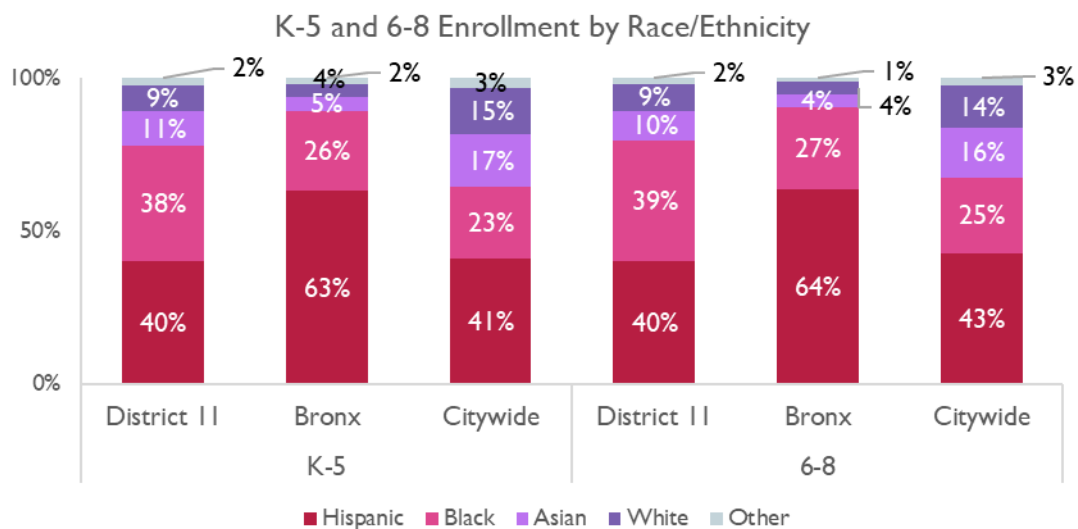
- There is a 185-seat deficit of District 75 elementary school seats in District 11.
- The number of students in District 11 who need a District 75 seat increased at elementary school but decreased at the middle and high school levels.
- The addition at X105 anticipated to open in September 2025 includes space designed for a District 75 elementary school.

RACE/ETHNICITY

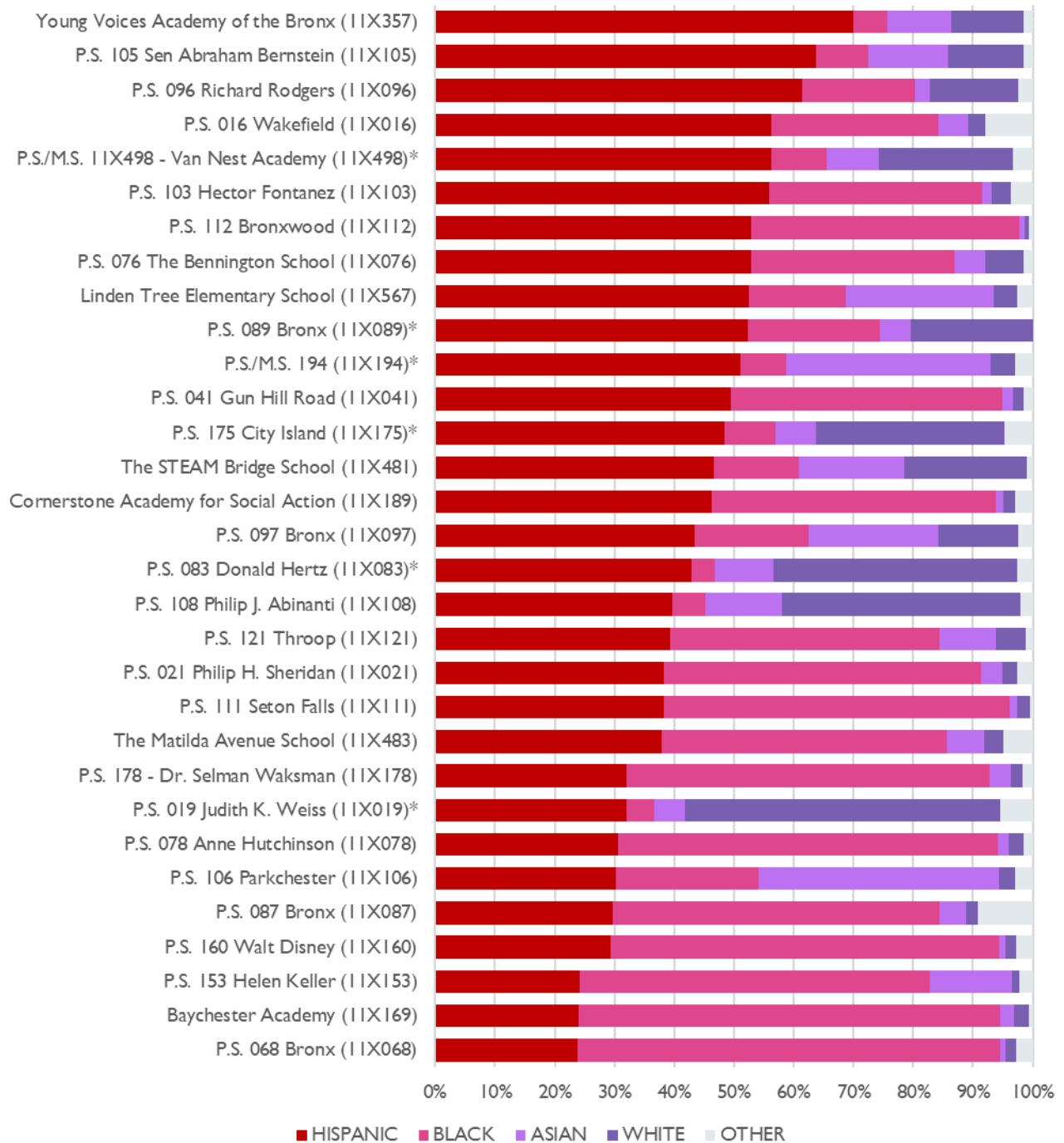

- District 11 serves a diverse student population, with significant populations of Black, Hispanic, Asian, and white students.
- District 11 elementary and middle schools serve a larger percentage of Black, white, and Asian students and a smaller percentage of Hispanic students than the Bronx average.
- District 11 elementary and middle schools serve a larger percentage of Hispanic and Black students and a smaller percentage of White and Asian students than the City average.

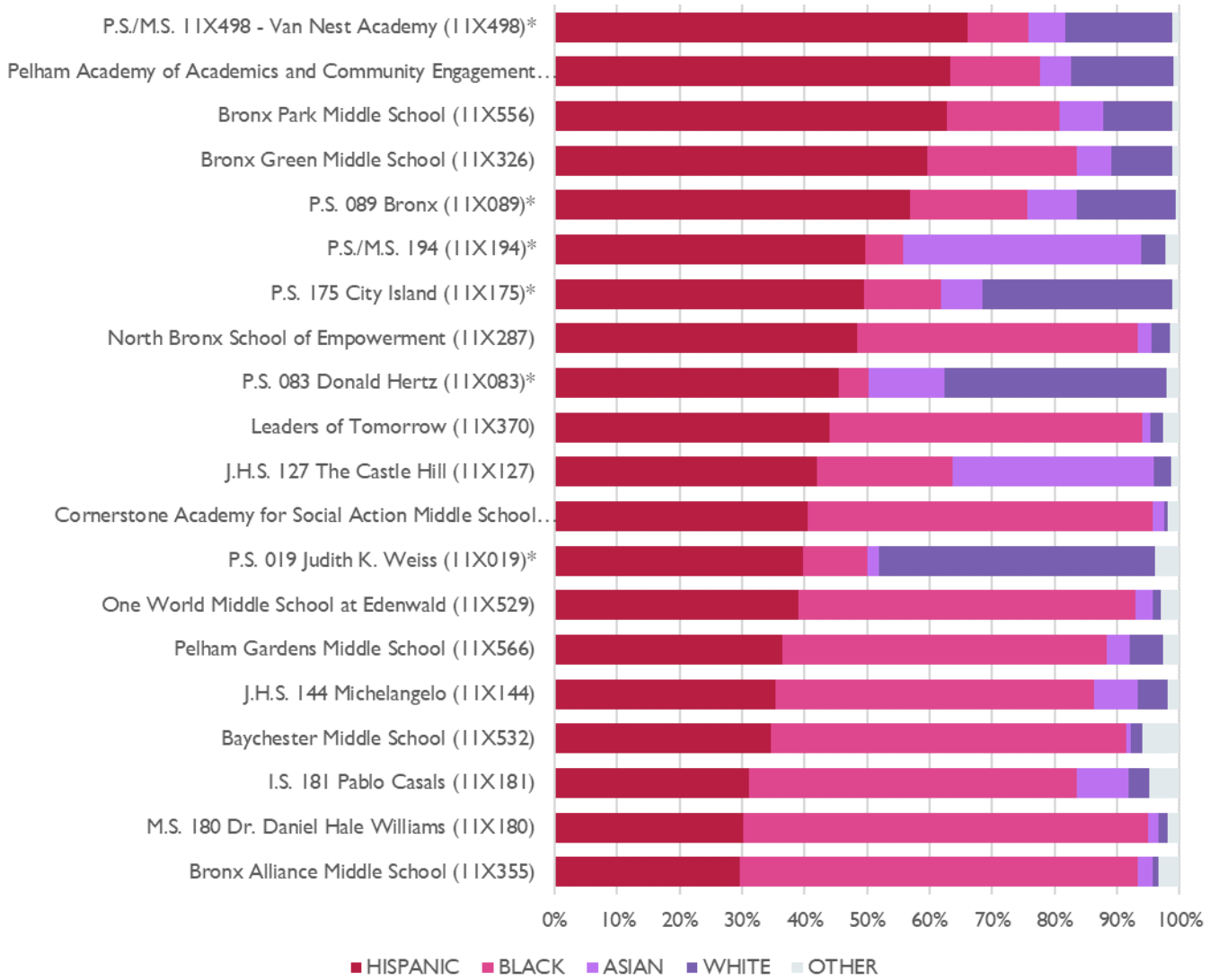
- District 11 schools have a wide array of demographic profiles depending on the neighborhood.
- Schools in the north part serve more Black students, schools near Bronx Park serve Hispanic majorities, schools in Morris Park serve more white students, and schools at the southern end of the district have large Asian populations.

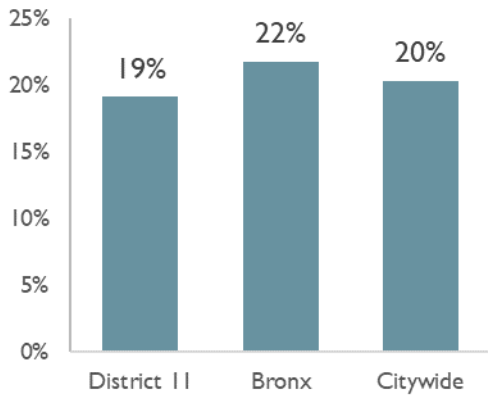
6-8 Race/Ethnicity, Schools Serving MS Grades

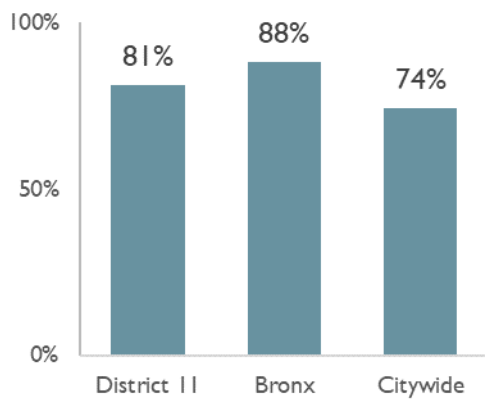

Students with Disabilities (K-8)



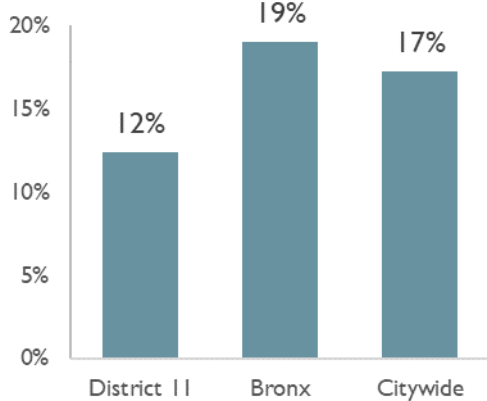
- Nineteen percent of District 11 students are students with disabilities. This is below the borough average.

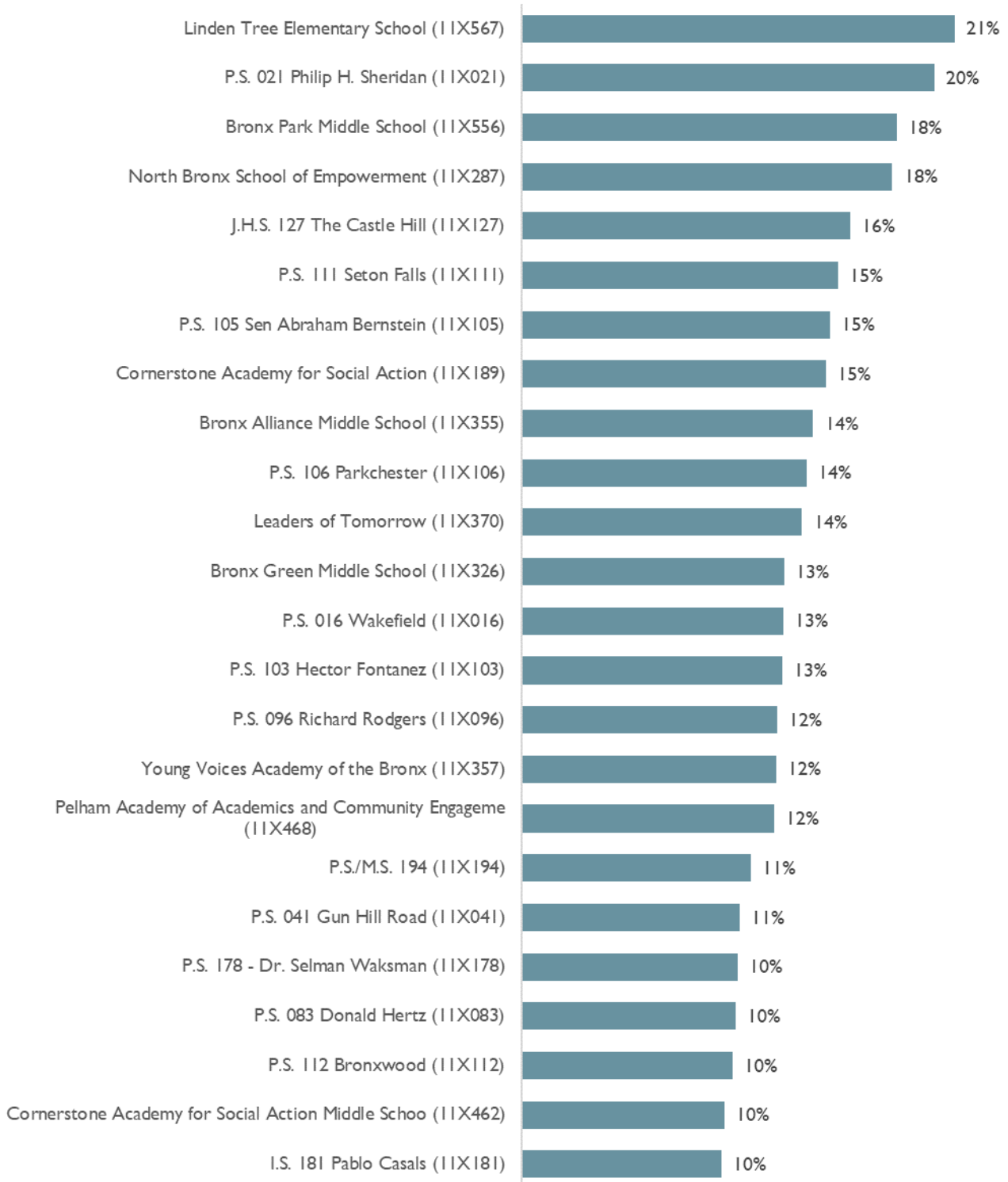
