## WEBSITE TERMS OF SERVICE

The following Website Terms of Service (these "**Terms**") govern your use of all web pages located within polygon.io (collectively, the "**Site**"). The Site is owned and operated by Polygon.io, Inc. ("**Polygon**", "we", "our", or "us"). Access to and use of the Site is subject to your acceptance of all the terms and conditions contained herein, and all other operating rules, policies, and terms on the Site.

Please note that these Terms are in addition to any other terms of service or separately executed agreement between you and Polygon that govern your use of the software, products, services, content, tools, and market data provided by Polygon (which, in the event of a conflict with these Terms and conditions, shall govern).
