'Scandal' star Kerry Washington meets **local Medal of Honor hero from WWII!**



of film as Actor Kerry Washington, the star of the hit television series, 'Scandal,' met with Anna Mae Robertson, one of the last remaining members of the legendary 6888 Postal Battalion of World War II, the first and only Women's Army Corps unit of color to be stationed in Europe during World War II.

While Robertson was all smiles meeting Washington, things got a little emotional for the actor after her

That's because Washington will be starring in the movie, 'The Six Triple Eight' about the famed yet, before now, little known Army unit that sorted for delivery millions of pieces of mail for American soldiers battling Nazi Germany. Washington plays the commander of the unit, Major Charity Adams.

In early 1945, the 6888th Central Postal Directory Battalion was deployed to England to take on a seemingly impossible mission.

more than 17 million pieces of mail to US soldiers fighting abroad and their loved ones back home, often mislabeled or without a complete

The task was Herculean, and the conditions arduous. As well as the terrors of war, the 855 women of the 6888th, led by Major Adams, faced segregation and sexism within their own military, carrying out their important work in derelict buildings lacking adequate light and heat.

They were given six months to complete the task. They did it in 90 days, bringing missives of hope to the front lines.

The film was produced, written and directed by Tyler Perry in commemoration of the postal unit and its legacy.

Out of 855 Black women who served with the 6888 Postal Battalion, only two are known to still be alive (one of them being Robertson).

Upon hearing that Robertson lived

Help in Milwaukee for hundreds who show up at wrong place

People go to early voting sites on Election Day, mistakenly thinking they can vote. A volunteer group perhaps unique in Wisconsin redirects them to polling places.

On the first day of early in-person voting in Wisconsin on Tuesday, October 22, a line 100 people long stretched outside the former Milwaukee Western Bank at 60th and Capitol.

Throughout the warm late afternoon, the line seemed to only grow, inspiring a local barber to hand out his business cards.

Some people arrived at the North Side early voting site and quickly decided to return another day. But others, including a couple who brought lawn chairs, dutifully took their places in the queue.

Voters exiting who said they spent an hour and a half or more in line, partly because of computer problems, didn't discourage Renee Green, 56. "Got to get out and make sure my vote is counted," said Green, who came with a woman who walked with a cane. "We said, 'We're going to get this done."

Linea Sundstrom, a semi-retired archaeologist, also arrived at the site,







U.S. POSTAL SERVICE IS READY TO DELIVER NATION'S ELECTION



Postal Service expects Election Mail service performance in the bar to be equal to or better than 2020

WASHINGTON, DC — With eight days remaining until Election Day, Tuesday, Nov. 5, the United States Postal Service recommends that voters who choose to vote by mail do so soon.

As we anticipate an uptick of ballots in the mail over the coming days, Postal Service employees are working to ensure the ballots of every individual who chooses to vote by mail are delivered quickly and securely. As in past elections, the Postal Service is ready to deliver your ballot on time.

But don't delay. If you choose to vote by mail, please

mail early as every day counts.

We continue to recommend that it is a good commonsense measure for voters who choose to mail in their ballots to do so before Election Day and at least a week before their election office needs to receive them. If a ballot is due on Election Day, the Postal Service recommends mailing the ballot by this Tuesday (October

The Postal Service remains fully ready to successfully deliver the nation's mail-in ballots for voters who choose to use us to vote.

And to be clear, even for return ballots that are entered in our system after Tuesday, we will continue to deploy our "extraordinary measures," which are designed to accelerate the delivery of Ballot Mail in the

final weeks of the election season. For the upcoming 2024 general election, the Postal Service anticipates similar service performance as demonstrated in the 2020 general election*:

• 99.89 percent of ballots mailed from voters to election officials were delivered within a week (7 days).

• 97.9 percent of ballots mailed from voters to election officials were delivered within three days, and 99.7 percent were delivered within five days.

 On average, the Postal Service delivered ballots from election officials to voters in 2.1 days and ballots from voters to election officials in 1.6 days.

*2020 general election statistics

For the 2024 general election the nation's postal network is operating effectively without any major reported disruptions. Service performance across the nation is strong. In the first three weeks of

October, Ballot Mail performance scores were high: • 99.9 percent of ballots (combined: outbound from election officials to voters and inbound from voters to election officials) were delivered within a week (7

• On average, the Postal Service delivered outbound ballots (to voters) in 2.0 days.

98.3 Percent of inbound ballots (from voters to election officials) were delivered within 3 days.

• On average, the Postal Service delivered inbound ballots (from voters to election officials) in 1 day.

Extraordinary Measures Underway (started Oct. 21)

In addition to the processes and procedures specific to Election Mail that the Postal Service deploys all year long, as in previous general elections, the Postal Service is deploying extraordinary measures in the final weeks of the election season to swiftly move Ballot Mail entered close to or on Election Day and/or the state's return deadline.

Extraordinary measures began Monday, Oct. 21, and will continue nationwide through Election Day (Tuesday, Nov. 5) and extend through the last day in each state that boards of elections will accept completed mail-in ballots as timely.

The extraordinary measures are designed to accelerate and enhance the delivery of Ballot Mail, when the Postal Service is able to identify the mailpiece as a bal-

- Special pick-ups;

WASHINGTON - Yesterday, Virginia state election officials requested the Supreme Court to block a ruling by a federal judge that would bar them from reviving an unlawful voter purge program that would prevent naturalized citizens from voting.

The program, which was responsible for purging more than 1,600 registered Virginia voters, was put in place by Virginia Governor Glenn Youngkin in August and was later struck down.

Derrick Johnson, President and CEO of the NAACP, made the following statement upon learning of the appeal to the U.S. Supreme Court:

"The voter purges here are textbook examples of attempted voter suppression and intimidation. Those behind the false allegations that saturate the Commonwealth's case seek to frighten those they consider their constituents by sounding xenophobic and racist dog whistles. That same message is being repeated throughout our nation in this election cycle.

They are playing a dangerous game designed to undermine the public's confidence in the entire democratic process."

The President of the Virginia State Conference of the NAACP, Cozy Bailey, released the following statement in anticipation of the Supreme Court's ruling:

"As the Supreme Court considers the appeal of Beals v. Virginia Coalition of Immigrant Rights,

the NAACP urges them to follow the law. This case has proven what we already know to be true - Governor Youngkin and his political cronies think winning is more important than democracy. As did their predecessors who passed and enforced Jim Crow laws, they will do and say anything to try to stop people of color from voting.

They now appear to be targeting naturalized citizens, who are legally allowed to vote.

We cannot be silenced. As we do in every election, Black Virginians will show up. We will ensure our voices are heard. This is not the end. It's just the beginning."

Virginia residents have the following options available to them:

The General Assembly approved legislation for Same Day Registration, Same Day Vote which provides the ability to register at any time, up to and including Election Day.

Early voting in Virginia runs through November

Election Day is Tuesday, November 5th. Even

those who are not registered or have been wrongfully removed from the voting rolls are able to register at the polls and cast a provisional ballot. For more information, including voter guides,

TO THE VOTERS OF THE CITY OF MILWAUKEE:

Notice is hereby given of a general election to be held in the several wards in the City of Milwaukee, on November 5, 2024, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are listed under the title of the office and under the appropriate party or other designation, together with any referendum questions submitted to a vote, in the sample ballot below.

Information to Voters

Upon entering the polling place and before being permitted to vote, a voter shall:

- state their name and address
- show an acceptable form of photo identification*
- sign the poll book**

If a voter does not have acceptable photo identification, the voter may obtain a free photo ID for* voting from the Division of Motor Vehicles.

**If the voter is unable to sign the poll book due to disability, a poll worker may write the word "exempt."

the voter provides proof of residence.

If a voter is not registered to vote, they may register to vote at the polling place serving their residence if

Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the voter shall enter a voting booth or go to a machine and cast their ballot.

assist the voter in marking their ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked. A voter who is a parent or quardian may be accompanied by the voter's minor child or minor ward.

The vote should not be cast in any manner other than specified here. Sample ballots or other materials to

An election official may inform the voter of the proper manner for casting a vote, but the official may not advise or indicate a particular voting choice.

Assistance for Voting

A voter may select an individual to assist in casting their vote if the voter declares to the presiding official that they are unable to read, have difficulty reading, writing, or understanding English, or that due to disability are unable to cast their ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents the voter. If a voter is unable to state their name and address, an assistant may also do so for the voter.

Voting for President and Vice President

A vote for candidates for President and Vice President is a vote for the presidential electors of those candidates. A write-in vote for President and Vice President must designate the name of a presidential candidate. A write-in vote for a candidate for President only will be counted. A write-in vote for a candidate for Vice President only will not be counted.

Where Optical Scan Voting is Used

The voter shall fill in the oval next to the name of the candidate of their choice for each office for which they intend to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of their choice in the space provided for a write-in vote and fill in the oval next to the write-in line. When voting for President and Vice President, the voter shall fill in the oval next to the set of candidates (ticket) for president and vice president for whom they intend to vote. To vote for a Presidential ticket that does not appear on the ballot, the voter shall write in the names of persons of their choice in the spaces provided and fill in the oval next the write-in lines. On referendum questions, the voter shall fill in the oval next to "yes" if in favor of the question, or the voter shall fill in the oval next to "no" if opposed to the question.

When using an *electronic ballot marking device* ("ExpressVote") to mark an **optical scan ballot**, the voter shall touch the screen or use the tactile pad to select the name of the candidate of their choice for each office for which they intend to vote. To vote for a person whose name does not appear on the ballot, the voter shall touch the screen next to "write-in" and type in the name of the person of their choice. When voting for President and Vice President, the voter shall touch the screen at the set of candidates (ticket) for president and vice president for whom they intend to vote. To vote for a Presidential ticket that does not appear on the ballot, the voter shall touch the screen next to "write-in" and type in the names of persons of their choice. On referendum questions, the voter shall touch the screen at "yes" if in favor of the question, These wards will not have a state senator contest on their ballots. or the voter shall touch the screen at "no" if opposed to the question.

If a voter spoils an optical scan ballot, they shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official who shall issue a proper ballot in its place.

"Zero: the number of Black women to ever serve as president of the United States.

"IF we do the work, we can change that with President Kamala Harris.

"As I reflect on what would be Congresswoman Chisholm's 100th birthday next month, I could not help but remember that my first official involvement in U.S. politics was working for her presidential campaign in 1972. Over 50 years later, I have been involved in every single campaign since.

Lowering the bar...again!

State education czar Underly continues the state's practice of 'under'-mining education for Black children!

Imagine a high school junior varsity basketball team with the worst freethrow percentage in the state.

Solution: lower the rims.

That's essentially what Department of Public Instruction Superintendent Jill Underly did to address stagnating state test scores in the core subjects of math and English

The relapsing policy lowers standards for student achievement assessments in 3rd to 8th grade and college preparation—ACT tests.

Not surprisingly, Milwaukee hosts the lowest reading proficiency rates for 4th and 8th grade in the country, Puerto Rico, the 'Unvirginal' Islands, and Jammin'

The lowered standards will make it appear that students are doing better than they are.

If they fall for the okie-doke, parents, and property taxpayers should feel better about their investments. Underly will have bullet points for her re-election bid.

The results of proficiency rates in the lower grades determine adult aspirations. If a child can't read at grade level by 4th grade, there is an appreciable reality they will suffer from the 'p' disease. (The 'P' disease is early 'Pregnancy' or 'Prison.')

The distorted new 'standards' for ACT rates will mislead students into thinking they are prepared for college when they are not.

The first test scores produced under the lowered report card results revealed earlier this month showed 'slight' improvements based on revised formulas and new terminology statewide.

White students averaged twice as high in the English arts and math scores as Black students. Twice!

(Ask yourself if there is something genetically wrong with Black students, or is it the system? Is it the pupil or the parent?)

Black students in charters and private schools participating in the Milwaukee Parental Choice Program scored four percentage points higher than their 'government (aka public) school' counterparts.

But under revised terminology, they are no longer listed as 'below basic,' but instead as 'developing.'

Basic is now identified as 'approaching.' (I assume that means approaching 'mediocre').

The new terminology for ACT tests is equally misleading. Instead of the bottom base—formerly 'below college ready'—students are now listed as 'meeting' (which I assume means they are college

If this needs to be clarified, go to the back of the bus.

Or, let me break it down utilizing an analysis revealed by 'City Forward Collective,' a local research organization: • More Students Meeting Lower

Standards—Under new, lower standards for student learning, just over half of Wisconsin's students earned a "Meeting Expectations" or higher rating on the spring 2023 state assessments.

Statewide, 49% of students met new state standards in English Language Arts (ELA), and 50% of students met these standards in Math

In Milwaukee, across all sectors, 25% of students met new state standards in ELA, and 21% of students met new state standards in Math

• Lowered Expectations: The state's definition of 'meeting expectations' no longer aligns with rigorous national benchmarks for what students should know and be able to do to be ready for college or for

For the ACT, students are now rated as 'Meeting Expectations' with a composite score of 19 - well below the ACT's College Readiness Benchmark of 22.

Statewide, over 7,000 eleventhgraders were in a new 'Meets Expectations, Below College Ready' category in Math.

For the Forward Exam, students are now expected to demonstrate only "partial mastery of the skills foundational for proficiency at a given level.

• More Inequities, Wider Gaps,

& Disproportionate Subgroup Impacts: As anticipated by DPI staff. while the new lower standards resulted in across-the-board increases in students rated as meeting standards across all subgroups, these changes had less benefit for historically under-educated groups of stu-

- By race/ethnicity: the percentage change in White students who met the new, lower state standards was two to three times greater than for Black and Hispanic students
- By family income: the percentage change in non-economically disadvantaged students who met the new, lower state standards was 25% larger than for economically disadvantaged students
- Special Education: the percentage change for non-special education students was four times as large as for students with identified

• Milwaukee's Academic Crisis: Milwaukee's academic crisis persists, with the gap between overall city and state performance growing by four percentage points under the new standards.

In ELA, 28% of students in both public charter and private schools in the Milwaukee Parental Choice Program (MPCP or vouchers) met state expectations, compared to 22% of students in MPS districtoperated schools.

In Math, 27% of public charter schools and 25% of private school students in the Milwaukee Parental Choice Program met state expectations, compared to 16% of students in MPS district-operated schools.

The bottom line is that a significant cover-up is in place, a paradigm consistent with past practices for DPI and MPS

The difference this time is that the government is trying to confuse

or hypnotize parents into believing their child is doing better than they.

Following an analysis of the recent test scores, Colleston Morgan, executive director of City Forward Collective, noted

"Superintendent Jill Underly & DPI's decisions to lower expectations for students—and the associated changes made to Wisconsin state assessments—are harmful to students, bad for families, and do a disservice to educators and all stakeholders in our state's K12 schools."

Moreover, "Underly has implemented a series of ill-considered changes, hastily pushed through without proper deliberation and full stakeholder input, that both lowered the bar and muddied the picture of student outcomes and school performance."

Even Governor Tony Evers, the former DPI superintendent who established the prior standard, agrees. Sadly, he said he could do any-

thing since DPI is a different de-

I beg to differ, but that, too, is consistent with policies that have undermined Black academic achievement over the decades.

It brings to mind a scenario at North Division a few years ago when the school's valedictorian and salutatorian—the top two students—enrolled in a state college only to discover they were unprepared.

Both had to take a full year of remedial Education. One transferred to MATC. Valedictorian Martinez Martin

has since crusaded to bring attention to the dichotomous and seemingly racist scenario that he assumes was taking place across the district. It's too bad his alarm has fallen

From 'Law and Order' to a Racist National Agenda By Pilar Marrero, courtesy of ethnicmediaservices.org

The undercurrent of hatred and racism behind anti-immigrant policies over the last 35 years has been exposed in the platform of a certain Donald J. Trump.

Not too long ago, American politicians—

mostly Republicans, with a few Democrats—denied that their "tough" positions against immigrants had anything to do with race or ethnicity.

"It's not a matter of racism," they assured us, "it's a matter of legality, of enforcing the laws of the United

Their focus, they argued, was on deporting those who commit crimes, while protecting citizens and legal residents, and those immigrants who "did things the right way" by coming to this country legally.

But now the masks have come off. The undercurrent of hatred and racism behind anti-immigrant policies over the last 35 years, barely concealed under a veneer of "law and order," has been exposed in the platform of a certain Donald J. Trump, whose personal disdain for minorities is more than evident.

I think it's been made sufficiently clear in recent weeks—on top of everything that's happened over the last few years—that Donald

Trump's third presidential campaign and the MAGA movement generally don't bother with these distinctions.

Instead, what we hear from Trump and those who support him at his events is this: "We (the United States) have become the depository of the world's garbage"; "Venezuela is opening its prisons and sending us its rapists and criminals"; "an island of garbage floats in the sea, and it's called Puerto Rico," Haitians in Springfield eat cats and dogs, and Black Americans use watermelons instead of pumpkins for Halloween.

The list of stereotypes and clichés coming from Trump and his allies grows more radical, but the evidence of Trump's racism is not new.

He made it clear when he launched his first campaign in 2015 and continued for years: "Mexico isn't sending their best, they are bringing crime, they're bringing drugs, they're rapists, and some, I assume, are good people," his comments about Central American and African nations as "shithole countries," his "scientific" insight in declaring COVID as "the Chinese virus," unleashing a wave of hate crimes against the Asian American community not seen in decades, and

his "security-related" ban on thousands of Muslims entering the U.S. are all just older exhibits attached to the continued mountain of evidence.

But his new promises go beyond deporting "illegals." Now it's about making "legals" illegal (removing TPS, refugee programs, and work visas) and changing the Constitution so that being born in the United States does not automatically grant citizenship.

Creating millions of stateless babies is one of his goals.

Central to his campaign promises are the mass deportations of "between 12 and 21 million immigrants" that will begin "from day

There's also the notion that separating families during deportations isn't necessary "since we can deport the whole family," as Tom Homan, the former ICE director under Trump, clearly explained last week on "60 Minutes."

This will include anyone indiscriminately caught in the net, whether or not they're citizens or legal residents.

We're talking about another, much larger, "Operation Wetback," like the one the U.S. carried out in

1955 when hundreds of thousands of people were deported from various U.S. regions to Mexico, many of them citizens or people who had spent nearly their entire lives in the United States.

What Trump is proposing is the use of military tactics and "detention camps," along with the investment of billions of dollars in a program unprecedented in the modern world.

The human, familial, and economic devastation is indescribable and would become a historic curse for this country.

Sometimes I wonder, though, if those Latinos voting for Trump understand what they're doing. If, as journalist Paola Ramos suggests in her study on the Latino far-right, "many Latinos don't believe that Trump is talking about them when he says what he says." When we hear that disillusioned Black men are turning to Trump as an alternative, or when nationalist groups talk about "expelling immigrants and protecting our way of life."

Many say it without hesitation: "Protect the white heritage of Amer-

Latinos and other racial minorities who believe that Trump's plans don't include them and who only want "to improve the economy" or "recover the jobs that illegals take from us" will face a rude awakening when they realize that the vision of

the country their admired leader holds doesn't include them either.

Their lives will become hell in a country led by a man whose closest conservative and Republican associates have described as a Hitler fan and a fascist.

which is advertised on temporary street signs more than a mile away. But her work — dubbed "voter

rescue" — won't begin until after the voting machines are gone. Sundstrom co-leads Supermarket Legends, a nonpartisan, left-leaning Milwaukee voter advocacy group

that has registered voters outside grocery stores and other venues since For the "voter rescue" initiative,

volunteers spend each Election Day at some of the city's 10 early voting sites, greeting hundreds of bewildered residents who mistakenly thought they could cast Election Day ballots at early voting locations such as the old bank.

The volunteers explain that the nearly two-week early voting period ends the weekend before Election Day. They try to make sure the voters know how to find their local polling place — which is the only place where in-person voting on Election Day is allowed.

"We do a lot of different things around promoting voting in Milwaukee. This is one that everybody likes to do," Sundstrom said. "Because you get that instant feedback — this person was upset and discouraged, but now they have a plan. Maybe they'll vote, maybe they won't; we can't control that. But at least they've empowered themselves to vote if they want to, and they didn't just get the door slammed in their face."

Hundreds of voters 'rescued'

By now, battleground state is almost as synonymous with Wisconsin as Badger State when it comes to presidential elections. The candidate who carried Wisconsin in four of the last six contests — including Republican Donald Trump in 2016 and Democrat Joe Biden in 2020 — won the state by less than 1 percentage

So, the adage that every vote counts packs more power here, and in-person early voting has become more important.

In the 2020 presidential election, 20% of Wisconsin ballots were cast at early voting sites. It was 12% in the November 2022 election, which featured races for governor and U.S.

Sundstrom said that based on simple tallies kept on paper, Supermarket Legends "rescued" 800 Election Day voters in 2020 and nearly 900 in

Leaders of the National Association of State Election Directors, the national Electionline news service and the Wisconsin League of Women Voters said they were not aware of voter rescue efforts anywhere else in the U.S.

"This is a really interesting phenomenon," said Barry Burden, director of the Elections Research Center at the University of Wisconsin-Madison, adding that he had not heard of such initiatives elsewhere. He noted similar confusion among students at UW-Madison, where the early voting site is not always the same as the Election Day polling place.

Orlando Owens, a Milwaukee County Republican Party branch chair who works to increase GOP voter turnout in Milwaukee, called voter rescue "another tool in the toolbox" of increasing voter turnout in heavily Democratic Milwaukee. "We have to find a way to match it," he

During early voting, Milwaukee voters can cast ballots at any early voting site in the city, which is part of what leads to confusion.

On Election Day, a voter can vote at an early voting site — but only if it is also a polling place that serves that voter's address.

Early voting sites such as the old

Avoiding the anxiety

More than 97,000 people in Wisconsin cast ballots on the first day of early in-person voting, 22% more than in the November 2020 election.

That doesn't eliminate chances of confusion at early voting sites on

Election Day for a presidential contest that is effectively tied in Wisconsin, according to the latest polls, and with voter turnout expected to be

Kisha Fields, 47, came to 60th and Capitol on Tuesday to vote early for the first time, saying she wanted to

avoid Election Day anxiety. Fields was undaunted by the wait and hopeful that all ballots, no matter how they're cast, would be accurately counted.

"Prayer is the key," she said. "I don't have no control over it; none of us do ... I've just got to do my part.'


