12. PROPOSED AMENDMENTS TO THE CONSTITUTION OF THE COUNCIL

The Council considered the Report of the Head of Democratic Services on proposed amendments to the Constitution as a result of the new ways of working outlined by the Majority Group which required amendments to the Council's Constitution.

Councillor Clements addressed the amendments and stated that he recognised the importance of the Constitution and stated that he thought the New administration had proposed to consult with those who elected them before the Council resolved to change its Constitution and existing Committee structure.

He and Councillor Allen also raised concerns that the amendments were not tabled in detailed, in writing for Members prior to the Council meeting.

The Head of Democratic Services explained that due both to the time constraints and also the number of minor amendments the Report before the Council was comprehensive. He explained that following the Council meeting the detailed wording of the Constitution would be updated and copies made available to Councillors, in the Group Rooms, public libraries and on the Web.

A number of Members were against the proposals for the changes recommended to Area Committees feeling that there had been no genuine consultation with residents about the changes proposed in areas.

A number of Members maintained that the changes to Area Committees were not policy matters and therefore there was no need for consultation. A Member reminded Councillors that once elected they represented the whole of the population in their Ward regardless of party political allegiance.

It was moved and seconded

"that Council resolves to consult on the proposed Committee structure and that the existing structure should remain in place for one cycle."

It was moved and seconded

"that the number of Area Committees be increased from 5 to 6 with no more than 3 Wards represented on each Area Committee and that residents and other interested parties be consulted."

Concern was also expressed by some Members with regard to the proposals to the changes with regard to the "call-in" arrangements to Scrutiny Committees. It was proposed that each of the Scrutiny Committees be allocated dates on

alternative weeks throughout the year which could be cancelled if there was no business.

Amend the Constitution to allow for any two Members of a Scrutiny Committee to "call-in" a decision to that Scrutiny Committee and any five Councillors (whether or not they are Members of a Scrutiny) to "call-in" a decision to a Scrutiny Committee. There is to be a requirement for the appropriate Scrutiny Committee to meet within 10 working days of the "call-in". If the Committee does not meet within this period the decision will stand. Urgent decisions will be acted upon whether or not they are "called-in". Councillors "calling-in" decisions will be expected to attend the Scrutiny Committee to outline their reasons for doing so.

- (iv) The proposal involves the Borough or County Council either as applicant or landowner (except in the case of minor applications).

Planning and other applications made by the Council which involve Council owned land would fall within the Scheme of Delegation where they relate to minor amendments. Schemes where the Council is the landowners but not developing themselves fall within the Scheme of Delegation (TO BE DELETED).

The applicant/agent is a Councillor or a Council employee directly involved in the handling of applications or is a Service Unit Manager, a member of the corporate Management Team or a member of the Planning Design and Control Services Unit (TO BE DELETED).

- (v) The applicant is a Councillor.
- (vi) The applicant is a member of the Council's Management Team, a Service Unit Head, a member of the Planning Design and Control Services or any member of staff within the Authority who could be seen to have a direct input to, and therefore influence on, application decisions.
- (vii) Any other planning applications from employees of the Borough of Poole may be delegated subject to prior consultation with the Chairman and Vice-Chairman of the Planning Committee.
- (viii) Any application where a Council employee is involved in any capacity i.e. agent or consultant.
- (ix) Planning and other applications by or involving a Housing Association would fall within the Scheme of Delegation except where new units are created.

(x) Planning applications for telecommunications development will fall within the Scheme of Delegation except where they relate to the erection or installation of new masts. Proposals for additional antennas or dishes on existing telecommunication structures to fall within the Scheme of Delegation.
