The information in this Athlete Allocation System is accurate as at 01 July 2021 but remains subject to change. As a result of the unique and extenuating circumstances caused by COVID-19 and the subsequent impact on international sporting calendars, the CGF and FIVB will be closely monitoring this Athlete Allocation System to determine if any changes are necessary. For the avoidance of doubt, the CGF and FIVB reserve the right to amend this Athlete Allocation System in any manner, and in their sole and absolute discretion, should it be deemed necessary to ensure a fair qualification pathway for all Athletes.

## 1 INTRODUCTION

The Beach Volleyball Athlete Allocation System includes four (4) key methods of qualification;

#### 1. Host CGA

Automatic qualification

#### 2. Direct Qualification

FIVB World Ranking (Men and Women) - Ranking period 16 April 2018 to 31 March 2022

#### 3. Continental Representation

Five (5) zones including four (4) FIVB recognised zones + Oceania, as defined by the CGF

#### 4. Bipartite Invitation

FIVB and CGF Bipartite Invitation

### 3 ATHLETE ALLOCATION SYSTEM

## a) Host CGA Automatic Qualification (Commonwealth Games England)

For the avoidance of doubt, each CGA is entitled to have a maximum of 1 team per medal event in the entire qualification process.

## 4 QUALIFICATION FRAMEWORK

CGAs not affiliated with FIVB will be required to affiliate with FIVB, or if not eligible to affiliate will be required to obtain approval from FIVB before eligibility to participate.

Teams will be selected to compete in accordance with the following process.

#### Note:

FIVB World Rankings are established based on the FIVB Beach Volleyball Ranking points earned at the eight (8) best performances as a team in all FIVB sanctioned or homologated Beach Volleyball events over the specified ranking period.

## 5 QUALIFICATION PATHWAY

#### a) Host CGA Automatic Qualification

- o The Host CGA shall be issued the maximum slot allocation of one (1) Team per medal event;
- The Host CGA athletes will be removed from the FIVB World Ranking and FIVB regional event results for the purposes of determining Direct Qualification and Continental Representation;
- In the event the Host CGA is unable to accept the award of any and/or all slots earned via the Host CGA method, the slot(s) will be redistributed via the Reallocation of Unused Qualification Slots Process.

#### b) Direct Qualification

The top five (5) CGA Nations on the FIVB World Ranking (Men and Women) in the ranking period 16 April 2018 to 31 March 2022 will earn direct qualification. For the avoidance of doubt, the Host CGA will be awarded the Host CGA slot, and therefore removed from the FIVB World Ranking for these purposes.

In the event the final slot of qualification has been achieved by more than one CGA, the CGA to be allocated the slot will be identified in priority order according to the FIVB Beach Volleyball World Ranking Definitions.

- In the case of a further tie, the CGA will be identified at the sole and absolute discretion of the FIVB and CGF, taking into consideration factors including, but not limited to:
  - international competition results during the period of 16 April 2018 31 March 2022; and
  - any other factor(s) considered relevant by FIVB and CGF.

For the avoidance of doubt, for an athlete to be eligible to accrue points for consideration on behalf of their CGA, they must be a passport-holder for that CGA country and satisfy all other CGF eligibility regulations. Satisfying general FIVB Eligibility criteria will not be sufficient.

In the event a CGA is unable to accept the award of any and/or all slots earned via this method, the slot(s) will be redistributed via the Reallocation of Unused Qualification Slots Process.

#### c) Continental Representation

The top CGA Nation from the four (4) FIVB Regions of AVC, CAVB, CEV and NORCECA/CSV as well as the top CGA from Oceania (as defined by the CGF) not otherwise qualified through Host CGA or Direct Qualification will qualify one slot to be awarded to the CGA.

For the purposes of FIVB Continental Representation, places will be determined by the highest placed CGA (not otherwise qualified) from designated FIVB regional events ("Continental Representation events"). These events will be concluded prior to 31 March 2022 and will be confirmed by no later than 01 October 2021.

For the avoidance of doubt, CGAs who have already earned qualification through Host CGA and Direct Qualification will be removed from the Continental Representation event results to determine Continental Representation. Continental Representation slots will therefore not be awarded until after Direct Qualification slots are determined following the FIVB World Ranking as at 31 March 2022.

For the purposes of qualification through Continental Representation, CGA representation across FIVB regions will be as follows:

Where there is no Continental Representation event held due to unforeseen or extenuating circumstances, the highest ranked CGA not otherwise qualified from that region on the FIVB World Rankings in the ranking period 16 April 2018 to 31 March 2022 will qualify.

Where there is no Continental Representation event held due to unforeseen or extenuating circumstances and all eligible CGAs from that region have qualified through another pathway, the highest ranked CGA not otherwise qualified from any region on the FIVB World Rankings in the ranking period 16 April 2018 to 31 March 2022 will qualify.

For the avoidance of doubt, for an athlete to be eligible to accrue points or compete in Continental Representation events for consideration on behalf of their CGA, they must be a passport-holder for that CGA country and satisfy all other CGF eligibility regulations. Satisfying general FIVB Eligibility criteria will not be sufficient.

In the event a CGA is unable to accept the award of any and/or all slots earned via this method, the slot(s) will be redistributed via the Reallocation of Unused Qualification Slots Process.

#### d) Bipartite Invitation

Bipartite Invitation slots will be awarded to one (1) CGA Nation per medal event not otherwise qualified, at FIVB and CGF sole and absolute discretion.

Applications for a Bipartite Invitation slot are to be submitted by the CGA by the prescribed deadline. It is at the sole and absolute discretion of the FIVB and CGF to allocate a Bipartite Invitation slot in an instance where no application has been received.

CGAs to be considered by the Bipartite Commission must participate in the Continental Representation events.

These slots are non-transferable and in the event the CGA is no longer able to accept the Bipartite Invitation slot(s) it will be distributed at the sole and absolute discretion of the Bipartite Commission with consideration for the factors listed below.

In making determinations on allocating Bipartite Invitation slots, FIVB and CGF may consider factors including, but not limited to:

- 1. Field depth and competition strength;
- 2. International, regional and national competition results including strength of competition and consistency of performance;
- 3. Widely and regularly practising national athletes;
- 4. Demonstrated availability of athletes to participate in the Birmingham 2022 Commonwealth Games competition; and
- 5. Any other factor(s) considered relevant by FIVB and CGF.

Where a CGA has not competed in the Continental Representation event, but would otherwise be deemed eligible, the Bipartite Commission may grant an exemption on the grounds of extenuating circumstances. CGAs may request this consideration when applying for the Bipartite Invitation slot.

#### **Reallocation of Unused Qualification Slots Process**

Any qualification slots that are not used by the CGA will be reallocated as follows:

- Any unused slots earned from the Host CGA method shall be reallocated to the next highest ranked CGA not otherwise qualified on the FIVB World Ranking in the ranking period 16 April 2018 to 31 March 2022. Where there are no eligible CGAs remaining on the FIVB World Ranking, remaining slots may be reallocated at the sole discretion of the CGF and FIVB.
- Any unused slots earned from the Direct Qualification method (FIVB World Ranking) shall be reallocated to the next highest ranked CGA not otherwise qualified on the FIVB World Ranking in the

ranking period 16 April 2018 to 31 March 2022. Where there are no eligible CGAs remaining on the FIVB World Ranking, remaining slots may be reallocated at the sole discretion of the CGF and FIVB.

- Any unused slots earned from the Continental Representation shall be reallocated to the next highest
  placed CGA not otherwise qualified from the respective Continental Representation event. Where
  there are no eligible CGAs remaining from the respective Continental Representation event, remaining
  slots may be reallocated at the sole discretion of the CGF and FIVB.
- The CGF and FIVB reserve the right not to reallocate the slot, in the case that the reallocation process
  results in the potential award of a slot to a CGA whose performance could compromise the safety and
  integrity of the competition.

### 6 ATHLETE ELIGIBILITY

To be eligible for endorsement by a CGA, an athlete must;

- Not be currently under disqualification or suspension by the CGF, or their respective Affiliated CGA or FIVB or under the World Anti-Doping Code;
- Have complied with all applicable rules and regulations of the CGF, FIVB and the World Anti-Doping Code as may be modified and applied by the Federation to ensure that the overriding principles of the Commonwealth Games are observed. In the case of any inconsistency, CGF rules and regulations will prevail;
- o Have complied with the minimum age regulations, as stipulated by FIVB; and
- Have met the CGF's eligibility regulations in accordance with the CGF Constitution.
