**COMMENT SOUGHT ON SAGE TELECOM, INC.'S AND SAGE TELECOM OF TEXAS,
L.P.'S REQUEST FOR WAIVER OF THE COMMISSION'S RULES REGARDING THE
UNIVERSAL SERVICE CONTRIBUTION ANNUAL TRUE-UP PROCESS**

On June 25, 2008, Sage Telecom, Inc. and Sage Telecom of Texas, L.P. (collectively, Sage) filed a petition for waiver of the requirement that the Universal Service Administrative Company (USAC) calculate the universal service annual contribution true-up for under-projections based on the average of the two highest contribution factors, and that USAC calculate the true-up for over-projections based on the average of the two lowest contribution factors.¹

Interested parties may file comments on or before **August 7, 2008**, and reply comments on or before **August 21, 2008**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.²

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. filing instructions, filers should send an e-mail to ecfs@fcc.gov, and include the following words in the body of the message, “get form.” A sample form and directions will be sent in response.

- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This matter shall be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules.³ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and

arguments presented generally is required.⁴ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁵
