## COMMENT SOUGHT ON IDT CORPORATION AND IDT TELECOM REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

On June 30, 2008, IDT Corporation and IDT Telecom (collectively IDT) filed a request seeking review and reversal of an audit by the Universal Service Administrative Company (USAC), in which USAC found that IDT had understated its end-user telecommunications revenue associated with its prepaid calling card line of business.<sup>1</sup> In its request, IDT alleges that the findings in USAC's audit report are based on instructions to the FCC Form 499-A that are invalid as a matter of law because, IDT asserts, they were not adopted in accordance with the notice and comment requirements of the Administrative Procedure Act (APA).<sup>2</sup> IDT asserts, in the alternative, that, even if the APA was not violated, the FCC Form 499-A instructions regarding the definition of "end user" relied upon by USAC directly conflict with Commission orders.<sup>3</sup>

Interested parties may file comments on or before **September 5, 2008**, and reply comments on or before **September 22, 2008**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>4</sup>

This matter shall be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules.<sup>5</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission’s rules.<sup>7</sup>
