COMMENT SOUGHT ON AMBESS ENTERPRISES, INC. REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

On November 20, 2008, Ambess Enterprises, Inc. (Ambess) filed a request seeking review and reversal of a decision of the Universal Service Administrative Company (USAC), in which USAC denied Ambess' request to accept its amended February 2008 FCC Form 499-Q. In its request, Ambess asserts that it mistakenly submitted an FCC Form 499-Q on February 1, 2008 which it was not obligated to file. Additionally, Ambess asserts that it erroneously over-projected revenue on the FCC Form 499-Q, and did not discover the error until after the 45-day FCC Form 499-Q revision window. Ambess, therefore, requests that the Commission direct USAC to disregard Ambess' erroneously-filed FCC Form 499-Q, or, waive the 45-day revision deadline to permit Ambess to amend its February 2008 FCC Form 499-Q filing.

Interested parties may file comments on or before **January 2, 2009**, and reply comments on or before **January 21, 2009**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.⁵
