## COMMENT SOUGHT ON ASPIRE TELECOM, INC. REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

On April 9, 2009, Aspire Telecom, Inc. (ATI) filed a request for review of a decision of the Universal Service Administrative Company (USAC), in which USAC rejected ATI's request to revise its May 2008 FCC Form 499-Q after the 45-day deadline for filing form revisions. ATI also requests abatement of all universal service contributions, late payment fees and interest charges associated with its late-filed May 2008 FCC Form 499-Q.<sup>2</sup>

Interested parties may file **comments on or before June 8, 2009**, and **reply comments on or before June 22, 2009**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>
